# OFFICE OF THE CITY ADMINISTRATOR

Re: Agenda items for City Council meeting on Tuesday, January 18, 2022, 6:30 p.m.

<u>Finance/Administration Committee</u> - There are two items for consideration through the Finance / Administration Committee.

I will give a brief update on the tax revenue collections.

2. We have, for several years, contracted with the Missouri Department of Corrections through the work release program for seasonal labor. This program provides inmates that are not incarcerated for violent offenses and close to release, the opportunity to get out of the facility, under strict supervision, to work. Much of the purpose for this program is to make a successful transition back into society from the life of incarceration. From the City's perspective, for the taxpayers' benefit, it provides a lower cost for this seasonal labor such as mowing and weed eating at the cemetery. Due to the pandemic, this labor has not been available to us for the last two years. However, in case this would become available to us again this summer, staff recommends approval of the amendment to extend the term of the contract for another year.

<u>Public Safety Committee</u> – There are three items for consideration through the Public Safety Committee.

- The police department has been awarded a grant from the US Department of Justice to purchase two dual band radios. These dual band radios provide shift supervisors essential intraoperative communications with other public safety agencies to coordinate activities during joint operations. The total cost of the radios is \$11,780.18. Staff recommends approval of the resolution and ordinance to recognize the grant revenue and appropriate the expenditure.
- 2. As presented in our strategic planning session, staff is working on a grant application for a Community Development Block Grant (CDBG) to fund additional sidewalk rehabilitation projects. Part of the requirements of the grant is to have in place a resolution establishing policies about the use of excessive force. Later in this meeting, you will be presented a resolution for your consideration authorizing the submittal of the grant.
- 3. Unfortunately, we have had more than normal vehicle repairs on multiple fire apparatuses throughout the year. This has caused us to exhaust the budgeted amount for this line item. Staff recommends approval of a budget amendment to increase the appropriations for repairs and maintenance in the fire department by \$24,000.00.

<u>Public Works Committee</u> – There are eight items for consideration through the Public Works Committee.

 As presented during the strategic planning session, staff is working on an application for a Community Development Block Grant (CDBG) to fund additional sidewalk rehabilitation projects. Staff recommends approval of a resolution to authorize staff to submit an application for a \$500,000.00 grant. This grant, if awarded would require an equal amount of matching funds. This project scored the highest priority for capital improvement funds during your meeting on January 8.

- 2. The permits for our sewer operations with the Missouri Department of Natural Resources (MDNR) require a review of each of our permitted pretreatment industries. Staff prepared the evaluation in the format prescribed by MDNR and recommends approval of a resolution authorizing the submission of the report and the applicable changes in local limits in the City code.
- 3. Staff has been meeting with representatives from the Sedalia 200 School District to review and develop ways to improve traffic safety around the schools. From these meetings, staff presented a recommendation to reduce the speed limit on Tiger Pride Boulevard from 25 mph to 15 mph to the Citizen's Traffic Advisory Commission. The Commission voted unanimously to recommend the reduction in speed limit.
- 4. From the meetings mentioned above, staff also recommended to the Citizen's Traffic Advisory Commission to establish a no parking zone on the South side of West 5<sup>th</sup> Street from Warren Avenue to South Limit during times when school is in session. The Commission voted unanimously to recommend the no parking zone.
- 5. Staff recommended to the Citizen's Traffic Advisory Commission to formally approve and establish by ordinance stop signs installed at the intersection of East Saline Street and North Engineer Street. The Commission voted unanimously to recommend establishing by ordinance a four way stop at this intersection.
- 6. Staff recommended to the Citizen's Traffic Advisory Commission to formally approve the reduction of the speed limit along North Engineer Street from Reine Avenue to the intersection with the railroad from 30 mph to 25 mph. The Commission voted unanimously to recommend the reduction in the speed limit.
- 7. As presented in the strategic plan for the Water and Wastewater departments, we have been working with an engineering firm to develop a master plan. As part of this project, they are creating a model that can be updated showing capabilities and capacities of the systems. This dynamic modeling capability would make us much more responsive in analyzing economic development growth opportunities, while also guiding us in our planning processes for intrinsic growth and ongoing maintenance needs. Working with the engineers, staff reviewed two commonly used software packages capable of performing these modeling functions. Staff identified Bentley as the preferred software provider at a cost of \$34,946.00 for the water and sewer packages.
- 8. Councilman Bloess, with his forestry experiences, has recommended that we consult with a forestry management firm to identify opportunities to harvest some of the timber at Springfork Lake while improving the landscape and sustainability of the trees. Staff recommends establishing a budgetary amount of \$5,000.00 to employ a forestry management consultant.

<u>Community Development Committee</u> – There are two items for consideration through the Community Development Committee.

1. Oats has expressed their desire to expand their operations into currently underutilized space at the train depot. Staff has negotiated with them to establish a lease for this space for \$600.00 per month and they will assume the utilities.

2. As mentioned earlier, staff is working on a grant application for a Community Development Block Grant (CDBG) to fund additional sidewalk rehabilitation projects. Part of the requirements of the grant is to have in place a resolution supporting fair housing practices. The City passed a fair housing ordinance in 1980, and this resolution expresses the City's commitment to adhere to such practices.

## Presentation: Scott Joplin International Ragtime Foundation - Annual Report

Doug Freed, Scott Joplin Ragtime Foundation President, stated this year is the 43<sup>rd</sup> anniversary of the Scott Joplin Festival and the new pavilion will make a positive impact for the festival.

John Simmons, Ragtime Foundation Board Member, stated that the foundation's mission is "to preserve and promote an understanding and appreciation of Ragtime music and its history worldwide, and to promote Scott Joplin's contribution to Ragtime music and the importance of Sedalia, Missouri to Ragtime history." The annual 4 day festival hosts 23 musicians, 2 free performances, 7 Liberty Center concerts, 9 symposiums, interaction with musicians and Ragtime reunion.

Due to Covid-19, the 2020 and 2021 festivals were cancelled prior to contract penalties. If the festival is held, the City's financial support is \$10,000.00 and local businesses contribute over \$10,000.00 in products, services and sponsorships. A grant in the amount of \$8,877.00 from The Missouri Arts Council and \$4,500.00 from the Central Business & Cultural District are received as well. The Tourism Marketing Grant of \$26,050.00 brings in overnight visitors and ragtime education throughout the year is supported by civic organizations.

Due to festival cancellations, "Syncopated Saturday Night" was created as an alternative and is the first Saturday night of each month, available on YouTube, includes 2 performers and features different venues. Performances have helped raise \$29,715.00 in donations to help cover production expenses and payments to musicians.

- Educating younger generations on the importance of ragtime's contribution to modern American music
- Increased awareness of Sedalia's location and importance to American music

John Simmons stated there was more involvement from Rotary and other civic organizations, however, this year, 3 vital volunteers will not be available at critical areas throughout the festival, therefore, more volunteers are needed.

## **Strategic Planning Presentation: Animal Services**

Animal Shelter Manager Randi Battson stated the Sedalia Animal Shelter has 49 dog kennels, 96 cat kennels and a "Wiggle Room" located behind the shelter that allows dogs to exercise and develop better social skills. The facility also includes a walking trail behind the shelter.

2021 - Adoptions 682; Transferred Out 21; Returned to Owners 277; Euthanasia 30.

#### 2022 Goals:

- Continue to Trap/Neuter/Release stray cats to reduce overpopulation and nuisance problems.
- Work with Parks Department to landscape and beautify walking trail to make it user friendly. A donation has been made for a gazebo.
- Promote Good Pet Practices: 2020 70 pupples brought in, 497 dogs running at large, 8 bite quarantine dogs; 2021 126 pupples brought in, 608 dogs running at large, 15 bite quarantine dogs. Reasons for the increase include people going back to work and an additional Animal Control Officer in the field. Prevention solutions include Ordinances and spay & neuter education thru pamphlets handed to each citizen promoting healthy breeding practices and hosting rabies vaccine clinics.

**Future Goals:** Bring Animal Control up to municipal standards with electronic citations to save time in the field, ensure tickets are submitted in a timely manner and lighten load on Police Records.

➤ The agreement with AT&T is to provide dedicated internet and voice bundle services at the Fire Department as a backup for major disruptions at the Municipal Building or internet outage at Fire Headquarters.

## TRAFFIC ADVISORY COMMISSION MEETING DECEMBER 15, 2021

The Traffic Advisory Commission duly met on Wednesday, December 15, 2021 at 12:00 p.m. at the City of Sedalia Municipal Building. The meeting was called to order by Chairman Esquivel.

Minutes from the October 13, 2021 meeting were approved previously via email.

#### OLD BUSINESS:

None

#### **NEW BUSINESS:**

#### Reduce Speed Limit on Tiger Pride Blvd. to 15 MPH

Currently the speed limit is 25 MPH. Ms. Ardrey stated she met with the Sedalia Police Department and Sedalia School District officials to discuss options and alternatives for making improvements in school zones. At that time, it was noted there is not a school zone posted along the roadway going into Smith-Cotton High School. There is also an area along Tiger Pride Blvd. where vehicles have gone over the curb and struck a utility pole on multiple occasions. It appears appropriate to reduce the speed along Tiger Pride Blvd. from 25 MPH to 15 MPH consistent with other school zones within Sedalia.

Mr. Callis motioned to approve the request. Mr. Matson seconded. All were in favor.

#### Intersection of E. Saline St. and N. Engineer Ave.

Public Works was contacted by Administration and the Sedalia Police Department concerning this intersection soon after the accident involving a child being struck by a vehicle. Public Works was requested to place a 4-way stop at the intersection until such time as a thorough accident investigation could be completed, as an abundance of caution.

Additionally, the speed coming north to south along Engineer Ave. from Reine Ave. to Union Pacific Railroad was reduced from 30 MPH to 25 MPH.

Ms. Ardrey asked the Commission to ratify the placement of the 4-way stop and the lowering of the speed limit. Once the accident investigation is complete any further action will be brought to the Commission.

Mr. Matson made the motion to ratify the placement of the 4-way stop sign at the intersection of E. Saline St. and N. Engineer Ave. and for reducing the speed limit coming north to south along Engineer Ave. to 25 MPH from Reine Ave. to Union Pacific Railroad. Mr. Henderson seconded. All were in favor.

#### Horace Mann School

New signs were put out to test drivers' attention. The City's consulting Traffic Engineer is looking at alternatives to slow traffic down in the school zone. Curb bump outs to narrow the driving lane and consideration of a speed table are being evaluated. Further information will be forthcoming.

#### **Washington School**

A Traffic Engineer is looking at Engineer Ave. from Reine Ave. to Broadway Blvd. related to speed. Traffic counts are currently being conducted in those areas.

While on the topic of the Washington school zone the new paint marking of crosswalks, reflective signage and mid-crosswalk signs at Skyline and Whittier School were also discussed.

#### **Heber Hunt School**

Mr. Kline stated the School Resource Officer does a great job directing traffic in the area, but there have been parents and non-parents parking along the south side of W. 5<sup>th</sup> St. which impedes the flow of the pick-up and drop-off line. The School during the meeting with Public Works requested the south side of W. 5<sup>th</sup> St. from S. Warren Ave. to S. Limit Ave. to be designated as no parking between the hours of 8 am and 4 pm Monday through Friday.

Another area of concern is the crosswalk located at W. 5<sup>th</sup> St. and S. Limit Ave. The intersection is not controlled by traffic control devices and it is five lanes for children to cross. Mr. Curry with the Sedalia 200 School District and Ms. Miller with the Bus Barn met with Mr. Kline and are working on a plan to bus the approximately 30-50 students who utilize the crosswalk on a daily basis. It will be safer to bus those students and reduce or eliminate the use of the U.S. 65 crosswalk by students and parents.

Additionally, Public Works will be adding "Do Not Block Intersection" signs at the intersection of W. 4<sup>th</sup> St. and S. Warren Ave. to help with traffic flow and line of sight issues.

Mr. Henderson made the motion to designate the south side of W. 5<sup>th</sup> St. from S. Warren Ave. to S. Limit Ave. as no parking on school days from 8 am to 4 pm. Mr. Leftwich seconded. All were in favor.

#### Update on Thompson Blvd.

Ms. Ardrey stated Public Works is requesting budget authority to resurface Thompson Blvd. next year. The roadway when originally engineered did not have a crown which allows water to stand on the roadway. This surface water causes ice to build in the winter and stormwater to stand in the roadway resulting in roadway markings deteriorating at an increased rate. The road is being designed with a crown, so the water will flow to the gutter and the Engineer is looking for a thermo-plastic marking material which will help with the markings on the roadway last longer.

#### OTHER ITEMS FOR DISCUSSION:

There was general discussion concerning MoDot intersections in town.

AN ORDINANCE AUTHORIZING A CONTRACT AMENDMENT TO A SUPERVISED WORK RELEASE PROGRAM AGREEMENT BY AND BETWEEN THE CITY OF SEDALIA, MISSOURI AND MISSOURI DEPARTMENT OF CORRECTIONS, DIVISION OF ADULT INSTITUTIONS, TIPTON CORRECTIONAL CENTER.
WHEREAS, the City of Sedalia, Missouri, by Ordinance No. 11306 dated January 19, 2021, approved an agreement with the Missouri Department of Corrections, Division of Adult Institutions, Tipton Correctional Center wherein the Tipton Correctional Center would provide 15 worker offenders per day per work week for up to one year to assist the City in maintaining its cemetery, airport, and streets and allow the said offenders to gain work skills; and
WHEREAS, the Missouri Department of Corrections desires to renew and execute a one year contract amendment to said agreement for another year from May 1, 2022 to April 30, 2023, as more fully described in the proposed amendment attached to this ordinance and incorporated by reference herein.



Subject: Update to City Code related to Sewers pursuant to MDNR Permitting

Requirements and Evaluation of Industrial Pretreatment Local Limits

Attached for approval from Council is an update to City Code related to sewers and local limits as submitted in draft form and approved by the Missouri Department of Natural Resources.

Pursuant to requirements in the Missouri State Operating Permit Numbers MO-0023019, MO-0023027 and MO-0101567 for the City of Sedalia's Central, North and Southeast Wastewater Treatment Plants which became effective on April 1, 2019, the City was required to submit a detailed reevaluation of the City's industrial pretreatment program including local limits during each permit cycle. This local limits review and the City Code related to the City's pretreatment program are the methods used to ensure wastewater effluent returned to local streams is within the permit limits for specific pollutants. In order to meet these limits, industrial contributors within the City are required to apply for a permit for wastewater contribution and each of the industrial contributors are provided a share of the local limit for each pollutant they contribute to wastewater treated at the City's facilities. (Note: The City currently permits: Maxion Wheels, Nucor Steel Sedalia, WCA-Central Missouri Landfill, Inter-State Studios and Publishing, Stanley-Black and Decker and Sierra Bullets/Starline Brass. 



Dear Ms. Ardrey:

As part of the Water and Wastewater Master Plan project, the City of Sedalia requested an evaluation of the commercially available hydraulic modeling software. The intent of this letter is to deliver the water and wastewater software and model recommendations. The recommendations presented herein are based on correspondence with City staff during software review meetings, model demonstration efforts, model workshops, and model/software conference calls. Goals of the referenced meetings were to evaluate hydraulic modeling software and providers. The two software providers evaluated were Bentley and Innovyze, two common hydraulic model providers in the industry. The pros and cons of each software were discussed for a variety of criteria based on the City of Sedalia required use. Criteria included: ability to model current and future needs, data management, connectivity with other GIS software, common water and wastewater platform, ease of use for existing staff needs, and cost. The ultimate goal was to reach a consensus on a preferred software for the City.

Meeting minutes and the software demonstration presentation are attached with this letter and, in their totality along with conference calls and in-person demonstrations, represent the technical memorandum and software selection requirements identified in the scope of services for both projects. Listed below is a summary of the work efforts completed on behalf of both projects:

- November 13, 2020: conference call with City staff initiating software selection process with questions to determine the selection criteria and action items; see meeting minutes attached.
- December 8, 2020: virtual model demonstration workshop with PowerPoint presentation discussing options available to City based on initial conference call. A virtual walk-through and demonstration of software options was presented. Meeting minutes and presentation are attached.
- 3. April 23, 2021: conference call with City staff discussing software selection and desire for an in-person model tutorial and workshop; no minutes taken.

- May 12, 2021: Master Plan Model Software Review Workshop hosted City staff at Burns & McDonnel for interactive model workshop to evaluate model software alternatives; no minutes taken.
- 5. Monthly progress reports discussing project status and requesting City's status on software selection decision from the project kickoff meeting through April 2021.

After completion of the model demonstration and workshop, City staff identified Bentley as the preferred software provider. Based on correspondence with City staff and the technical and modelling needs of both projects, the recommended model platforms for the Water and Wastewater master plans is WaterCAD V8i and SewerGEMS respectively. The City will proceed with procurement of the software directly with Bentley. If there are any additional questions your Burns & McDonnell team is available and look forward to continuing our path to completion.

As part of the Water and Wastewater Master Planning effort, Burns and McDonnell Engineering has worked with Public Works staff to review software for water and waste water system modeling. Burns and McDonnell based on discussions with City staff of our needs and their experience in working with other municipalities of similar size provided the City with two options for software, Innovyze and Bentley. Burns and McDonnell had available in their office for review and use by our staff using our system data both software packages. After evaluating both packages and considering costs associated with maintaining the packages in coming years, we believe the City's needs for water and waste water modeling software will best be met through the purchase of the Bentley products, WaterCADD and SewerGEMS.

In comparing the Innovyze's InfoSWMM and InfoWater with Bentley's WaterCADD Standalone and SewerGEMS, the Bentley Product was both more efficient (required less steps to achieve the same goal) and easier to use than the Innovyze products. Bentley products are also designed to be used as standalone software which means they do not require ArcGIS Pro to be used, as opposed to Innovyze which requires the City to upgrade our existing ArcGIS to ArcGIS Pro and to maintain a continual subscription for the software to be used. The Bentley product will allow for updating of the City's GIS system, but can be used easily on a laptop while in the field.

We originally procured services from Burns and McDonnell through our Request for Qualifications process and as part of their services, they provided software packages that they have evaluated and believe will best suit the City's needs. As this is specialized software and each company solely markets their product, we are requesting approval of the software without further bidding. Public Works would like to recommend the purchase of Bentley's WaterCADD Standalone and SewerGEMS.

Attached is a quote from Bentley for the WaterCADD Standalone for \$13,978.00 and SewerGEMS for \$20,968.00 along with a sole-source statement. Also attached is a quote from Innovyze for InfoWater Pro FOR \$14,085.00 and InfoSWMM for \$17,060. The City's budget includes \$19,781.00 in account 62-73-351-05 for water modeling software and \$19,781.00 in account 61-51-351-05 for waste water modeling software.

### OFFICE SPACE LEASE

This is a lease agreement by and between OATS, Inc., a private not for profit 501c3 corporation, ("Lessee" or Tenant") and the City of Sedalia, Missouri, a municipal corporation ("City", "Lessor" or "Landlord") for the lease of 2,120 square feet of office space located at the City of Sedalia's Amtrak Depot. This agreement is made and entered into on March 1, 2022, and will run concurrent with the original lease dated June 4, 2004, as amended on March 16, 2020 provided, however, that either party may terminate this lease by delivering to the other party a notice in writing of such termination at least thirty (30) days prior to the date of any such expiration.

### 1. Demise, Term and Rent

- a. In consideration of the covenants and agreements hereinafter set forth, City agrees to lease to Lessee the building space highlighted on the map in Exhibit A (Premises) at the Sedalia Amtrak Depot.
- b. The Lessee shall pay the Lessor \$600.00 per month, payable in advance on the first day of each month during the term of this lease. Rent is subject to change annually on July 1, with no less than 30 days' notice to lessee of proposed change.
- c. The term of this Lease ("Term") shall commence on the mutually agreed upon date set forth in recital introductory paragraph of this lease agreement. The Term shall be open-ended. The Term shall be terminated upon mutual written agreement by the parties or by Lessor as set forth in Section 4.a. Additionally, If the Lessee desires to unilaterally terminate this Term, it shall provide Lessor with written notice no less than 60 days prior to the last day of the final month of the Term. If the Lessor desires to unilaterally terminate this Term, it shall provide Lessee with written notice no less than 60 days prior to the last day of final month of the Term.
- d. Lessor covenants that the Lessee shall peaceably hold and enjoy the premises during the tenancy of the lease.

### 2. Special Related Conditions

- a. Lessee shall have the right of ingress and egress to and from the leased premises.
- b. City reserves the right to develop, improve, maintain and keep in repair the exterior public facilities of said depot building, together with the right to control and direct all activities of Lessee in such areas, regardless of the views or desires of Lessee, and without any interference or hindrance by Lessee. Lessee agrees not to exercise Lessee's rights granted under this lease in such a way as to interfere with or adversely affect the use, operation, maintenance or development of said rail passenger depot.
- c. Lessor and Lessee will not, on the grounds of race, color, age, creed, sex, physical handicap or national origin, discriminate or permit discrimination against any person or group of persons in any manner prohibited by law or by any rules or regulations of the Secretary of Transportation of the United States. City reserves the right to take any such action as the United States may direct to enforce this covenant.

### Lessee Covenants.

- a. Lessee shall only use the premises for office space pertaining to their business, and have no other business ventures which occupy the premises. Lessee shall not sub-lease the premises or assign rights in this lease, except as expressly permitted in writing by the City of Sedalia. That they will not make or suffer any unlawful, improper, or offensive use of the premises, or any use or occupancy thereof contrary to any law of the state or any ordinance of the city now or hereafter made, or which shall be injurious to any person or property, or which shall be liable to endanger or affect any insurance on the building or to increase the premium thereof.
- b. Lessee may, subject to the written approval of Lessor, alter, modify, repair and maintain said leased premises with the Lessor having the right to inspect.
- c. Lessee will keep all the building and premises, including the heating, in such repair as the same are at the commencement of the said term or may be put in during the continuance thereof, reasonable wear and tear and damage by fire or other unavoidable casualty only excepted, and will promptly replace all glass thereof broken during the said term by other of the same size and quality.
- d. Lessee will not injure, overload, or deface or suffer to be injured, overloaded, or defaced the premises or any part thereof.
- e. Insurance. During the term of the lease, Lessee shall maintain:
  - i. liability insurance for bodily injury and property damage in any amount of at least a minimum of \$250,000 per occurrence, and
  - ii. Lessor shall be an additional insured payee on said policies by name and address, and Lessee shall provide Lessor with copies of said policy within five (5) days of request by Lessor. Said insurance shall not be cancelable without thirty (30) days written notice to Lessor. Lessee shall be responsible for and pay for its own premium relative to any contents insurance which it desires to procure on any personal property.
- f. At the expiration of the term Lessee will peaceably yield up to the Lessor the premises and all erections and additions made upon the same, in good repair in all respects, reasonable use and wear and damage by fire and other unavoidable casualties excepted, as the same now are or may be put in by the landlord.
- g. Lessee will promptly pay all gas, electric light, and water rates or charges which may become payable during the continuance of this lease for gas, electric light, and water used on the premises.

### 4. Default By Tenant

a. If tenant defaults in the payment of rent and remains in default for ten (10) days after a notice to pay is delivered to tenant; or if tenant defaults with respect to any other covenant and remains in default for thirty (30) days after a notice to cure default is delivered to tenant (or fails to take

reasonable steps to cure the default if such takes longer than 30 days); then landlord, at its sole option, may elect to do any of the following:

- i. demand that tenant vacate the premises, with which demand tenant shall promptly comply; and if tenant fails to promptly vacate, landlord may reenter the premises, with or without court order, change the locks and take other steps to exclude the tenant from the premises;
- ii. re-let the premises as an agent for tenant; or
- iii. terminate the lease by delivering or mailing to tenant an express notice of lease termination, it being agreed that nothing less than an express notice of termination will terminate this lease.
- b. If landlord reenters the premises pursuant to Paragraph 4(a) above, or if tenant vacates the premises and delivers proper notice of such to landlord, then landlord, without terminating this lease, agrees to make reasonable efforts to mitigate tenant's damages by obtaining another tenant.
- 5. In the event either party to this lease is required to bring any action at law or in equity against the other party to enforce any terms of this lease, the losing party hereby agrees to pay the prevailing party's reasonable attorney fees (including appellate fees), as they may be set by the court in which the original action was brought. If the landlord is awarded attorney fees pursuant to this paragraph, such fees shall be considered additional rent.
- 6. All property of any kind that may be on the premises during the continuance of this lease shall be at the sole risk of the tenant, and that the landlord shall not be liable to the tenant or any other person for any injury, loss, or damage to property or to any person on the premises.
- 7. If the building is less than 50% destroyed or rendered temporarily uninhabitable, the Lessor shall, upon request by lessee, repair the damage thereto at its costs and expense to the extent of proceeds from any insurance coverage. Rental in such circumstance shall be temporarily apportioned based on that portion of the building available for use during the period of repairs. If the building is totally destroyed (more than 50%), Lessor shall have the option of terminating this lease or rebuild the buildings on the premises up to the amount of the insurance proceeds.
- 8. During the term of this lease or any extension thereof, Lessee agrees to protect, save and keep the Lessor forever harmless and indemnified against and from any penalty of damage or charges imposed for any violation of any laws or ordinances whether occasioned by the neglect of Lessee or those holding under Lessee, including but not limited to those pertaining to pollution, toxic chemicals and matters governed by the Environmental Protection Agency or the Missouri Department of Natural Resources and that lessee will at all times protect, indemnify and save and keep harmless Lessor against and from any and all loss, cost, damages or expense, arising out of or from any accident or other occurrence on or about said premises, causing injury to any person or property whomsoever or whatsoever and will protect, indemnify and save and keep harmless Lessor against and from any and all claims and against and from any and all loss, cost damage or expense arising out of any failure of Lessee in any respect to comply with and perform all requirements and provisions hereof.

- 9. Lessee shall permit City and its agents, officers and employees to enter into and upon said premises at all reasonable times for the purposes of inspecting said premises and posting notices.
- 10. No act or failure to act by City shall be deemed a waiver of any of City's rights herein. In the event of any of the provisions of this lease shall be contrary to the laws of the State of Missouri or any other law, rule or regulation applicable to this lease, the said provisions shall be void and all other provisions of said lease shall remain in full force and effect.
- 11. This lease shall be binding upon the parties hereto and their successors, assigns and transferees as permitted under said lease.



Subject: CDBG Grant Council Resolutions

The City will be submitting a Community Development Block Grant application proposing to install, repair and replace failing sidewalks, curb and gutter in the Midtown 353 Redevelopment Area and the south section of the city (generally bounded by the residential properties from the east city limits west to Park Avenue, and from south city limits to the north city limits).

The total project cost is estimated at \$1,000,000. The city will propose to contribute \$464,440 in cash, \$35,560 in-kind labor by city project managers, inspectors and crews and demolition equipment hours, with grant funds of \$500,000 needed to make up the balance. The project, if funded, will benefit 52.1% low/moderate income persons.

The grant application requires that the city have resolutions in place for the following items in order to be considered for the grant:

- 1. Resolution to Apply for the Grant
- 2. Fair Housing Resolution
  - 3. Excessive Force Prohibition Resolution
