<u>Finance/Administration Committee</u> - There is are two items for consideration through the Finance / Administration Committee.

- 1. I will provide a brief update on the major tax revenue collection trends.
- 2. The City uses Sensus Analytics as the software package that partners with our water meter equipment to bring in the meter readings and upload them to the utility billing software. As the billing software was migrated over to our accounting systems, the meter reading systems was upgraded and the agreement amended. The vendor did not submit the invoice for the annual maintenance and licensing agreement for the last year. This was budgeted for in both last year and this year, however the payment for last year is now rolled over into this year. Staff recommends a budget amendment to appropriate the funds that were not spent last year in this year.

<u>Public Works Committee</u> – There is one item for consideration through the Public Works Committee.

1. Roger Waters, Cemetery Director, included in his strategic plan the purchase of another columbarium. Recent trends indicate that a 64-niche columbarium supports about three years of requirements. Due to the lead times being up to a year, we plan to order a new unit when about two thirds of the last unit has been committed. Through the budgeting process, funds were appropriated for this purchase. Staff sought out bids and received two, with the lowest being from M&R Monument Co. for \$21,500. This is also the amount budgeted for this item however since we will have some costs to install the proper footings, we will be committing to approximately \$1,700 more than the current budget. The expenditure for the purchase will almost certainly not take place until next fiscal year, so no budget amendment is recommended at this time though. Staff recommends award to the low bidder.

<u>Public Safety Committee</u> – There are three items for consideration through the Public Safety Committee.

- As discussed during the June 20 council meeting, Chief Irwin has developed a plan to deploy squad trucks in addition to our current equipment. At this meeting staff recommended, and council approved, a plan to go forward with the order of two units this year rather than one this year and another next, since they will not be able to be delivered until next fiscal year. Staff recommends approval of a budget amendment for this fiscal year to show the encumbrance of currently available funds that will not be expended until next fiscal year.
- 2. As a rather routine housekeeping matter, the police department has identified specific records that have met their retention requirements and recommends approval of the proper destruction of such records.

3. For the past several years, the police department has been successful in securing a Justice Assistance Grant (JAG). The grant requirements include allocating 40% of the grant proceeds to the Pettis County Sheriff's Department as a subrecipient. These funds help offset the costs of equipment to enhance the operations and effectiveness of both agencies. This year the City intends to use these funds to offset about 75% of the costs of two car radios. Staff recommends approval of a resolution to authorize staff to apply for the grant, and in doing so, commit to the applicable compliance requirements.

Councilman Oldham stated the July 4th parade had a great turn out of citizens, floats and entries. The cookout put on by Parks & Recreation went smoothly despite the heat and 500 hot dogs were served. City Administrator Kelvin Shaw added the fireworks display was good.

City Attorney Nathan Nickolaus stated Governor Parsons signed House Bill No. 1662 on Thursday, June 29, 2022. This will be an important bill for cities as it cuts home occupation ordinances. If Council doesn't object, a new home occupation ordinance will be drafted for Sedalia. The bill talks about "no impact occupations" which allows an unlimited number of customers/employees in the business/house up to what the Fire Code allows. Certain businesses couldn't be prohibited and hours of operation can't be limited. Councilman Robinson asked if zoning would be involved and City Attorney Nathan Nickolaus said the city is not allowed to require any zoning permits and commercial businesses can now be allowed in any residence within the City.

Councilman Marshall stated he has seen campaign signs in right-of-ways and where they are not allowed. Councilwoman Foster stated it was discussed in committee meeting and it will be addressed. If they are placed improperly they are removed.

Minutes from the January 12, 2022 meeting were approved previously via email.

OLD BUSINESS:

NEW BUSINESS:

Horace Mann Elementary School

Ms. Ardrey gave an update on this school zone and presented the Traffic Engineer's study recommendations to help channel traffic in the area (see attached). The recommendations are to extend the curbing (bump-outs) without removing parking, installing a safety island which is a raised median in the center of the street and the painting of ladder style crosswalks. Ms. Esquivel inquired if there was money available for the project and Ms. Ardrey said a request for this was made during the budget process and the School District has also made some funds available to help improve the safety of the school zones. Mr. Henderson inquired if the project would be completed by the start of school in the fall and Ms. Ardrey anticipates it's completion by then.

Ms. Broyles made the motion to accept the Traffic Engineer's recommendation of the installation of the curb bumpouts, the safety island and painting of the crosswalks. Mr. Matson seconded. All were in favor.

Skyline Elementary School

The mid street signs have been used in this school zone and they have been struck repeatedly and are designed to break apart upon impact of over 40 mph. Mr. Kline stated so far they have been broken apart at least ten times. The plan for this school zone is to put in rumble strips at lead in points so as drivers drive down W. 32nd St. they will hit the strips and it will alert them to the zone ahead. Two sets of rumble strips will be installed and additional signage and roadway painting will also be installed to alert drivers of the rumble strips ahead.

Ms. Broyles made the motion for the installation on the rumble strips, signage and roadway painting on W. 32nd St. for the Skyline Elementary school zone. Mr. Henderson seconded. All were in favor.

Washington Elementary School Zone

Traffic counts will be conducted by Washington Elementary to determine the amount of traffic in the school zone. Ms. Ardrey has been in contact with MoDot about the marking on 50 Hwy. Signs will be moved to the appropriate places and additional signs will be installed to alert drivers of the school zone ahead. A Traffic Engineer will also be evaluating alternatives for this school zone and crossing.

Some improvements are also being planned for Tiger Pride Blvd.

OTHER ITEMS FOR DISCUSSION:

Ms. Ardrey also indicated there will be a crosswalk and signage installed and the intersection of W. 2nd St. and S. Kentucky Ave. by the newly completed Katy Trail Health Center.

Resident Sherry Harris voiced her concern about the traffic exiting the Heckart Community Center and not stopping as they are entering Liberty Park Blvd. and W. 3rd St. She said vehicles exiting the Community Center have almost struck her vehicle several times. Ms. Ardrey stated Public Works is already working on the issue. Locates have been called in and as soon as those are completed stop signs will be installed in the parking lot at the north and south entrances.

Re: Washington - Intersections Study

Background

Wilson & Company was tasked to conduct a traffic study at the intersection of 16th Street/S Park Ave/S Stewart Ave in Sedalia due to a concern of speeding through this area. The intersection is located next to Horace Mann, a local elementary school. Speed limits in the corridor are set at 15 MPH in a school zone, and the intersection is not STOP controlled.



The study location is near Horace Mann Elementary School and near major highway 65. Horace Mann contributes a significant portion of pedestrian traffic through intersections of 16th St and Stewart Ave and 16th St and Park Ave.



Data Collection

Wilson & Company was provided traffic violations involving speeding by the Sedalia Police Department on April 28th, 2022, covering violations from April 24th, 2020, to April 24th, 2022. The traffic violations were on W 16th St between S Grand Ave and S Barrett Ave. With over 293 traffic stops, 99 were for speeding violations and of the 99, 70 were in the school zone. Additionally, 112 traffic complaints were submitted and 8 of the complaints were for excessive speeding.

Recommendations

With the level of pedestrian activity in the area of Horace Mann, urban design treatments can be used to assist in calming traffic speeds. Features to reduce the roadway width for crossing, which also restricts the feel of the road can assist in reducing travel speeds. This can be accomplished by either creating a raised median in the center of the street that can also serve as a pedestrian refuge area, or by reducing the roadway width by developing bump-outs at the intersection. In this case, a blending of the two treatments can be used to create greater definition at the intersection and provide pedestrian safety enhancements at the intersection. The Figure below illustrates the recommended concept.

Prior to the integration of the water department verbal approval was given for an upgrade to the "Enhanced Package" of Sensus Analytics. Apparently, this required the execution of a First Amendment to the Advanced Metering Infrastructure Agreement before they would provide an invoice for their maintenance services. On March 7, 2022, the First Amendment to the Advanced Metering Infrastructure Agreement was signed at which time I requested an invoice for the services rendered in 2021, as the funds to pay for that expense were budgeted in FY22. On June 16, 2022, the attached invoice was received from Core & Main for the Sensus Analytics maintenance services for both 2021 and 2022. We have only budgeted for payment for one year of service in FY23 and need to request a budget amendment to appropriate the additional funds necessary to pay the invoice in full.

2022 EDWARD BYRNE JUSTICE ASSISTANCE GRANT (JAG) PROGRAM

This Agreement is made and entered into this 18th day of July, 2022, by and between The COUNTY of PETTIS, acting by and through its governing body, the County Commissioners, hereinafter referred to as the COUNTY, and the CITY of SEDALIA, acting by and through its governing body, the City Council, hereinafter referred to as the CITY, both of Pettis County, State of Missouri, witnessed:

WHEREAS, this Agreement is made under the authority of laws of the State of Missouri; and

WHEREAS, each governing body, in performing governmental functions, or in paying for the performance of governmental functions hereunder, shall make that performance or those payments from current revenues legally available to that party; and

WHEREAS, each governing body finds that the performance of this Agreement is in the best interests of both parties, that the undertaking will benefit the public, and that the division of costs fairly compensates the performing party for the services or functions under this agreement: and

WHEREAS, the CITY agrees to provide the COUNTY \$5,710.00 from the JAG award, if awarded, for the purposes of enhancing law enforcement in Pettis County: and

WHEREAS, the CITY and COUNTY believe it to be in their best interests to reallocate the JAG funds.

NOW THEREFORE, the COUNTY and CITY agree as follows:

Section 1.

CITY agrees to pay COUNTY a total of \$5,710.00 of JAG funds, if awarded.

Section 2.

COUNTY agrees to use \$5,710.00 for the JAG program until 30th day of September 2023.

Section 3.

Nothing in the performance of this Agreement shall impose any liability for claims against the COUNTY other than claims for which liability may be imposed under the Statutes for the State of Missouri.

Section 4.

Nothing in the performance of this Agreement shall impose any liability for claims against the CITY other than claims for which liability may be imposed under the Statutes for the State of Missouri.

Section 5.

Each party to this agreement will be responsible for its own actions in providing services under this agreement and shall not be liable for any civil liability that may arise from the furnishing of the services by the other party.

Section 6.

The parties to this Agreement do not intend for any third party to obtain a right by virtue of this Agreement.

Section 7.

By entering into this Agreement, the parties do not intend to create any obligations express or implied other than those set out herein; further, this Agreement shall not create any rights in any party not a signatory hereto.
