Re: Agenda items for City Council meeting on Tuesday, September 6, 2022, 6:30 p.m.

<u>Public Hearing – Closeout CDBG Grant</u> The City was able to partner with State Fair Community College (SFCC) to obtain a \$500,000 Community Development Block Grant (CDBG) to assist with the construction of the Olin Howard Workforce Innovation Center. This is a "pass through" grant in that the City is the grantee and passes through the funds to the sub-grantee, SFCC. The CDBG program requires a hearing as part of the process to "close out" the grant. This hearing is to let the public know what the proceeds of the grant were used for, and to allow for any public comments on the project. Community Development Director Simmons will present the information for the hearing.

<u>Finance/Administration Committee</u> - There are six items for consideration through the Finance / Administration Committee.

- 1. With body art becoming more prevalent, we have reviewed the related personnel policies and recommend an update. The current policy requires the Department Head to make a recommendation to the City Administrator for specific approval on a case by case basis. Staff proposes to change to a policy that prescribes action only when body art or jewelry is deemed offensive or interferes with the employee's job function. Staff recommends approval.
- Councilman Robinson brought forth a recommendation to purchase some art work to display
 at City Hall. Since this was not a budgeted item, staff pulled together a budget amendment
 for Council's consideration.
- 3. Retrieving Freedom and Craft Beer Cellar have submitted an application to host an event downtown, and for that event close certain streets and suspend the liquor open container laws. In the request, they asked to close Ohio Street from Broadway to 7th and 7th from Ohio to Osage. Staff explained to them that closing the intersection of Ohio with Broadway would also require Missouri Department of Transportation (MODOT) approval and that we doubted they would grant it. Staff recommends the granting of the street closure not to include the section of Ohio from Broadway to the alley in the 700 block. Also, in their application they requested volunteer security. Staff advised them that we would not recommend to Council a volunteer security staff. The City has been very cautious in the suspension of open container laws in the past, and have only done so with the requirement of paid police officers in uniform ensuring security during the event. Staff recommends continuation of this precedent. Retrieving Freedom subsequently agreed to cover the costs of the paid police officers for security. As for other events of this nature in the past certain conditions have been agreed to that include, checking identification to ensure legal age for consumption of alcohol and issuing a wristband indicating such. Also, open containers will only be allowed in a special, easily identifiable container by individuals with a wristband, and then only within the designated

- area during the specific times of the event. With these conditions staff recommends approval of the ordinance proposed.
- 4. Jessica Pyle has joined the team as our Finance Director. In accordance with our Code, the Finance Director also serves as the Treasurer for the City. In both of these capacities, she needs to have signatory authority to effectively represent the City in transactions with our financial partners. In connection with this level of responsibility, we have purchased a specific insurance bond coverage for her as we have for previous Finance Directors. Staff recommends approval of the ordinance authorizing adding her to the signature cards for all of our depository and investment relationships.
- 5. It has come to our attention that the Office of Homeland Security is making grant funds available to do assessments of cyber security vulnerabilities. Staff recommends adoption of a resolution authorizing and directing staff to apply for a grant under this program in the amount of \$15,000.
- 6. Last fiscal year Monte Richardson included in his strategic plan, and the related budget, a project to bring up to date our Microsoft products. The City's network and many functions are deeply dependent on software from Microsoft and many of those products are over ten years old. As is customary, Microsoft is phasing out support for these older versions of their software, so to keep them protected from viruses and working as intended, we must upgrade them to the newer versions. Due to the many moving parts to this project, he was unable to get it completed before he had to go on an extended medical leave. Also, the budget adoption for this year took place while he was out on medical leave. Not having good information to estimate the costs of these open projects, we just proposed a bare bones budget. The thought was that when he returns and we have good information we would then revisit the budget with Council. He has since returning, worked with a new representative with the vendor to get a clean quote under the state procurement program. Staff recommends approval of a budget amendment for the anticipated software upgrades, including this one, and award of the quote to purchase upgrades of our Microsoft software products for \$38,554.21.

<u>Public Works Committee</u> – There are seven items for consideration through the Public Works Committee.

1. We have been approached by a non-profit organization that is an extremely low volume water and sewer user to see if they could get some relief on their water and sewer rates. This particular organization is in a residential structure with limited occupancy. Under the current fee schedule they are classified as commercial, which has a base monthly rate of \$53.71 for sewer. The base monthly rate for residential customers is \$13.13 for sewer. The volume charges are the same for all types of customers and the water charges are based on the size of supply line, as opposed to the type of customer. Rates are set through a rate study that breaks down the costs of providing the utility and attempts to match the rates to what is driving the costs. In general, the base rates are set to offset the costs of providing the infrastructure to the property, and the volume charges are set to offset the costs of the treatment of the water and wastewater. The variation in the base charges also comes from this detailed analysis. Regardless of the allocation amounts, in general the total of all charges must be sufficient to cover the costs in the long run. We point this out just to provide background and point out that decisions on rate changes cannot be made in a vacuum, as they have a ripple

- effect. Brenda Ardrey, Public Works Director will be prepared to discuss with you as you deliberate on what changes, if any, you want to make to the rate structure.
- 2. As part of the ongoing planning for a replacement for our aging North Wastewater Treatment Plant, we must take steps to ensure that the replacement plant will qualify for the permits needed to operate. This process includes a study to show the impact the proposed plant would have on the extent of degradation, if any, on the stream it will discharge to. Staff recommends approval of adding to the scope of work for the engineering firm we are working with on this project to conduct the study.
- 3. Each year we contract with a firm that provides a chemical treatment to areas of our sewer mains that are know to be subject to tree root invasion. This is included in the budget at \$25,000 and the quote for this year is just under that amount, at \$24,785.54. Staff recommends approval.
- 4. Staff has learned of the availability of Traffic Engineering Assistance Program (TEAP) grant funds coming available through Missouri Department of Transportation (MODOT). These funds are targeted towards engineering costs to improve traffic flow and safety. Staff has identified Engineer Avenue from 7th Street to the Northern City Limits as an area of significant need for this type of assistance and recommends approval of a resolution authorizing and directing staff to apply for a \$12,000 grant under this program.
- 5. Serghei and Karina Comerzan have requested utility services from the City for property located outside the city limits. Staff has negotiated an agreement that in return for extending services, they would grant the perpetual right of the City to annex the property if it ever becomes contiguous to the city limits. This agreement is consistent with past practices and agreements in other similar situations and staff recommends approval.
- 6. During the strategic planning and budget development process, we proposed the replacement and upgrade to the water main along Locust Lane. This water line is beyond its useful life and often has to be repaired. In accordance with our procurement policies, we issued an invitation for bids and received five bids. Staff recommends award to the low bidder, Orr Wyatt Streetscapes from Raytown in the amount of \$144,815. This is over the budgeted amount for this project of \$110,515. Staff will monitor the total budget and if this cannot be made up in other projects, we will develop a recommendation to Council later in the year.
- 7. As part of our Tree City USA program participation, we have obtained a Tree Resource Improvement and Maintenance (TRIM) grant for the past several years. This grant provides funds to employ a specialist to inventory the trees in the city right of ways and parks, along with a report on maintenance needs to keep them healthy. Staff recommends approval of a resolution authorizing and directing staff to apply for a \$10,000 grant again this year.

<u>Community Development Committee</u> – There are three items for consideration through the Community Development Committee.

We received a special use application to allow an animal crematorium. Upon review of
this section of our zoning code, we identified a barrier to consider this application. The
text of the current code would only allow consideration of a human crematorium. Staff
worked with legal counsel and the Planning and Zoning Commission (P&Z) to schedule a
public hearing before the Commission and then consideration of this text change to the

zoning code. After the public hearing and deliberation among the commission members, P&Z voted unanimously to recommend adding animal crematoriums to the section that allows for consideration for a special use permit. Staff also recommends approval. It should be noted that this code does not automatically allow this use, as it just allows you to consider them as a special use under those provisions of the code.

- 2. As mentioned for the last agenda item, we received a special use permit application for an animal crematorium from Chad McNeal to be located at 1520 West Spring Street. If you have approved the text change to the code, you may now consider this application. The Planning and Zoning Commission (P&Z) held the required public hearing, and after public comments were addressed and their deliberations, they voted unanimously to recommend to Council approval of the permit. Staff also recommends approval. Both of these recommendations are contingent upon approval of the text change presented in the previous agenda item.
- 3. As discussed in previous meetings, we obtained a grant and a generous donation from the Haydens to commission the painting of a mural on the side of the building owned by the Hoffert family housing Stone Laser Imaging. Additionally, this alley was resurfaced and plans are underway to add lighting making it a more usable public space and attraction. The Hoffert family has requested that the alley be named "Freedom Alley", in honor of all the mural represents. Staff recommends approval.

<u>Public Safety Committee</u> – There are three items for consideration through the Public Safety Committee.

- 1. As discussed last meeting, included in the budget for this fiscal year is \$79,000 for the purchase of two new patrol vehicles for the police department. With the ongoing supply chain disruptions, we were unable to secure new vehicles as intended. Chief Wirt was able to locate two used vehicles from the Kansas State Highway Patrol to help us continue to fill the gap until we can again start obtaining new vehicle replacements. Council approved the purchase of two used Dodge Durango's for \$58,200. We mentioned at that time that we were expecting the manufacturer to open the window to order next year model vehicles soon and that we would bring you a recommendation to enable us to get on their build schedule. Staff now recommends a budget amendment to appropriate the funding and authorize the order of the vehicles. It is highly unlikely that the vehicles will be delivered this fiscal year, however approval of the budget amendment will appropriate the funds and allow them to be encumbered with the order. This is necessary to meet the constitutional requirements of not committing beyond currently available funds. If the vehicles are not delivered by the end of the fiscal year, then the encumbrance will expire in accordance with our policies, and we will reinstate the budget next year. In order to move back towards the replacement schedule as patrol vehicles wear out, we suggest ordering four patrol vehicles. At the same time, we propose to order the fire command vehicle that is already budgeted this year. Therefore, the proposed budget amendment is for four police patrol vehicles in the amount of \$167,596. Staff recommends approval.
- 2. Our mobile communications for public safety depend on equipment strategically located throughout the community to provide links to the receiver towers. One link has been discovered as not operating and upon investigation; it appears it was struck by lightning rendering it not repairable. The replacement equipment is not compatible with the receiver that this links

- with so it also needs to be upgraded to reestablish these communications. The total cost estimate is \$13,974.55. Due to the essential nature of this equipment, and the unusual lead times, we declared this an emergency purchase in accordance with our procurement policies to authorize Chief Wirt to go ahead and get the equipment ordered. Staff recommends approval of the budget amendment and ratification of the authorization of the purchase.
- 3. We have experienced several unanticipated vehicle repairs in the police department. Most of these unusual repairs were due to insured accidents, and most of those were not the fault of our officers. Even though the insurance is covering the majority of these costs, the line item for the expenditure is being depleted and the appropriation thereby needs to be increased to show the use of the insurance proceeds. The net increase of expenditures over the added revenues is \$7,192.36, which represents the insurance deductibles on four vehicles along with a major repair to another. Staff recommends approval.

The City of Sedalia will hold a public hearing at 6:30 pm during the regular Council meeting on Tuesday, September 6, 2022, in the Council Chambers at City Hall to discuss the past performance by the City in carrying out the City's 2018 Community Development Block Grant project to assist State Fair Community College build a new 35,500 square foot technical training facility to house both its current Welding and Machine tool programs. The completed facility will increase SFCC's training space by 200% for all the manufacturing training programs.

The build project is a two phased plan with the first phase funded by this Workforce Training Initiative. Phase one will construct the shell of the building and finish 20,885 sq. ft. for the Welding programs with 11,750 sq. ft. of lab space and 9,135 sq. ft. for seven classrooms and other finished space. The 7,000 sq. ft. of vacated lab space will provide additional hands-on learning space for workforce development training in industrial maintenance and advanced manufacturing. The two vacated classrooms can then be used to support SFCC's growing apprenticeship programs and additional workforce training courses.

Kevin Wade, Chairman called the meeting to order & opened the public hearing at 5:30 pm.

Re-zoning of 1907 W 4th. Ben Ross with Engineering Survey & Services along with the property owner, Victor Garnik. Ben presented the information for 1907 W 4th. As far as Ben can remember this property has never been developed. Would like to rezone from R-1 to R-2. Had a preapplication meeting with city staff to work out issues of zoning as well as flood plain. Property is in the flood plain & have a strategy to address that & confident will be able to get that removed by the Federal Emergency Management Agency. In the packet is a floor plan & the architects rendering of the proposed duplexes. Ben said it's interesting in Sedalia you are allowed to build townhouses in R-1. One of the options looked at was a 2 story buildings that are connected like a row house, those are allowed in R-1. Didn't think that would work well with the neighbors being single story ranch houses. Victor liked the idea of a duplex better. In discussion with city staff really focused on the Comprehensive Plan which the City adopted a couple of months ago in September 2021. It identified

501 E 28th, 505 E 28th & 2720 S Ingram. John Simmons stated have an application from Pioneer Properties LLC to develop 501 E 28th, 505 E 28th & 2720 S Ingram. Present use of the parcels are vacant land. Desired use is 24 unit multi-family complex along 28th St with retail & residential along the Ingram border. Currently zoned R-1 and request to rezone to C-1 zoning to accommodate the multi-family & multi-use application. Applicant, Bryant Dawson, in attendance. Request is to rezone R-1. Would like to bring housing to Sedalia. Would be between 20-24 unit complex, working with the engineer to expand to 24 unit. Vincent's Pawn Shop building would be demolished & would be developed into retail lower & mix use in the upper. Bryant handed out a packet of information, on page 2 is the proposed property layout. Building zones highlighted in

red & parking in yellow. Page 3 indicates the 20 unit building, however, working with the engineer for a 24 unit building if space allows. Layout will be 50/50, 2 bedroom & 3 bedroom & all will have 2 bath units, that's the most we have requested in Sedalia. Currently own a fairly large property management company, have 400 units under management. Get about 100 inquires a day on these types of units & that's the reason we would like to build these. Ann asked if these would be rental properties? Bryant indicated they would be, would be on the higher end rentals. Bryant provided pictures of cabinetry they have done previously. Connie asked if there would be garages? Bryant said this property wouldn't allow for garages, would be too compact. Connie asked how many parking spaces per unit? Bryant said waiting on engineering for that information, plan is to have a covered VIP type parking along the back, would like to get an entrance off S Lafayette and another entrance off 27th & would have a big L shape for parking. John Simmons indicated the zoning requirements is 2 spaces per unit. Chris wanted to know what kind of retail would be there? Bryant said at this time the retail has not been fully established, the portion that retail would be on is already zoned commercial, that will be coming in stage 2 & 3 of this plan. Teresa asked what kind of outdoor lighting there would be? Bryant indicated there would be dust to dawn lighting on the full exterior of the building. Val wanted to know if he has built any of these anywhere else? Bryan said they have not built any 24 plexes like this. Have built several houses & done tons of renovation in Sedalia & around. Kevin Wade asked if there was anyone in the audience to speak for or against the proposed zoning? Val wanted to know if these would be brick front buildings? Bryant said no they would not be, they will be siding to keep up with the neighborhood theme. With no further questions or comments Jeff Leeman made the motion to close the public hearing. Chris Marshall seconded the motion. All approved.

The City allows reasonable self-expression through personal appearance, unless it conflicts with an employee's ability to perform their job effectively or with their specific work environment, or it is regarded as offensive or harassing towards others.
Factors that management will consider when determining whether jewelry or tattoos pose a conflict with the employee's job or work environment include: Personal safety of self or others, or damage to City property. Productivity or performance expectations. Offensiveness to co-workers, customers, vendors or others in the workplace. City or societal norms. Customer complaints. If management determines an employee's jewelry or tattoos present such a conflict, management in conjunction with Human Resources will decide appropriate action."

The Human Resources Department is requesting an update to the Personnel Policies Manual. As you are aware, there are several policy updates, additions, changes and revisions that are needing to be made to our current version of the Personnel Policies Manual.

A change that is currently being recommended is:

We have been asked to review and update our current policy on tattoos and piercings. Below is our current policy and the draft language being proposed for Council's review.

Current Policy:

SECTION 7.11 PERSONAL APPEARANCE AND DRESS CODE

City employees are expected to exhibit appropriate standards of dress, personal hygiene and cleanliness for their required duties and responsibilities in the workplace.

Employees who are provided with work uniforms are responsible for the care of those uniforms and shall wear the assigned uniform while working for the city.

Employees are not permitted to have body ornamentation including, but not limited to, nose, lip, eyebrow and tongue piercing. Ear piercing, with no more than two piercings per ear, is permissible.

Body art and/or tattoos covering an area larger than the size of an adult fist shall be covered. No visible tattoos will be permitted on the head, neck, chest area or on the arm in a location more than six (6) inches below the shoulder. Any exceptions to the current policy must be requested by the Department Head to the City Administrator. Each case will be considered on a case by case basis and separately from any other exceptions that have been previously made. All City employees are public representatives and most are in the public eye:

Consequently, because some tattoos have the potential to create a negative impression to the public and even to the point of being inflammatory, every effort must be taken to avoid this potential situation. The final decision on whether an exception is granted to the tattoo policy lies with the City Administrator.

Hair styles and colors will reflect the city's professional atmosphere. Styles and colors in conflict with this atmosphere are not permitted.

Proposed Language:

The City recognizes that personal appearance is an important element of self-expression and strives not to control or dictate employee appearance, specifically with regard to jewelry or tattoos worn as a matter of personal choice. The City expects all employees to exercise appropriate judgment with regard to personal appearance, dress and grooming to be most effective in the performance of their workplace duties.

The City allows reasonable self-expression through personal appearance, unless it conflicts with an employee's ability to perform their job effectively or with their specific work environment, or it is regarded as offensive or harassing towards others.

Factors that management will consider when determining whether jewelry or tattoos pose a conflict with the employee's job or work environment include:

- Personal safety of self or others, or damage to City property.
- Productivity or performance expectations.
- Offensiveness to co-workers, customers, vendors or others in the workplace.
- · City or societal norms.
- Customer complaints.

If management determines an employee's jewelry or tattoos present such a conflict, management in conjunction with Human Resources will decide appropriate action.

The City uses Microsoft software almost exclusively from desktop applications like Office email, word, excel, etc., computer operating systems such as Windows 10/11 and Server 2016/2019 etc. Our agreement with Microsoft allows us to purchase software at a discount from commercial prices under volume licensing provisions at government pricing. The only pricing cheaper than government is education.

Many of the Microsoft products that we use were getting ready to expire last year. For example, we have been using Office 2010 for over 10 years. There have been three major upgrades to Office, Server, SQL and Exchange since then and Microsoft announced that 2010 versions of the software were no longer going to be supported. Last fiscal year I started the discussion with SHI Inc., the State of Missouri preferred vendor for IT purchases, to upgrade our licensing. I went through several iterations of quotes through 2021 with SHI as I had budgeted the money for software upgrades in anticipation of "end of life" for the software.

SHI was unable to quote the software that I needed before I had an extended medical leave that lasted several months. I wasn't able to make the software purchase before the end of the fiscal year or ensure that funding was carried forward to FY23. I have recently been assigned to a new account manager at SHI who was able to provide a quote according to our needs.

I have completed a software inventory based on our needs and compliance requirements from Microsoft. The attached quote from SHI reflects our needs at the present time. This includes three instances of SQL Server 2019 for finance, police records management and police statistical analysis as well as related user licensing. There is user licensing (Client Access License) for accessing Windows 2019 servers. And finally Office 2019 software for using email, documents, spreadsheets, etc.

I am requesting permission to purchase Microsoft software as outlined on the attached quote for \$38,554.21 from SHI Inc. under the Cooperative Procurement Agreement we have with the State of Missouri.

Proposed Scope of Services and Cost

North Plant Siting (Preparation of Antidegradation Report)

Antidegradation Report and ARPA Grant Request

Public Works is requesting City Council approval of the attached Burns and McDonnell Task Order #7 for work related to the siting of the new North Wastewater Treatment Plant specifically for preparation and submission of an antidegradation report to the Missouri Department of Natural Resources (DNR). This work will assist in obtaining DNR approval for the release of the effluent into Brushy Creek roughly 1½ mile north of the current North Wastewater Treatment Plant and determine feasibility of the site as a wastewater treatment plant. DNR requires submission of an antidegradation report for the siting of a plant with or without grant funds being considered. However, DNR notified the City that for the ARPA grant funds application for the new North Wastewater Treatment Plant (\$5M) to be considered eligible this antidegradation report would need to be submitted and reviewed by DNR prior to Oct. 12, 2022.

The proposed budget is \$33,000. The scope of work is to develop an Antidegradation Review Report for a Tier 2 protection level as discussed with the Missouri Department of Natural Resources. Burns and McDonnell will identify and assess potential of no-discharge options and non-degrading alternatives related to the siting of the new wastewater treatment plant. The base case will be determined and an alternatives analysis will be conducted to select the preferred alternative that is the least degrading and economically efficient option.

Here is a quick summary of the alternatives we have already started to evaluate:

- 1. Upgrade existing Trickling Filter facility: trickling filter technology is incapable of achieving desired ammonia effluent water quality or nutrient removal. Existing facility would require extensive overhaul, which would not be constructable due to necessity to maintain treatment during construction.
- 2. New MBR facility at new site: achieves excellent water quality, however additional energy and chemical would be necessary. Given the footprint flexibility of the identified property, the smaller footprint value of an MBR facility would be diminished relative to an oxidation ditch with effluent filtration, which can achieve water quality necessary to meet discharge requirements.
- 3. New Oxidation ditch facility with effluent filtration: will achieve water quality necessary for receiving stream and position for future nutrient removal biologically (TN and TP).

Other items related to anti-degradation:

- 1. Regionalization is not possible; Central WWTP (MO-0023019) is closest facility, but is landlocked. Further, the Capital Improvement Program identifies decommissioning the Central Plant in the future and consolidating with the new North WWTP.
- 2. No Discharge Alternative: not possible due to volume of wastewater to discharge, associated land required, and existing land values.

Task Order #7 is attached.

The approved Water Pollution Control Budget includes \$500,000 to begin the engineering work on the North Wastewater Treatment Plant. (\$500,000 - \$62,400 previously approved survey/geotechnical - \$33,000 = \$437,600).

WHEREAS, H-GAC hereby engages the Contractor to perform certain services in accordance with the specifications of the Agreement; and

ARTICLE 11: AUDIT

Notwithstanding any other audit requirement, H-GAC reserves the right to conduct or cause to be conducted an independent audit of any transaction under this Agreement, such audit may be performed by the H-GAC local government audit staff, a certified public accountant firm, or other auditors designated by H-GAC and will be conducted in accordance with applicable professional standards and practices. The Contractor understands and agrees that the Contractor shall be liable to the H-GAC for any findings that result in monetary obligations to H-GAC.

ARTICLE 12: EXAMINATION OF RECORDS

The Contractor shall maintain during the course of the work complete and accurate records of all of the Contractor's costs and documentation of items which are chargeable to H-GAC under this Agreement. H-GAC, through its staff or designated public accounting firm, the State of Texas, and United States Government, shall have the right at any reasonable time to inspect, copy and audit those records on or

off the premises by authorized representatives of its own or any public accounting firm selected by H-GAC. The right of access to records is not limited to the required retention period, but shall last as long as the records are retained. Failure to provide access to records may be cause for termination of the Agreement. The records to be thus maintained and retained by the Contractor shall include (without limitation): (1) personnel and payroll records, including social security numbers and labor classifications, accounting for total time distribution of the Contractor's employees working full or part time on the work, as well as cancelled payroll checks, signed receipts for payroll payments in cash, or other evidence of disbursement of payroll payments; (2) invoices for purchases, receiving and issuing documents, and all other unit inventory records for the Contractor's stocks or capital items; and (3) paid invoices and cancelled checks for materials purchased and for subcontractors' and any other third parties' charges.

The Contractor further agrees that the examination of records outlined in this article shall be included in all subcontractor or third-party agreements.

ARTICLE 13: RETENTION OF RECORDS

The Contractor and its subcontractors shall maintain all records pertinent to this Agreement, and all other financial, statistical, property, participant records, and supporting documentation for a period of no less than seven (7) years from the later of the date of acceptance of the final payment or until all audit findings have been resolved. If any litigation, claim, negotiation, audit or other action involving the records has been started before the expiration of the retention period, the records shall be retained until completion of the action and resolution of all issues which arise from it, or until the end of the seven (7) years, whichever is later, and until any outstanding litigation, audit, or claim has been fully resolved.

ARTICLE 14: CHANGES AND AMENDMENTS

- A. Any alterations, additions, or deletions to the terms of this Agreement, which are required by changes in federal or state law or by regulations, are automatically incorporated without written amendment hereto, and shall become effective on the date designated by such law or by regulation.
- B. To ensure the legal and effective performance of this Agreement, both parties agree that any amendment that affects the performance under this Agreement must be mutually agreed upon and that all such amendments must be in writing. After a period of no less than 30 days subsequent to written notice, unless sooner implementation is required by law, such amendments shall have the effect of qualifying the terms of this Agreement and shall be binding upon the parties as if written herein.

ARTICLE 15: TERMINATION PROCEDURES

The Contractor acknowledges that this Agreement may be terminated for Convenience or Default.

- A. Convenience
 - H-GAC may terminate this Agreement at any time, in whole or in part, with or without cause, whenever H-GAC determines that for any reason such termination is in the best interest of H-GAC, by providing written notice by certified mail to the Contractor. Upon receipt of notice of termination, all services hereunder of the Contractor and its employees and subcontractors shall cease to the extent specified in the notice of termination.
 - The Contractor may cancel or terminate this Agreement upon submission of thirty (30) days written notice, presented to H-GAC via certified mail. The Contractor may not give notice of cancellation after it has received notice of default from H-GAC.
- B. Default

- H-GAC may, by written notice of default to the Contractor, terminate the whole or any part of the Agreement, in any one of the following circumstances:
- (1) If the Contractor fails to perform the services herein specified within the time specified herein or any extension thereof; or
- (2) If the Contractor fails to perform any of the other provisions of this Agreement for any reason whatsoever, or so fails to make progress or otherwise violates the Agreements that completion of services herein specified within the Agreement term is significantly endangered, and in either of these two instances does not cure such failure within a period often (10) days (or such longer period of time as may be authorized by H-GAC in writing) after receiving written notice by certified mail of default from H-GAC.

ARTICLE 16: SEVERABILITY

H-GAC and Contractor agree that should any provision of this Agreement be determined to be invalid or unenforceable, such determination shall not affect any other term of this Agreement, which shall continue in full force and effect.

ARTICLE 17: FORCE MAJEURE

To the extent that either party to this Agreement shall be wholly or partially prevented from the performance of any obligation of duty placed on such party by reason of or through strikes, stoppage of labor, riot, fire, flood, acts of war, insurrection, accident, order of any court, act of God, or specific cause reasonably beyond the party's control and not attributable to its neglect or nonfeasance, in such event, the time for the performance of such obligation or duty shall be suspended until such disability to perform is removed. Determination of force majeure shall rest solely with H-GAC.

ARTICLE 18: CONFLICT OF INTEREST

No officer, member or employee of the Contractor or subcontractor, no member of the governing body of the Contractor, and no other public officials of the Contractor who exercise any functions or responsibilities in the review or Contractor approval of this Agreement, shall participate in any decision relating to this Agreement which affects his or her personal interest, or shall have any personal or pecuniary interest, direct or indirect, in this Agreement.

ARTICLE 19: FEDERAL COMPLIANCE

Contractor agrees to comply with all federal statutes relating to nondiscrimination, labor standards, and environmental compliance. Additionally, for work to be performed under the Agreement or subcontract thereof, including procurement of materials or leases of equipment, Contractor shall notify each potential subcontractor or supplier of the Contractor's federal compliance obligations. These may include, but are not limited to: (a) Title VI of the Civil Rights Act of 1964 (P.L. 88-352) which prohibits discrimination on the basis of race, color or national origin; (b) Title IX of the Education Amendments of 1972, as amended (20 U.S.C. §§ 1681-1683, and 1685-1686), which prohibits discrimination on the basis of sex; (c) the Fair Labor Standards Act of 1938 (29 USC 676 et. seq.), (d) Section 504 of the Rehabilitation Act of 1973, as amended (29 U.S.C. § 794), which prohibits discrimination on the basis of handicaps and the Americans with Disabilities Act of 1990; (e) the Age Discrimination in Employment Act of 1967 (29 USC 621 et. seq.) and the Age Discrimination Act of 1974, as amended (42 U.S.C. §§ 6101-6107), which prohibits discrimination on the basis of age; (f) the Drug Abuse Office and Treatment Act of 1972 (P.L. 92-255), as amended, relating to nondiscrimination on the basis of drug abuse; (g) the Comprehensive Alcohol Abuse and Alcoholism Prevention, Treatment and Rehabilitation Act of 1970 (P.L. 91-616), as amended, relating to the nondiscrimination on the basis of alcohol abuse or alcoholism; (h) §§ 523 and 527 of the Public Health Service Act of 1912 (42 U.S.C. 290 dd-3 and 290 ee-3), as amended, relating to confidentiality of alcohol and drug abuse patient records; (i) Title VIII of the Civil Rights Act of 1968 (42 U.S.C. § 3601 et seq.), as amended, relating to nondiscrimination in the sale, rental or financing of housing; (j) any other nondiscrimination provisions in any specific statute(s)

applicable to any Federal funding for this Agreement; (k) the requirements of any other nondiscrimination statute(s) which may apply to this Agreement; (l) applicable provisions of the Clean Air Act (42 U.S.C. §7401 et seq.), the Federal Water Pollution Control Act, as amended (33 U.S.C. §1251 et seq.), Section 508 of the Clean Water Act (33 U.S.C. 1368), Executive Order 11738, and the Environmental Protection Agency regulations at 40 CPR Part 15; (m) applicable provisions of the Davis- Bacon Act (40 U.S.C. 276a - 276a-7), the Copeland Act (40 U.S.C. 276c), and the Contract Work Hours and Safety Standards Act (40 U.S.C. 327-332), as set forth in Department of Labor Regulations at 20 CPR 5.5a; (n) the mandatory standards and policies relating to energy efficiency which are contained in the state energy conservation plan issued in compliance with the Energy Policy and Conservation Act (P.L. 94-163).

ARTICLE 20; CRIMINAL PROVISIONS AND SANCTIONS

The Contractor agrees to perform the Agreement in conformance with safeguards against fraud and abuse as set forth by the H-GAC, the State of Texas, and the acts and regulations of any related state or federal agency. The Contractor agrees to promptly notify H-GAC of any actual or suspected fraud, abuse, or other criminal activity through the filing of a written report within twenty-four (24) hours of knowledge thereof. Contractor shall notify H-GAC of any accident or incident requiring medical attention arising from its activities under this Agreement within twenty-four (24) hours of such occurrence. Theft or willful damage to property on loan to the Contractor from H-GAC, if any, shall be reported to local law enforcement agencies and H-GAC within two (2) hours of discovery of any such act.

The Contractor further agrees to cooperate fully with H-GAC, local law enforcement agencies, the State of Texas, the Federal Bureau of Investigation and any other duly authorized investigative unit, in carrying out a full investigation of all such incidents.

The Contractor shall notify H-GAC of the threat of lawsuit or of any actual suit filed against the Contractor pertaining to this Agreement or which would adversely affect the Contractor's ability to perform services under this Agreement.

ARTICLE 21: INDEMNIFICATION AND RECOVERY

H-GAC's liability under this Agreement, whether for breach of contract, warranty, negligence, strict liability, in tort or otherwise, is limited to its order processing charge. In no event will H-GAC be liable for any loss of use, loss of time, inconvenience, commercial loss, lost profits or savings or other incidental, special or consequential damages to the full extent such use may be disclaimed by law. Contractor agrees, to the extent permitted by law, to defend and hold harmless H-GAC, its board members, officers, agents, officials, employees and indemnities from any and all claims, costs, expenses (including reasonable attorney fees), actions, causes of action, judgements, and liens arising as a result of Contractor's negligent act or omission under this Agreement. Contractor shall notify H-GAC of the threat of lawsuit or of any actual suit filed against Contractor relating to this Agreement.

ARTICLE 22: LIMITATION OF CONTRACTOR'S LIABILITY

Except as specified in any separate writing between the Contractor and an END USER, Contractor's total liability under this Agreement, whether for breach of contract, warranty, negligence, strict liability, in tort or otherwise, but excluding its obligation to indemnify H-GAC, is limited to the price of the particular products/services sold hereunder, and Contractor agrees either to refund the purchase price or to repair or replace product(s) that are not as warranted. In no event will Contractor be liable for any loss of use, loss of time, inconvenience, commercial loss, loss of profits or savings or other incidental, special or consequential damages to the full extent such use may be disclaimed by law. Contractor understands and agrees that it shall be liable to repay and shall repay upon demand to

END USER any amounts determined by H-GAC, its independent auditors, or any agency of State or Federal government to have been paid in violation of the terms of this Agreement.

ARTICLE 23: TITLES NOT RESTRICTIVE

The titles assigned to the various Articles of this Agreement are for convenience only. Titles shall not be considered restrictive of the subject matter of any Article, or part of this Agreement.

ARTICLE 24: JOINT WORK PRODUCT

This Agreement is the joint work product of H-GAC and the Contractor. This Agreement has been negotiated by H-GAC and the Contractor and their respective counsel and shall be fairly interpreted in accordance with its terms and, in the event of any ambiguities, no inferences shall be drawn against any party.

ARTICLE 25: DISPUTES

All disputes concerning questions of fact or of law arising under this Agreement, which are not addressed within the Whole Agreement as defined pursuant to Article 4 hereof, shall be decided by the Executive Director of H-GAC or his designee, who shall reduce his decision to writing and provide notice thereof to the Contractor. The decision of the Executive Director or his designee shall be final and conclusive unless, within thirty (30) days from the date of receipt of such notice, the Contractor requests a rehearing from the Executive Director of H-GAC. In connection with any rehearing under this Article, the Contractor shall be afforded an opportunity to be heard and offer evidence in support of its position. The decision of the Executive Director after any such rehearing shall be final and conclusive. The Contractor may, if it elects to do so, appeal the final and conclusive decision of the Executive Director to a court of competent jurisdiction. Pending final decision of a dispute hereunder, the Contractor shall proceed diligently with the performance of the Agreement and in accordance with H-GAC's final decision.

ARTICLE 26: CHOICE OF LAW: VENUE

This Agreement shall be governed by the laws of the State of Texas. Venue and jurisdiction of any suit or cause of action arising under or in connection with the Agreement shall lie exclusively in Harris County, Texas. Disputes between END USER and Contractor are to be resolved in accordance with the law and venue rules of the state of purchase. Contractor shall immediately notify H-GAC of such disputes.

ARTICLE 27: ORDER OF PRIORITY

In the case of any conflict between or within this Agreement, the following order of priority shall be utilized: 1) General Provisions, 2) Special Provisions, 3) Scope of Work, and, 4) Other Attachments.

A RESOLUTION PROVIDING AUTHORITY FOR SUBMISSION OF AN APPLICATION BY THE CITY OF SEDALIA FOR A MODOT TRANSPORTATION ENGINEERING ASSISTANCE PROGRAM (TEAP) GRANT.

WHEREAS, the Missouri Department of Transportation (MODOT) notified Local Public Agencies (LPAs), such as the City of Sedalia, of grant funding availability through the Transportation Engineering Assistance Program to assist those LPAs with safety and operational projects that the community would not otherwise be able to complete; and

WHEREAS, the City of Sedalia has identified Engineer Ave. from Reine Road to its intersection with E. 7th St. as an area of concern where traffic flow has increased significantly and congestion occurs near Washington Elementary School; and

WHEREAS, streets are the public realm and should be designed to a higher standard as beautiful, safe and comfortable places for all people including pedestrians, bicyclists, those who use wheelchairs and mobility devices, transit riders, shared ride services, micro-mobility users, motorists and freight delivery services, in order to equitably support the common good; and

WHEREAS, the City of Sedalia recently completed its Comprehensive Plan including Complete Streets, with a major focus on safety for all road users, easy access to employment and activity centers for people with limited mobility or access to a car, the inclusion of sidewalks and bicycle paths in capital road improvement projects and new development, and ensuring that the environmental impact of the City's transportation system is minimized; and

WHEREAS, planning and analysis of this area may enable use of simple design solutions, such as road diets, traffic calming elements, bicycle lanes and signage modifications which have proven to assist in reducing traffic speeds and serious crashes and other alternatives for improving safe operating conditions.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SEDALIA:

Section 1. That the Mayor and Council authorize the Sedalia Public Works Department to act as the agent for the City of Sedalia, Missouri in the application process with the Missouri Department of Transportation for TEAP grant funding of \$12,000 and to provide local match of \$8,000 to complete the needed operational and safety analysis of Engineer Ave. from E. 7th St. to Reine Road.

Section 2. That Brenda Ardrey, Director of Public Works, is hereby authorized and directed to furnish such information as MoDOT may reasonably request in connection with the application which is herein authorized and to furnish such assurances as may be required by law or regulation.

Section 3. That upon execution of a grant agreement with MoDOT, the Public Works Department shall utilize a MoDOT approved TEAP consultant from the LPA On-Call Consultant List to perform the traffic analysis as required by the grant terms.

Section 4. If awarded a TEAP grant by MoDOT, the City of Sedalia shall complete the analysis by Spring 2023.

Subject: Resolution allowing for submission -- MODOT Traffic Engineering Assistance Program (TEAP)

Operational Analysis – Engineer Ave. from North City Limits (Reine Road to E. 7th St.)

This is a request for authorization to submit an application to the Missouri Department of Transportation (MoDOT) for grant funds from their Traffic Engineering Assistance Program (TEAP). The grant application including a number of associated documents is required to be completed and submitted to MoDOT by September 23, 2022 to MoDOT's Local Public Agency Contact (Kansas City Region).

As background, MoDOT's TEAP provides funding to allow LPAs to receive engineering assistance for studying traffic engineering problems. LPAs facing a traffic safety or operational problem must utilize approved TEAP consultants from the LPA On-Call Consultant List to perform the traffic study.

Engineer Ave. between E. 7th St. and E. 3rd St. is of particular concern due to heavy traffic flow and congestion around Washington Elementary School. Engineer Ave. north from 3rd St. to its point of beginning at Reine Road has been under discussion with Pettis County as a result of their project to improve Cedar Drive from Reine Road north and connect to a new "Route H" overpass roadway which is likely to increase truck traffic along this section of Engineer Ave. also. In recent years, there has been a significant increase in traffic along this route including heavy truck and commercial traffic. This study is intended to provide recommendations for site-specific improvements, such as projects intended to increase traffic safety along the roadway, such as speed limit changes; traffic control devices, such as installation of new, or replacement of obsolete, traffic control devices, such as signs or street lighting, etc.; and potential re-routing to better use underutilized capacity in the form of parallel roadways.

This grant requires local match including local funds and in-kind available to the City. MoDOT will provide 80% funding up to \$12,000 for a project and the City will be required to match the funds provided with at least 20% local funding (\$3,000). This analysis is estimated to cost a total of \$20,000. The City will provide a total of \$8,000 in matching funds for the project.

RECITALS:

1. Whereas, Owners represent that they are the owners of the following real estate (hereinafter referred as "Property") located in Pettis County, Missouri:

See attached "Exhibit A" as legal description of property and "Exhibit B" for location of property.

- 2. Whereas, Owners desire to connect Owners' property to the City's water and sanitary sewer systems for purposes of developing Owners' property; and
- 3. Whereas, City desires to permit Owners to connect to the City's water and sanitary sewer systems for purposes of developing Owners' property; and
- 4. Whereas, City desires the right to annex Owners' property if Owners' property becomes contiguous to City's corporate city limits; and

NOW, THEREFORE, for and in consideration of the above-recitals as well as the terms and conditions hereafter, the parties hereby agree as follows:

- 1. Owners, in exchange for the City's agreement to allow Owners to connect their property to the City's water and sanitary sewer systems, the Owners, on behalf of them's elves, their successors, heirs and assigns, hereby convey unto the City the irrevocable and perpetual right to file on their behalf a Petition of Annexation at any time after annexation becomes possible.
- 2. City shall allow Owners to connect water and sanitary sewer lines serving Owners' property to the City's water and sanitary sewer systems, and Owners shall make connection at their expense. Prior to approving the physical connection, Owners shall obtain all necessary easements, if needed, from any other landowners and provide recorded copies to the City, obtain permits for the connection and pay all fees required to connect to the City's water and sanitary sewer systems. City shall provide and install water meter and box for connection of Owners' water service line. Owners shall be responsible for connecting the Owners' water service line from the house to the meter. Owners shall become a utility customer of the City and shall pay all fees and charges established by the City for water and sanitary sewer services.
- 3. The Owners shall ensure the sanitary sewer line serving Owners' property is constructed in

compliance with City regulations and standards. Construction of the sanitary sewer line shall be inspected by the City as though the property were within the City limits and shall be subject to City approval. Owners agree to bring the new sewer line to the City's existing sewer line and make connection. Owners shall not be charged for sewer services until the activation of service with City of Sedalia.

- 4. Owners agree to the "out of city limits" fee/cost schedule for services until such time as the Owners' property is annexed into the City of Sedalia.
- 5. Sanitary sewer lines serving property other than the Owners' property shall not be connected to the line serving the Owners' property without the City's written consent.
- 6. To the extent allowed by law, the City may annex Owners' property into the City, without further action of the Owners, after Owners' property becomes contiguous to the corporate limits of the City.
- Owners irrevocably appoint the City Administrator of Sedalia, Missouri, as its attorney-in-fact for the sole purpose of presenting a verified petition requesting annexation of Owners' property to the City Council of Sedalia, Missouri, IF AND WHEN the property becomes contiguous and compact to the city limits of the City of Sedalia, Missouri. The City Administrator may exercise this power of attorney at any time after Owners' property becomes contiguous to the corporate limits of the City. Owners on their behalf, and on behalf of their heirs, successors and assigns do hereby waive any notice of the filing of the petition, do hereby consent to the granting of the petition, and do hereby waive any objections, statutory or otherwise, to the annexation of the property into the City of Sedalia. Owners do hereby authorize the City to take whatever action necessary to complete the annexation of this property. Owners' consent to such future annexation of the Property is irrevocable.
- 8. The parties hereto agree that this Agreement shall be recorded, in the real estate records of the Office of the Recorder of Deeds of Pettis County, Missouri, and that the obligations and conditions of this Agreement shall run with the Property and shall be binding upon all future owners and users of the Property. Owners, on their own behalf and on behalf of all such future owners of the Property hereby agree that each purchaser, assignee or transferee of an interest in the Property, or any portion thereof, will be obligated and bound by the terms of this Agreement. Owners, on their own behalf and on behalf of all future owners of the Property, acknowledge that they and/or future owners of the Property shall be responsible for payment of all properly billed fees for water and sewage treatment services as established by the City of Sedalia. Owners' liability contained in this paragraph 8 shall terminate when Owners have transferred their ownership interest in Owners' property to a successor owner, at which time, the successor owner shall be responsible for payment of all properly billed fees for water and sewage treatment services as established by the City of Sedalia.
- 9. Alternatively, if requested by the City Administrator, Owners, their successors, assigns and heirs shall, within such time as specified by the City Administrator, submit a verified petition requesting annexation of the Owners' property to the City Clerk for presentation to the City Council of Sedalia, Missouri. The City Administrator may request Owners to present an annexation petition at any time after Owners' property becomes contiguous to the corporate limits of the City. The provisions of this paragraph shall be enforceable by specific performance.
- 10. Owners shall give a copy of this Agreement to the person or persons who buy the Owners' property.

- 11. If Owners fail to comply with any of the provisions of this Agreement, or repudiate the terms of this Agreement, City may terminate water and sanitary sewer services to Owners' property and disconnect the utility lines serving Owners' property from the City's water and sanitary sewer systems. City shall give Owners six months prior written notice of its intent to terminate services.
- 12. This Agreement is not intended to confer any rights or remedies on any person other than the parties.
- 13. The benefits and burdens of this Agreement are intended to attach to and run with the land and shall be binding on and inure to the benefit of the parties and their respective legal representatives, successors, heirs and assigns. All persons claiming under the parties shall conform to and observe the provisions of this Agreement.
- 14. This Agreement shall be recorded in the office of the Pettis County Recorder of Deeds at the City's expense.



TRIM Grant Application

This is a request for authorization to submit an application to the Missouri Department of Conservation for a Tree Resource Improvement and Maintenance (TRIM) grant to assess and re-inventory 1,500 public trees within the City's rights-of-way and public spaces, such as parks. The attached map shows the area to be re-inventoried this year. The area selected is based upon the number of trees that could be completed from funds available under the TRIM grant and quoted by vendors that conduct such inventories. If need be due to availability of grant funds, the arterial streets will be either increased/decreased to stay within the grant amount requested from the Missouri Department of Conservation of \$10,000.

In the last 3 years, the City has removed nearly 250 trees from public spaces. As part of this year's grant, we are requesting funds to obtain some trees to begin the replacement process and to provide trees for the planned George R. Smith College Memorial. Additionally, last year's inventory also included a special report on ash trees impacted by the emerald ash borer. It was determined that many ash trees within public spaces have died and replacement would be appropriate for some of these trees.



AN ORDINANCE AMENDING SECTION 64-124 (4) OF THE CODE OF ORDINANCES OF THE CITY OF SEDALIA, MISSOURI REGARDING SPECIAL USE PERMITS FOR CEMETERIES, MAUSOLEUMS OR CREMATORIES FOR PROCESSING OF ANIMAL REMAINS.
NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF SEDALIA, MISSOURI, AS FOLLOWS:
Section 1. The Sedalia Police Department has solicited bids for four Dodge Durangos to be used as police vehicles and one Dodge Durango to be used by the fire department. Over the past year supply chain issues and the aftermath of the COVID-19 pandemic have continued to limit the Police Department's ability to find and purchase police vehicles. Ford and Chrysler limited their production of the 2022 model year and we were not able to purchase vehicles. To improve delivery time and to obtain vehicles in 2023 we have developed a plan to order the vehicles early in the production year (September 2022). Bids were solicited during the month of August and we received one bid from WK Chrysler Jeep Ram of Sedalia. The bid was \$41,899 per police vehicle for a total of \$167,596 and \$42,270 for the fire vehicle.

I recommend we accept the bid for the purchase of four Dodge Durangos from WK Chrysler Jeep Ram of Sedalia in the amount of \$167,596 for the police vehicles and one Dodge Durango for fire in the amount \$42,270.00.

The police department did not budget for this additional purchase since supply chain issues were expected to improve in 2022. As a result, I would like to request a budget amendment and/or to encumber \$167,596.00 for the police vehicles in account 10-63-351-10. SFD budgeted the purchase of the fire SUV for FY23.

Ref: Acceptance of repair/budget amendment radio system

In July Commenco discovered that the police/fire radio receiver at Skyline Elementary was not working. Commenco examined the system and found that the fixed radio link (link) had been damaged by lightning causing the police/fire radio receiver to not function. The link is a device that takes the radio signal from the radio receiver and sends it to the West Water tower, feeding it into the SPD/SFD radio system. There is also another link at the west water tower to receive the signal. Commenco determined that the link was not repairable and must be replaced. In addition, due to the age of the link a replacement at both Skyline Elementary and the west water tower would be needed to maintain compatibility. Even though Commenco takes every precaution to minimize the possibility of lightning damage to tower mounted equipment, damage can still occur in extreme cases. Commenco has provided an estimate to make the repairs to Skyline Elementary to include all the necessary hardware and cable to repair the lightening damage. In the estimate is also the cost to replace the link at the west water tower to maintain compatibility for the system. The total cost estimate is \$13,974.55. The estimated amount is under the cost of the City's insurance deductible, consequently, we will be responsible for cost to make the repair.

In addition, Commenco is our current radio equipment provider, radio system provider, and the vendor that built the SPD/SFD radio system. Chief Irwin and I recommend accepting the radio repair estimate. SPD did not budget for a repair of this size and will need a budget amendment. I request a budget amendment in the amount of \$13,974.55 for SPD account 10-13-223-00 Radio Repairs.

Sedalia Police Department has encountered several large vehicle repairs this year that have impacted the budget to the point of depletion.

Below is a list of the substantial repair cost and short description of the issue:

Repair cost: \$4,346.00 A Suspect intentionally rammed a police car causing damage to the entire front of the vehicle. Insurance Paid: \$3,346.50

Repair Cost: \$4,576.00 An uninsured motorist struck the side of a legally parked and unoccupied police car. Insurance Paid: \$3,576.60

Repair cost: \$6,316.49 An officer struck a light pole in a parking lot while leaving the lot to stop a vehicle. Insurance paid: \$5,316.49

Repair cost: \$1,800.00 A pending repair of damage when an officer struck a sign pole turning around to go on a disturbance call. Insurance paid: \$806.05

Repair Cost: \$3,200.00 Pending engine repair on a vehicle that the valve train has failed, needing replacement. No insurance or warranty coverage.

The total cost of repairs was/is \$20,238.49 with a total insurance amount paid of \$13,045.64
