Liquor License Requirements:

- Application
- No Tax Due Statement from Missouri Department of Revenue (no more than 90 days old)
- Paid real property and personal property tax receipts for Pettis County
- Copy of State of Missouri Liquor License
- Appropriate Fee (Requires background check by Police Department and approval of City Council)

The No Tax Due Statement may be obtained online at <u>https://dor.mo.gov/business/sales/notaxdue/</u> or by calling the Missouri Department of Revenue at (573) 751-9268.

*Please note that if your license for the prior year was not renewed we are requried to collect a penalty (see City Code 12-28 which can be reviewed at <u>https://library.municode.com/mo/sedalia/codes/code_of_ordinances?nodeId=CD_ORD_CH12BURETA_ARTIIOCLITA_DIV1GE_S12-28WHLIDEPEDE</u>).
