How To Detect An Illicit Discharge



An *Illicit Discharge* is any discharge that enters a storm drain that isn't entirely composed of stormwater.

Don't throw trash, where I splash!

Keep my home clean by reporting what you see!

- Fluids from leaking vehicles
- Grass clippings
- Pet Waste
- Litter
- Hazardous Waste
- Paint
- Soil
- Sediment
- Concrete Washout
- Industrial Waste

Be prepared to give the address and details about what you saw.

Stormwater Quick Facts-

- Stormwater runoff isn't treated before it reaches our community waterways and streams.
- Runoff becomes polluted as it runs along roads, parking lots, roofs and lawns.
- You don't need a heavy rain storm to send pollutants towards our streams. A garden hose alone can supply enough water.
- Clogged storm drains from yard debris and trash can lead to flooding in our city streets.
- You can stop the fast flow of stormwater on your property by installing a rain garden or barrel, use gravel or pavers in place of concrete and asphalt and direct your home downspouts onto the grass not your driveway.

The City has six minimum control measures (MCM) in place for stormwater management. These include:

- Public Education and Outreach
- Public Participation and Involvement
- Illicit Discharge Detection and Elimination
 - Construction Site Runoff Control
 - Post Construction Runoff Control
- Pollution Prevention and Good Housekeeping
