Re: Agenda items for City Council meeting on Monday, May 1, 2023, 6:30 p.m.

<u>Public Hearing State Fair Property Annexation</u> — A petition was received from the State, as owners of the property they purchased for the expansion of the Fairgrounds, for a voluntary annexation of this additional land. In accordance with State Statutes, we must hold a public hearing between 14 and 60 days of receiving such a petition. The hearing is to hear from any interested parties on the appropriateness of the annexation. We must then wait at least 14 days after the hearing to consider adoption of an ordinance to effect the annexation.

<u>Public Hearing E.W. Thompson Property Annexation</u> – A petition was received from the owners of the property for a voluntary annexation of land along 10th Street just West of Winchester. This lot is part of the area the E.W. Thompson group has been developing over the last several years, and has been their practice to request annexation as each lot develops. In accordance with State Statutes, we must hold a public hearing between 14 and 60 days of receiving such a petition. The hearing is to hear from any interested parties on the appropriateness of the annexation. We must then wait at least 14 days after the hearing to consider adoption of an ordinance to effect the annexation.

<u>Finance/Administration Committee</u> – There are no items for consideration through the Finance / Administration Committee.

<u>Public Works Committee</u> – There are four items for consideration through the Public Works Committee.

- 1. As discussed during the budgeting process, adding a day cab tractor with a low boy trailer will add significant efficiencies to the Street Department. This tractor and trailer would transport between job sites the paving equipment added last fiscal year much quicker, and thereby less costly. Likewise, other equipment such as the excavator would be able to be moved more efficiently than the current method of driving the equipment at low speeds. Further, having the tractor will allow for the use of an end-dump trailer for hauling much larger loads of construction materials. Included in the adopted budget is \$295,000 for the truck, low boy, and end-dump trailers. This estimate was based upon a new truck. However, staff recommends that a used truck is more prudent for our current needs. A used freightliner with about 400,000 miles has been located in the area. Staff drove the truck, found it to be in good shape, and negotiated a price of \$27,000. This price was compared to other advertised similar units and appears to be a fair value. Staff recommends approval of the purchase.
- 2. During the sidewalk replacement project in the area of Kentucky and Main Street, two unanticipated voids under the old structure were encountered. Staff recommends approval of a change order to cover the costs of filling these voids of \$8,198.13.
- 3. Staff proposed, during the budgeting process, to purchase a used crew cab pickup to replace a truck used in the Cemetery operations that is down and beyond feasible repair. In the

adopted budget \$35,000 was allocated to this project. Chief Wirt reached out to the contacts he has developed through Missouri Surplus Property and located a suitable unit for \$30,000. Staff recommends approval of the purchase.

4. The Water Department currently participates in a program through our electricity provider to obtain a discounted rate in exchange for agreeing to switch over to generator power in peak demand situations. Staff recommends approval of the renewal of this agreement.

<u>Public Safety Committee</u> – There are four items for consideration through the Public Safety Committee.

- 1. Chief Irwin presented in the strategic plan for the Fire Department, moving to a lower pressure hose and nozzle attack package. This system makes handling the hoses much more manageable for our personnel, as well as, creating less wear on the pumps in the engines. This project was ranked sixth out of seventeen in the scoring process of the strategic planning meeting, and \$50,000 was included in the adopted budget. Staff sent out a request for proposals (RFP) to solicit bids, and obtained four bids. Two bids were deemed unresponsive to the requirements of the RFP. Of the two responsive bids, Feld Fire Equipment was the low bid at \$49,126.00 and staff recommends approval.
- 2. The City has had a long-standing agreement with Whiteman Airforce Base to provide mutual aid. Staff recommends approval of an update and renewal of this agreement reflecting the current Mayor and Chief.
- 3. The Fire Department has been successful in obtaining grants through the Regional Homeland Security Oversight Committees (RHSOC) program over the years. Staff is seeking authorization to apply for another grant to fund the purchase of additional dual band radios capable of communicating with other agencies in the event of emergencies.
- 4. Chief Wirt has presented in the Police Department strategic plan a project to add a portable command and control trailer. This trailer will act as a staging area in situations where command and control coordination activities are necessary on the scene of an emergency. Last year a truck capable of pulling such a trailer was purchased that is used as a response vehicle assigned to the Chief. Staff recommends utilizing asset forfeiture funds available to purchase this unit. Asset forfeiture funds are from property that was previously seized due to it being used in illegal activities that the Police assisted in bringing the perpetrators to justice. These funds are restricted and can only be used for law enforcement to further its efforts in eliminating crime. Stated in a simplistic way, drug dealers are helping us fund equipment to stop more of them. Staff recommends approval of a budget amendment to designate the use of these funds for this purpose.

<u>Community Development Committee</u> – There are two items for consideration through the Community Development Committee.

- Rather than adopting an ordinance each year to suspend the open container laws during the Scott Joplin Festival, a specific section was added to the code dealing with this annual event. With the development of the pavilion and other changes, staff recommends updates to this code section to reflect the current areas the festival activities take place.
- 2. The contract for the sale of the property surrounding Springfork Lake, expired and is now null and void. A provision of that contract that Council maintained was of the upmost importance

was maintaining public access to the lake. On the other hand, a major reason for even considering the agreement was that the ongoing costs to maintain the dam and lake are no longer appropriate charges against the Water Department Enterprise Fund offset by water usage fees. With that understanding, staff recommends soliciting public input to your deliberations over what should be done longer term with this asset and what are the proper funding sources for the maintenance that matches up with the level of public good derived from the asset.

Presentation: Ukrainian Festival Event

Ukrainian Festival organizers from The Sedalia Tabernacle presented an update on the 2022 Ukrainian Festival. \$26,500 was raised for the Citizens of Ukraine and the church donated \$60,000 to help Ukrainian refugees with housing, clothing and food until they are able to obtain government assistance.

At this year's festival, a map will be displayed showing where funds helped provide food, clothing, and other necessities to those in need. Organizers presented 2 videos, the first highlighted events from the 2022 festival and the second included Ukrainian citizens expressing appreciation for donations, their current conditions and how volunteers are helping.

The 2023 Ukrainian Festival will be held April 29, 2023 at the Downtown Pavilion from 11:00 a.m. – 5:00 p.m. and proceeds will go towards humanitarian aid in Ukraine.

Presentation: Self-Funding Health Insurance

Terri Etter, with IMA Financial Group, presented a 3 year plan for the City of Sedalia to establish a self-funding medical plan. The first year, the City would move into a bundled partially self-insured plan with Blue Cross Blue Shield of Kansas City. This allows members to have the same network providers and keep all products bundled and the City will have plan discretion based off what works best for employees. This will also allow money paid towards premiums not being used, to be held in a reserve that goes back to the City.

The first year of the plan, claims will be significantly lower and still paid for through the fully insured plan. Claims typically have a 1-2 month lag time and a majority of "run-out claims" will be paid in the first 3 months. The carrier will still be responsible for payment of all claims incurred in 2023 and paid in 2024. Premiums for 2023 are estimated at \$1,671,708.00 and 2024 is estimated at \$1,764,698.00. In 2024, estimated self-funded funds is \$1,842,362, immature projected cost is \$1,682,034, mature cost is \$2,027,183 and estimated reserve amount is \$160,328.00. City Administrator Kelvin Shaw added that plans are more flexible and the health and wellness of employees lowers costs as well. A recommendation for Council consideration will be brought to the October 2, 2023 Council Meeting.

Financial Update: Finance Director Jessica Pyle stated for March 2023, Sales and Use Tax increased \$1.1 Million or 6.8% with a budget variance of \$470,835 for the past 12 months. Franchise Tax increased \$176,518 primarily due to Gas Tax. Transportation Tax increased 19% due to Gas Tax and vehicle sales were up 1.9% fiscal year-to-date. Over the last several years supply chain issues and the aftermath of the COVID-19 pandemic have continued to limit the City's ability to find and purchase vehicles, specifically pickup trucks. Manufactures have limited their production and the City has experienced issues where trucks that have been ordered but, later cancelled because the manufacture could not fill the order. These issues have continued to limit the City's ability to purchase trucks and has pushed the cost to much higher levels. The Cemetery is in need a reliable pickup truck for everyday needs and to move crews from one location to another.

To fill the need at the Cemetery I have located one 2019 F150 Responder 4x4 VIN 1FTEW1P40KKD30621 available for purchase at the Missouri State Highway Patrol (MSHP). The truck served as a police vehicle but MSHP has maintained it with regular maintenance and care. The truck is equipped with 4 doors, approximately 77,000 miles, class III receiver hitch, new brakes and tires, and a bed cover. MSHP has provided the entire vehicle maintenance history indicating the truck has been methodically maintained. Purchasing used trucks with some mileage can be a challenge but, in this situation, it is a clear solution to fill this need. By purchasing the truck, the city can continue operations and make quality replacements.

The purchase of the MSHP truck meets City purchasing policy under the Cooperative Procurement Program as this is a form of State Surplus and "similar programs that meet the spirit and intent of these procedures in their process." I recommend the City purchase the 2019 Ford F150 Responder 4x4 for a total of \$30,000.

Section C - Participant Incentive "Pay for Performance"

The Company will use a calculated baseline load (CBL) methodology to determine Participant's kW savings associated with a demand response curtailment event. A CBL approach applies a computer model to develop a site-specific baseline for each day by using historic metered usage data. This baseline is calibrated to best match recent operational and/or weather patterns. Then, the baseline is used to forecast facility demand usage for each hour of the event day absent a curtailment event. The CBL is then compared to the actual measured average hourly demand (kW) during the curtailment event. The difference between the forecasted hourly baseline and the actual measured hourly usage during the event equals the hourly impact kW achieved during the event. All kW is calculated as a whole number. The Seasonal hourly average kW achieved divided by the kW enrolled is the Participant's % achieved. The Company pays the Participant or Aggregator for their achieved Seasonal average percent of their enrolled Curtailable load within the established floor and cap as detailed below or as set forth in the agreement with the Aggregator. Participant feedback throughout the season as well as End of Season feedback is required for proper program participation. Failure to participate in season communication and/or End of Season meeting(s) can delay incentive payment.

- Participant may earn up to 110% for over-achievement of their enrolled Curtailable Load.

Section E - Terms and Conditions

Purpose:

The Company is offering the Business Demand Response program as a voluntary program within the Missouri Energy Efficiency Investment Act (MEEIA) to reduce Participant load during peak periods to improve local and/or regional system reliability, offset forecasted system peaks that could result in future generation capacity additions, and/or provide a more economical option to generation or purchasing energy in the wholesale market. Participant curtailment may be requested for any of these operational or economic reasons as determined by the Company.

Business Demand Response Tariff:

The Company has filed with the Public Service Commission of the State of Missouri (Commission) the Business Demand Response tariff stating the general rules and regulations of the BDR Program. The approved tariff provides the general rules and regulations of the Program. However, by signing this Participation Agreement, the Participant also agrees to the Program requirements as detailed in this agreement and/or any future addenda.

Availability:

The BDR program is available during the MEEIA Cycle 3 to Evergy Missouri West and Evergy Missouri Metro commercial and industrial rate class customers. To become a BDR Participant, a customer must demonstrate to the Company economic and technical feasibility for measurable and verifiable load curtailment at their enrolled facility. The Participant may enroll in the Program either directly through the Company's Program Administrator or through a Company approved Aggregator under an independent third-party contract with the Aggregator. If a customer chooses to participate in BDR via an Aggregator, they will contract directly with and be paid by the Aggregator per the terms of their contract with Aggregator.

Curtailment Season:

The Participant will curtail their annual enrolled Curtailable Load (Table 2, Section A) by executing their Curtailment Plan (Section C) when notified by the Company the following times throughout the term of this Agreement.

Curtailment Season: June 1 - September 30

Designated Event Days: Monday - Friday; excluding holidays

Designated Event Window: 12:00 p.m. - 8:00 p.m.

Curtailment Events:

The Company will communicate with Participants in advance of a curtailment event to increase Participants ability to successfully participate. The Company and Participant agree to the following Curtailment Event criteria:

Maximum number of events per season – 15
Minimum number of events per season – 1
Minimum number test events per season – 1
Maximum duration of an event - 8 hours
Minimum notification prior to an event - 1 hour

The Company reserves the right to require one (1) system Test curtailment event each year to ensure Participant technical and operational capability of achieving their enrolled Curtailable Load reduction. If Participant does not participate in the scheduled Test Curtailment event, the Company reserves the right to suspend or terminate this Agreement. Test Curtailments do not count toward the minimum or maximum number of annual Curtailment Events and will not be included in calculation of average Seasonal performance.

The Company reserves the right to cancel a scheduled Curtailment Event prior to the start time of such Curtailment Event. However, if cancellation occurs less than two hours before the scheduled start time of a Curtailment Event, the canceled Curtailment Event will count toward the Seasonal maximum number of events.

Participant agrees to acknowledge receiving event notification(s) prior to designated Event start time via the preferred communications method(s) as listed in Section D. Additionally, Participant acknowledges that Program staff will contact Participant prior to and/or during Curtailment events to validate Company participation if Participant has not responded to Event notification(s).

The Company will provide a financial incentive to Participant on a "pay for performance" scale equal to Participant's hourly average realized Seasonal curtailment level as described in Section C of this Agreement.

Enrolled Facilities/Metering:

Participant affirms the Company provides electric service to the Participant's facility located at the address referenced in Section A of this Agreement and that any equipment necessary for BDR participation aside from electrical service equipment provided by the Company per applicable Customer Service Agreement(s) is the obligation of the Participant. The Participant agrees to make available site-specific technical staff for consultation and regular communication of the facility's curtailment capabilities throughout the duration of Agreement to ensure Participant's successful achievement of enrolled Curtailment Level in this Agreement.

Only for the purposes of participating in BDR, individual service points with Company installed meters at Participant facility will be aggregated and tracked by the Company to determine facility demand usage. If Participant requests to enroll multiple facilities under one Agreement, the facilities' aggregated Curtailable Load Agreement will be evaluated together for performance.

Additionally, if Participant wishes for any account data including their facility metering data to be shared with a third-party, Participant must provide a signed Letter of Authorization on their corporate letterhead to the Company stating name of the third-party being authorized, the information to be shared and dates of authorization.

Self-Generation:

Self-generation as a curtailment method is restricted to Participants validating compliance pursuant to Environmental Protection Agency ("EPA") regulations (summarized at www.epa.gov/ttn/atw/icengines/comply.html) that affect the use of reciprocating internal combustion engines. By executing this Agreement, the Participant certifies that it has reviewed the EPA regulations pertaining to its specific generating equipment and it hereby represents and warrants that any enrolled self-generation utilized in the BDR Program is in compliance with all of the currently applicable federal and/or local regulations. The Participant further acknowledges that the Company will not certify, maintain any records or report on behalf of the Participant's self-generation certifications, testing, or reporting of self-generation used as a curtailment method in BDR.

DERMS Database of Record:

All official Participant notifications, tracking, reconciliation and reporting for Curtailment Event performance and Participation Payments will be executed within the Evergy Distributed Energy Resource Management System (DERMS).

MEEIA Cycle 3 Business Demand Response Agreement V2.0 Participant will be granted access to an online customer portal, www.evergy.websmartview.oati.com, for greater visibility into their enrolled facilities' electrical load details such as near-real-time performance during Curtailment Events, post event performance data and Participant point of contact information. Participant shall indicate which contact(s) in Section D above are authorized to have portal access. Access to portal will remain active throughout the term of this Agreement. Participant is responsible for contacting Evergy to terminate portal access for any designated contact.

Marketing:

By executing this Agreement Participant agrees that Evergy may use the Customer's name, noted above, in promotional material, including but not limited to print advertising, for Evergy Business Demand Response programs. Evergy will not disclose actual incentive payment amounts made without Participant's written approval. Participant may opt out of this Marketing agreement by submitting a written request.

General Terms:

Participants in BDR will automatically be enrolled in the Voluntary Load Reduction ("VLR") Rider under which the Company reserves the right to request voluntary participation during Non-BDR event days. Additional details and compensation for such events are described in the VLR Tariff available at www.evergy.com.

The Participant acknowledges that this Agreement is not assignable by Participant without the written consent of Company. If Participant no longer owns or operates the facility identified in this Agreement, participant agrees to notify Company in writing and this Agreement will be terminated.

The Participant further acknowledges that all information provided to the Company for the purpose of determining whether the Participant is eligible for service under the Tariff shall be retained by the Company, and shall be subject to inspection and disclosure under Chapters 386 and 393, RSMo, as amended from time to time. Should the Participant designate any such information as proprietary or confidential, Company shall notify Participant of any request for inspection or disclosure and shall use good faith efforts to secure an agreement or Commission order protecting the proprietary or confidential nature of such information.

This Agreement shall be governed in all respects by the laws of the State of Missouri, without regard to its conflict of law's provisions, and by the orders, rules and regulations of the Commission, as they may exist from time to time. Nothing contained herein shall be construed as divesting, or attempting to divest, the Commission of any rights, jurisdiction, power or authority vested in it by law.

Any regulation or law prohibiting the execution of this Agreement or its continuing execution will cancel the Agreement in place without penalty to either party.

This Agreement is subject to the Participant gaining the necessary permits, and to the Commission approval of MEEIA Cycle 3.

In the event of modifications to the Business Demand Response Tariff, the parties will meet and discuss such changes. This Agreement may be replaced by a new agreement or revised by Amendment. Amendment changes will take effect on the date of signature. Any events prior to Amendment signature will be incentivized at the original curtailment amount.

On 04/21/2023 we opened bids for the hose attack package for the Sedalia Fire Department: We received 4 bids from 4 companies. After opening the bids and review of those bids I am requesting that Feld Fire equipment be awarded the winning bidder.

Feld Fire was not the lowest bid received, the initial low bid was found to have numerous math errors and upon contact with the representative they would not be able to honor the quoted price nor where they able to give a fixed shipping cost rather an estimate of what they thought it would cost to ship the items. The next lowest bid did not bid the hose called out specifically in the bid document but rather chose a hose to quote that had a shorter warranty period and a 5 year warranty on delamination versus the life time warranty offered on the requested hose to quote.

Therefore I am recommending that Feld Fire be awarded the bid for the fire hose attack package as the lowest/best option. This bid still falls below the amount budgeted for these items.

Staff recommends this agreement be signed and extended.

AGREEMENT FOR MUTUAL AID IN FIRE EMERGENCY SERVICES

BETWEEN THE

CITY OF SEDALIA FIRE DEPARTMENT

AND

509TH BOMB WING, WHITEMAN AFB, FIRE DEPARTMENT

This Mutual Aid Agreement (the "Agreement") is made and entered into this _____ day of _____ 2023, between the Secretary of the Air Force (the "Air Force") acting by and through the Commander 509th Bomb Wing, Whiteman Air Force Base, Missouri pursuant to the authority of 42 U.S.C. § 1856a and the City of Sedalia Fire Department. Together the Air Force and the City of Sedalia Fire Department are hereinafter referred to as the "Parties".

WITNESSETH:

WHEREAS, each of the Parties hereto maintains equipment and personnel for the suppression of fires and the management of other emergency incidents occurring within areas under their respective jurisdictions; and

WHEREAS, as set forth in 42 U.S.C. § 1856 the term 'fire protection' includes personal services and equipment required for fire prevention, the protection of life and property from fire, firefighting, and emergency services, including basic medical support, basic and advanced life support, hazardous material containment and confinement, and special rescue incidents involving vehicular and water mishaps, and trench, building, and confined space extractions; and

WHEREAS, the Parties hereto desire to augment the fire protection capabilities available in their respective jurisdictions by entering into this Agreement.

NOW, THEREFORE, in consideration of the mutual covenants, obligations and agreements herein established, the Parties hereby agree as follows:

- a. The authority to enter into this Agreement is set forth in 42 U.S.C. § 1856a, and Title 15 United States Code Section 2210, the regulations implementing same at Title 44 Code of Federal Regulations Part 151 *Emergency Management and Assistance* and DAFI 32-2001, F&ES Program.
- b. This Agreement will serve as the agreement between the Parties for securing to each mutual aid in fire protection services as defined above.
- c. On request to a representative of the Whiteman Air Force Base fire department by a representative of the City of Sedalia Fire Department, fire protection equipment and personnel of the Whiteman Air Force Base fire department will be dispatched to any point within the area for which the City of Sedalia Fire Department normally provides fire protection services as designated by the representatives of the City of Sedalia Fire Department.
- d. On request to a representative of the City of Sedalia Fire Department by a representative of the Whiteman Air Force Base fire department, fire protection equipment and personnel of the City of Sedalia Fire Department will be dispatched to any point within the jurisdiction of the Whiteman Air

Force Base as designated by the representative of the Whiteman Air Force Base fire department.

- e. Any dispatch of equipment and personnel by the Parties pursuant to this Agreement is subject to the following conditions:
- (1) Any request for aid hereunder will include a statement of the amount and type of equipment and personnel requested and will specify the location to which the equipment and personnel are to be dispatched, but the amount and type of equipment and the number of personnel to be furnished will be determined by the responding organization. The requesting organization will ensure access to site for the responding organization.
- (2) The responding organization will report to the officer in charge of the requesting organization at the location to which the equipment is dispatched and will be subject to the orders of that official.
- (3) The responding organization will be released by the requesting organization when the services of the responding organization are no longer required or when the responding organization is needed within the area for which it normally provides fire protection.
- (4) Sharing of non-encrypted Radio Frequencies/INTEROPERABILITY capability between agencies specifically during Mutual Aids for accountability of personnel and assets, including sharing of valuable information between Incident Command and firefighters.
- (5). HAZMAT incident response will include the response to, and control and containment of any release or suspected release of any material suspected to be or known to be hazardous. Where the properties of a released material are not known, it will be considered hazardous until proven otherwise by the requesting organization using all technical resources available. Cleanup and removal of contained HAZMAT will be the responsibility of the requesting organization.
- (6) In the event of a crash of an aircraft owned or operated by the United States or military aircraft of any foreign nation within the area for which the City of Sedalia Fire Department normally provides fire protection services, the chief of the Whiteman Air Force Base fire department or his or her representative may assume full command on arrival at the scene of the crash.
- (7) Regardless of local agencies assigning an incident safety officer, an Air Force representative will be assigned to act as the incident safety officer for Whiteman Air Force Base fire department to observe Air Force support and operations at an incident. Local agencies are encouraged to assign a safety officer to observe the agencies support and operations at an incident on the installation.
- f. Each Party hereby agrees that its intent with respect to the rendering of assistance to the other Party under this Agreement is not to seek reimbursement from the Party requesting such assistance.
- (1) Notwithstanding the above, the Parties hereby recognize that pursuant to the Section 11 of the Federal Fire Prevention and Control Act of 1974 (15 U.S.C. § 2210) and Federal regulations issued there under (44 Code of Federal Regulations Part 151), the City of Sedalia Fire Department is permitted to seek reimbursement for all or any part of its direct expenses and losses (defined as additional firefighting costs over normal operational costs) incurred in fighting fires on property under the jurisdiction of the United States. Furthermore, under the authority of 42 U.S.C. § 1856a, and pursuant to any applicable state or local law each Party hereby reserves the right to seek reimbursement from the other for all or any part of the costs (defined as additional firefighting costs over normal operational costs) incurred by it in providing fire protection services to the other Party in response to a request for assistance.
- (2) Furthermore, to the extent permitted by law, the City of Sedalia Fire Department agrees to

indemnify and hold harmless the United States from any liability that may arise from the use of firefighting foams, chemicals, or other materials by the Air Force in providing fire protection services to the City of Sedalia Fire Department, which agreement to indemnify and hold harmless includes, but is not limited to, such uses that may result in hazardous substance exposure or pollution of or contamination to air, land, water, person or property or such uses that may result in response actions under CERCLA, RCRA, or any other federal, state, or local laws. Notwithstanding any other provision of this Agreement, termination of this Agreement shall in no way affect the City of Sedalia Fire Department's obligation under this paragraph to indemnify and hold harmless the United States from any liability that may arise from the use of firefighting foams, chemicals, or other materials by the Air Force in providing fire protection services to the City of Sedalia Fire Department, which obligation shall survive such termination.

- g. Both Parties agree to implement the National Incident Management System during all emergency responses on and off Installations IAW *National Fire Protection Association Standard 1561*.
- h. Each Party waives all claims against the other Party for compensation for any loss, damage, personal injury, or death occurring as a consequence of the performance of this Agreement. This provision does not waive any right of reimbursement pursuant to paragraph f.
- i. All equipment used by the City of Sedalia Fire Department in carrying out this Agreement will, at the time of action hereunder, be owned by it; and all personnel acting for the City of Sedalia Fire Department under this Agreement will, at the time of such action, be an employee or volunteer member of the City of Sedalia Fire Department.
- j. The rendering of assistance under the terms of this Agreement will not be mandatory; however, the Party receiving a request for assistance will endeavor to immediately inform the requesting Party if the requested assistance cannot be provided and, if assistance can be provided, the quantity of such resources as may be dispatched in response to such request.
- k. Neither Party will hold the other Party liable or at fault for failing to respond to any request for assistance or for failing to respond to such a request in a timely manner or with less than optimum equipment and/or personnel, it being the understanding of the Parties that each is primarily and ultimately responsible for the provision of fire protection services needed within their own jurisdictions.

1. Disputes.

Parties to Negotiate. If a dispute should arise, the Parties agree to first attempt to resolve the dispute using unassisted negotiation techniques (i.e., without the assistance of a neutral third party). Either Party may request in writing that unassisted negotiations commence. As part of the unassisted negotiation, the Parties shall consider employing joint fact-finding, if material factual disputes are involved, and shall use other early resolution techniques appropriate to the circumstances. If the dispute involves material issues of fact, the Parties may employ a neutral third party to provide a confidential evaluation of the issues of fact.

m. Alternative Dispute Resolution.

1. If the dispute is not resolved within sixty (60) days after the request for unassisted negotiations, and the Parties do not mutually agree to continue the unassisted negotiations, the Parties shall employ alternative dispute resolution procedures involving nonbinding mediation of the dispute by a neutral third party. The alternative dispute resolution procedures employed shall include a confidential evaluation of both the facts and the law and the issuance of confidential recommendations by the

neutral third party.

2. By entering into this Agreement, the Parties have voluntarily adopted alternative dispute resolution procedures IAW 5 United States Code. § 572(c). These procedures shall not be employed if determined by either Party to be inappropriate after taking into consideration the factors enumerated at 5 United States Code. § 572(b). A Party rejecting alternative dispute resolution as inappropriate shall document its reasons in writing and deliver them to the other Party. The Parties shall enter into a master written alternative dispute resolution Agreement governing alternative dispute resolution proceedings that may be amended as needed to fit individual proceedings. (A template of an acceptable alternative dispute resolution agreement may be found at (www.ada.af.mil).

The Government's obligation to make any payment arising out of an agreement resolving a dispute under this Agreement is contingent upon the availability of funds proper for such payment. The City of Sedalia Fire Department's obligation to make any payment arising out of an agreement resolving a dispute under this Agreement is contingent upon the availability of funds proper for such payment.

n. - p. Upon becoming effective, this Agreement will supersede and cancel all previous agreements between the Parties concerning the rendering of assistance from one to the other for the purposes stated in this Agreement.
- q. The modification or amendment of this Agreement, or any of the provisions of this Agreement, will not become effective unless executed in writing by both Parties.
- r. This Agreement may be executed in one or more counterparts, each of which will be deemed an original.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SEDALIA, MISSOURI, STATING FACTS AND REASONS FOR THE NECESSITY TO AMEND AND INCREASE THE CITY'S ANNUAL BUDGET FOR FISCAL YEAR 2024.

WHEREAS, Section 67.010 of the Revised Statutes of Missouri requires each political subdivision of the State of Missouri ("State") to prepare an annual budget and establishes the requirements for that budget; and

WHEREAS, the City of Sedalia, Missouri ("City"), is a city of the third classification created pursuant to Chapter 77, RSMo, and is a political subdivision of the State of Missouri; and

WHEREAS, the City Council of the City adopted and approved the City's annual budget for Fiscal Year 2023 in accordance with the requirements of Section 67.010, RSMo, by Ordinance No. 11535 on March 21, 2022, and

WHEREAS, Sections 67.030 and 67.040 authorize and provide a procedure for the City Council to amend the City's annual budget to increase expenditures in any fund; and

WHEREAS, expenses for City's operations for Fiscal Year 2024 have been higher than budgeted, but do not exceed revenues plus the City's unencumbered balance brought forward from previous years; and

WHEREAS, the City Council of the City desire to state the facts and reasons necessitating an amendment to increase certain expenditures in the Fiscal Year 2024 annual budget.



The Sedalia Police Department is in need of a command post trailer for special operations, large incidents, crime scenes, community events, and multijurisdictional trainings and disasters. The command post trailer will allow a workspace for officers and the incident command to work inside. The trailer can also provide a place for officers to stay warm during cold times of the year or cool off during the warm months. The trailer will be outfitted with office work space but also have the ability to haul cargo to an incident. SPD recently added a truck to our fleet that has the capability to pull the trailer. In addition, the company providing the trailer has improved their delivery dates and there is a slight possibility the trailer would arrive in time to be used for the upcoming Balloon Festival in June. After receiving quotes, per city purchasing policy, the best informal bid is for an Impact Shockwave trailer for \$24,999.

The trailer will also include a 4500 watt inverter generator for times when electricity is not available.

The police department did not originally budget for this additional purchase since supply chains had been none existent. However, the company increased production and as a result, I would like to request a budget amendment for \$24,999 to purchase the command post trailer from Trailer Trendz LLC of Eugene, MO.

The purchase revenue is available through Federal Asset Forfeiture funds allowing for no effect on the SPD or city budgets. The expense would be purchased through equipment expense account 10-63-351-00. Staff recommends this purchase.
