<u>Public Hearing For Proposed Tax Rates</u> - Every year we have to go through the calculations prescribed by the Hancock Amendment to determine the maximum allowed revenue from property taxes in order to set our levy amounts. This process starts with the County Assessor submitting the total assessed valuations for each taxing jurisdiction to the County Clerk the first part of July. The County Clerk then has to "certify" these values to us and to the State Auditor. A division of the State Auditor's office then prepares a "proforma" that makes the Hancock Amendment calculations that tell us what our maximum levies can be. We then have to publish a notice in the paper of what we intend to set these levies at and hold a public hearing before Council. After such hearing, Council can then set by ordinance the levy amounts. These amounts are then submitted back to the State Auditor through the County Clerk. This by law has to be completed by September 1 of each year or we cannot levy property taxes for that year. The State Auditor then reviews these and "certifies" to the county that these levies are allowable and they can use them for the billing of the property taxes to the taxpayers in November.

The Hancock Amendment calculations limit the amount of increased revenue any taxing jurisdiction can receive to the amounts associated with new territories, new construction, new voter approved levies, and the lesser of the rise in the Consumer Price Index (CPI) or 5%. This basically prohibits the taxing authorities from raising taxes without a vote of the people by just increasing assessed valuations. This assumes though that the assessed valuations are at least keeping up with inflation. The assessed valuations in the City of Sedalia have not kept up with inflation. This has the effect of raising the levy amount to compensate for the difference. This keeps the tax revenue from going down, but does not allow for the reality of the effects of inflation. Likewise, since the levy rate goes up, it has an uneven effect on individual taxpayers. The ones that are assessed accurately are paying more than their fair share, in favor of those that are significantly undervalued. Unfortunately, this can only be rectified through the assessor's office. Staff will continue to work to influence improvement.

This hearing is set aside for anyone from the public to make comments on the appropriateness of the levies before Council considers adoption of the ordinance to set them.

<u>Finance/Administration Committee</u> – There are six items for consideration through the Finance / Administration Committee.

- Jessica Pyle, Finance Director, will provide an update on the major tax revenue collection trends.
- As presented above, every year Council may consider an ordinance to set property tax levies after conducting the public hearing at the beginning of this meeting.
- The property insurance policy is expiring the end of this month. Jason Myers, City Clerk, has been working with each department to accumulate the information and has coordinated the

bid process. There was only one bid received and it was from the current underwriter through our current agent. We have been pleased with the service we have received and the quote came in overall as a flat rate. The premium will go up slightly due to increases in the amount of property being insured. Staff recommends renewal of the property insurance policy with Cincinnati Insurance, through Assured Partners at an annual premium of \$263,857.00.

- 4. State statutes require cities to select a financial institution to serve as its depository of public funds. Jessica Pyle, Finance Director, coordinated the bid process this year. Central Bank, our current depository, and Equity Bank submitted proposals. A six-person committee was organized to review the bids in detail and score each one in accordance with the established criteria of the request for proposals. These proposals were extremely competitive and that was reflected in the discussion of the committee as well as in the scoring. The scoring averaged less than one point difference, with Central Bank's proposal slightly edging out Equity Bank's. Equity scored higher on net revenue / costs, and Central scored higher on convenience and service level experience. Several of the committee members, noting the competitiveness of the proposals, recommended splitting the business to take advantage of the best of both proposals. Staff also recommends this approach of maintaining the existing relationship with Central Bank, while transitioning a significant portion of the business to Equity Bank.
- 5. The City has partnered with the Lion's Club on several past successful projects, such as a shelter at Katy Park, the Mini Park along Clarendon, and the beautification of the roundabout and the addition of the flag pole, to name just a few. Likewise, this very active club organizes volunteers on a regular basis to pick up trash along 50 Hwy entering our City. In keeping with these great works, the Club approached the City about the possibilities of organizing a fund raising campaign to facilitate adding logos to the water tower(s). After some preliminary investigation, they have received an estimated cost of approximately \$40,000 per side to affix the Sedalia logo and tagline to a tower. Staff agrees that having the logo displayed on the water towers would be a great promotional tool and generate a great deal of community pride. As you will recall, during the branding campaign, it was stated as a primary goal to create a brand identity for the whole community, and thereby it was not merely about creating a logo for city government. Therefore, it would be entirely appropriate to use the logo and tagline in this way. Likewise, having community support through the civic organizations serves to greatly enhance the sentiment of community spirit and pride displaying this logo represents. While, we would like to have the logo on two sides on both of the main water towers, this may be cost prohibitive to do all of this at one time. The Lions Club has done some research regarding where we could start in order to gain the most benefit. They have driven around the community and mapped where they could see each of the two main towers. From this informal study, the West tower along 16th Street is the most visible from the majority of the locations throughout the community. Therefore, they have set the goal of raising \$40,000 and asked for a pledge from the City to match this with \$40,000 that would fund putting the logo on two sides of the West water tower. Staff recommends approval of a resolution supporting this endeavor, as well as, amending the budget to formally appropriate up to \$40,000 matching funds for the project.
- State Fair Community College (SFCC) has been a long standing and essential partner with the City in its economic development efforts and successes. SFCC is always well represented at the bargaining table providing key components of the package to draw interest in our com-

munity. Being able to show with confidence how a prospective jobs creator can garner and retain a trained workforce is most often the first hurdle that we must overcome. SFCC is an invaluable asset to the community in this arena. The recently completed Olin Howard Workforce Innovation Center was a huge step forward for the College, and the City was proud to be able to act as a passthrough for some grant funds to help fund that project. SFCC is now currently working through the next phase of that project by renovating and repurposing some existing buildings to expand its programs. The College is now embarking on adding more infrastructure to expand its capabilities in such work force development through three interrelated projects. They are building a new Center for Advanced Agriculture and Transportation Technology, a new 200-bed residence hall, and a new outdoor athletic complex. All total approximately \$50 million in new construction. Dr. Bates, President and Patricia Wood, Board President, have requested consideration of waiver of the building permit fees for these projects. Staff recommends that the partnership with SFCC and the programs these projects will facilitate are in the publics best interest. It is an appropriate use of City resources to conduct the plan reviews and related inspections to ensure public safety while foregoing the revenue offsets.

<u>Public Works Committee</u> – There are six items for consideration through the Public Works Committee.

- 1. The City previously entered into a design build contract with Burns & McDonnell to design and construct improvements to the Central Waste Water Treatment Plant. This project has been part of the strategic plans for the last few years and some of the funds were included in the new moneys portion of the 2019 refinancing of the 2010 series Certificates of Participation (COP's). A design decision made on which style of blower equipment to be used created a scope change to the design portion of the contract. It has been decided that turbo style blowers are best suited for this application and those blowers require a building enclosure to protect them from the elements. The design of this building was not in the original scope of the design contract. Therefore, staff recommends amending the contract to add to the scope of work and increase the compensation by \$49,800.00.
- 2. The City's Water Department, through the then representative Public Works Board, entered into a collaborative agreement with the Department of Conservation in 2004. This Community Assistance Program (CAP) arrangement outlined certain roles and responsibilities of the City and the Department of Conservation over a 25-year period. This collaboration is what has provided the Dock, Access Road, Boat Ramp, and fish stocking, among other things, for the public enjoyment of Spring Fork Lake. Since that time, the management of the Water Department has been folded directly under the City Council. The Department of Conservation, wishing to continue this arrangement, proposed amending the agreement to clarify the Public Works Board no longer is the agent for the City, and thereby the agreement is simply with the City of Sedalia. Staff recommends approval. It should be noted that we are currently in the process of engaging the community to determine the best uses of the lake going forward. Preliminary indications are there is overwhelming support for maintaining at least these basic uses of the lake into the future. Likewise, the Department of Conservation has expressed their willingness to continue the relationship beyond the current agreement and potentially even expanding the services for the lake. Therefore, there may be reason in the near future to add to this agreement, but for now, it is simply changing the name and continuing at current levels.

- 3. As part of an E.W. Thompson, Inc. development project, it is necessary to extend an existing sewer main east from Curry Drive to Lamm Drive. E.W. Thompson is granting an easement to facilitate placement of such sewer main, along with the ongoing maintenance. Staff recommends approval.
- 4. Included in the current year budget appropriation is \$225,000 for the replacement of one of the dump trucks, plow, and spreader used in the Street Department. Lead times for new equipment continues to be excessive, with current estimates of 18-24 months for this type of truck. Staff has located an alternative in a used heavy haul truck that is in good shape and will provide some added flexibility to the fleet. After shopping around, staff negotiated a price of \$130,000 for this used truck. This will allow us to extend the use of the current fleet. However, it is likely staff will again recommend the purchase of another new truck and plow for next year, in hopes that lead times will be reduced and we can get back to a more routine replacement schedule.
- 5. As part of the planning for the upgrade project for the Central Waste Water Treatment Plant (CWWTP), staff identified a build up over the years of excess sludge being stored in drying beds and areas designed to hold overflow of this material. It appears this has been allowed to be only added to over time, without periodically dealing with it and disposing of it. As we undertake the process of making improvements to this plant, the drying beds and overflow storage capacity will become essential components, requiring their availability and functionality. Likewise, as part of normalized operations, these areas are intended to be cleaned out after drying and a full load of such dried material is accumulated. There is approximately now 480 tons of this material and staff has looked at the options for hauling and disposal of it. The use of internal staff and equipment is not recommended due to the amount of time and other projects that would have to be foregone or at least delayed to accomplish this task. Therefore, staff recommends hiring out the hauling of this material. Further, since this material has been there so long and there is no reliable way to tell what may be mixed into it, we do not recommend attempting to use this in our composting operation. The landfill will take this waste at a dumping cost of \$100 per ton. Staff thereby, recommends a budget amendment to appropriate \$75,000 for the hauling and disposal fee of this waste material.
- 6. Liberty Utilities is trying to secure ample easements to extend a gas main to a project north of Nucor. Nucor is supportive of granting an easement for this purpose across the property where their plant is located. Since this property is part of the Chapter 100 incentive program, the land is titled to the City and leased to Nucor, with a remainder interest flowing back to Nucor. In essence for practical purposes, the land is really fully under Nucor control. Nucor is in agreement with the easement, so therefore, staff recommends signing off on the granting of such easement.

<u>Public Safety Committee</u> – There are two items for consideration through the Public Safety Committee.

 Unfortunately, we have had individuals repeatedly calling public safety agencies for nonemergency situations. These calls have in some cases become so prevalent that they distracted 911 dispatch personnel from attending to real emergency calls. While we certainly do not want to discourage anyone from seeking and receiving assistance from these emergency service agencies such as police, fire, and ambulance, we must find a balance to prevent a few individuals making numerous harassing type non-emergency calls to the point of taking scarce resources away from those that truly need emergency responses when seconds count. Our prosecuting attorney has drafted an ordinance to define what would constitute abusive use of these public safety resources, grant the authority to fine an individual that violates these provisions, and provide for jail time for a second offense within a year of the first offense. Staff recommends approval.

2. Pettis County GIS Coordinator, James Theisen, worked with the police department to secure a grant from the Missouri Highways and Transportation Commission through their Strategic Highway Safety Plan Program. This grant will provide \$9,136.00 to offset the cost to purchase four bicycles equipped for the Police Bicycle Patrol Unit. Bicycles are better suited for areas where pedestrian and automobile traffic become combined and / or congested, as they can better move in and out of these areas. This grant was not anticipated in during the approval process of the budget. Staff recommends adding the revenue and formally appropriating such revenue for this purpose through a budget amendment.

<u>Community Development Committee</u> – There are three items for consideration through the Community Development Committee.

- The legal description attached to the annexation petition for the Deer Brook Villas Phase IV
 property contained a clerical error. Staff recommends amending the ordinance for the annexation to correct the legal description of the land.
- 2. There have been instances over the years where structures that have been duly adjudicated as dangerous or a public nuisance have been delayed for abatement while the courts moved through a sometimes lengthy eviction process. Our legal counsel has drafted legislation that effectively grants the authority to the Board of Appeals to issue an order to vacate the premises at the time they issue an order for repair or demolition of the structure. Staff recommends approval.
- 3. A previous amendment to the code governing the maximum size of signs created conflicting language between two sections. It was intended to increase the maximum size allowed, and a section containing the previous lower limit was overlooked and left unchanged. Staff recommends amending the code to remove the conflicting section with the lower limit of 48 square feet, leaving the revised section that allows for 80 square feet.

A public hearing will be held at 6:30 p.m. on August 21, 2023 in the Council Chambers in the Municipal Building, located at 200 S. Osage, at which time citizens may be heard on the property tax rates proposed to be set by the City of Sedalia, a political subdivision. The tax rates shall be set to produce the revenues which the budget for the fiscal year beginning April 1, 2023 show to be required from the property tax. Each tax rate is determined by dividing the amount of revenue required by the current assessed valuation. The result is multiplied by 100 so the tax rate will be expressed in cents per \$100.00 valuation.

Rene Vance, 19813 Tanglenook Rd., stated the Senior Center is selling raffle tickets for \$1,000.00 worth of meat along with a freezer. Tickets are \$10.00 each and only 450 will be sold. The Sedalia Tenderloin will be held September 10, 2023 from 11:00 a.m. to 1:00 p.m. and tickets are \$15.00 for adults and \$7.00 for kids. The fall spud sale will be held September 14, 2023 and they will also be collecting shoes of all sizes

through September 30, 2023 for their "Sole's for Success" fundraiser. AN ORDINANCE LEVYING AND PROVIDING FOR THE COLLECTION OF TAXES FOR THE YEAR 2023 IN THE CITY OF SEDALIA, MISSOURI.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF SEDALIA, MISSOURI, AS FOLLOWS:

Section 1. There is hereby levied for the year 2023 the following rate of taxation upon all real estate and personal property within the limits of the City of Sedalia, Missouri, which is not exempt from taxation as shown by the Assessor's valuation thereon, as fixed and agreed upon by the Board of Equalization, as follows:

- 1. For the purpose of defraying the expenses of the City of Sedalia, a city within the State of Missouri, having a population of less than 30,000 and more than 10,000 inhabitants, the rate and sum of \$0.4813 on the One Hundred Dollars valuation.
- 2. For the support and maintenance of the free public library heretofore established and now existing in the said City, the rate and sum of \$0.2344 on the One Hundred Dollars valuation.

The City Clerk's Office bid out the Commercial Property and Content Insurance for the City of Sedalia and only received one bid:

Assured Partners

Cincinnati Insurance – Total Premium \$265,880.00

The City's current coverage is with Assured Partners thru Cincinnati and the premium for 2022-2023 was \$247,896.00 which is a difference of \$17,984.00 from the amount bid by Cincinnati. The total values went up, so the comparison premium dollars per the value of the property being insured was flat.

Public Works Operations Manager, Justin Bray reviewed the schedule of contractor's equipment in order to compare amounts listed versus actual cash value for the various equipment. Following Mr. Bray's review and by adjusting amounts on the equipment to reflect current value, it resulted in an additional premium savings amount of \$2,023.00. With this additional savings, it decreases Cincinnati's bid to a total of \$263,857.00 which is a difference of \$15,961.00 from the 2022-2023 premium.

The recommendation is to award the bid for commercial property and content insurance for a one-year period with a renewal option of an additional two years to Assured Partners under Cincinnati Insurance effective September 1, 2023.

Re: City of Sedalia Depository Bid Award

State statues require City depository services to be selected by bid. The last depository bid was awarded in 2015. In May, City of Sedalia distributed notice for depository bids. The two bids received were opened on June 5, 2023. Central Bank and Equity Bank each submitted a bid for depository funds.

The proposals from Central Bank and Equity Bank were very competitive. The bid tabulation sheet prepared by Jason Myers is included. Also included is further analysis of comparison of the two bids and the scoring from each member of the finance committee.

In summary:

- Equity Bank's bid has the highest net income of just over \$20k annually, assuming a \$10M collective account balance. Both banks propose zero fees.
- 2) Five of the six scoring members, awarded equal or greater scores for Central Bank over Equity Bank in each of the remaining five categories: Service Levels, Service Experiences, Strength & Stability, Convenience, and Desirable Options.
- 3) Overall, five of the six scores awarded a total greater score to Central Bank over Equity Bank. The average of all six scores was less than one point. The bids were very competitive.
- 4) The recommendation by several scoring members includes to deposit some funds with Equity Bank, as best suited from an operational standpoint and to allow the opportunity to establish a depository relationship with Equity Bank.

All things considered, I recommend that we propose to Council on August 21 to accept the Central Bank proposal as the City of Sedalia main depository institution, while depositing some funds with Equity Bank.

SUBJECT: AMENDMENT TO CONTRACT WITH BURNS &

McDONNELL, CWWTP

Background:

The City is currently under contract with Burns & McDonnell, an engineering firm, for the design and construction of certain improvements to the Central Wastewater Treatment Plant. The scope of the project is refurbish the Aeration Basin, which includes: 1) New Mixer, 2) New Diffusers, 3) New Blowers, and associated equipment. The purpose of this upgrade is twofold: 1) to replace aging and broken equipment, 2) to assist in bringing the WWTP back into compliance with the approved National Pollutant Discharge Elimination System (NPDES).

Discussion:

City staff has been working with Burns & McDonnell on the upgrade to the plant. As part of that process, we have been reviewing various components of the proposed upgrade, which includes the blowers. There are two types of blowers for this application: 1) the existing blowers, which are Positive Displacement Blowers, or 2) Turbo Blowers. In reviewing the options and taking into account the proposed life of the WWTP, staff has recommend and is moving forward with the Turbo Blowers. There are two main reasons for this: 1) a more energy efficient blower, and 2) less moving parts and less expensive to maintain. The purchase of the Turbo Blowers requires the installation of a building to house the blowers, which is a requirement of the manufacturer to maintain the warranty; the existing blowers are outside and subject to the elements (which they are designed for). In choosing the Turbo Blowers, the cost of the building is factored into the overall life of the project. In the concept design work, the original plan was to replace the blowers with in-kind components, however as discussed above, the Turbo Blowers are the better option which requires the design of a building, which is currently outside of the scope of work with our contract with Burns & McDonnell.

Burns & McDonnell has provided the City with an Amendment to the Contract for the design work; this additional design work will increase the lump sum contract value by \$49,800 to a total value of \$248,700.00. Two signed amendments from Burns & McDonnell are attached.

Recommendation:

City staff recommends the City Council approved the amendment to the contract with an increased cost of \$49,800 and authorized the City Administrator to sign the amendment.

AMENDMENT TO TASK ORDER NO. 8

AMENDMENT No. 1 Date: 08/08/2023

This AMENDMENT modifies the Agreement dated February 22, 2023 made by and between Burns & McDonnell Engineering Company, Inc., (hereinafter called ENGINEER), and The City of Sedalia, Missouri (hereinafter called OWNER) for the following Project: Central WWTP Aeration Improvements. For good and valuable consideration, the sufficiency of which is acknowledged, the parties agree to make the following changes to their Agreement.

- 1. The parties agree that the DESIGN-BUILDER's Scope of Services is amended as follows:
 - A. Complete Preliminary Design and Pricing Development (in accordance with Task 4 and 5 of Task Order No. 8) for a new blower building with turbo-blowers adjacent to the Aeration Basin. Blower building to generally consist of:
 - i. Single room pre-engineered metal building.
 - ii. HVAC as needed for equipment requirements.
 - iii. No plumbing.
 - iv. Lighting, doors, and insulation in accordance with all applicable building codes.
 - Design of three (3) 2,700 scfm each turbo-blowers (2 duty, 1 standby) and associated piping and electrical equipment.
- 2. The following adjustments are made to the DESIGN-BUILDER's compensation:
 - Increase the total lump sum contract value by \$49,800 to a total value of \$248,700.00.
- The time for completion of DESIGN-BUILDER's Services is adjusted as follows:
 - Time for completion is extended by 62 calendar days to September 22, 2023.
- Other changes to the Agreement, if any, are stated below:

AGREEMENT BETWEEN THE

MISSOURI DEPARTMENT OF CONSERVATION

THIS AGREEMENT is to implement the MISSOURI DEPARTMENT OF CONSERVA	TION
COMMUNITY ASSISTANCE PROGRAM, and is made and entered into this	day of
20, by and between the CITY OF SEDALIA (City) and	l the
MISSOURI DEPARTMENT OF CONSERVATION (Department).	

WHEREAS, the City owns a tract of land in Pettis County with a 115-acre lake known as Spring Fork Lake that is used by the City for public fishing and recreation, and is referred to here as the "Area" and is described in attached Exhibit A; and

WHEREAS, the City and Department entered into a Community Assistance Program Agreement on July 23, 2004 for the Area which is hereby superseded and replaced; and

WHEREAS, the Department and City realize the importance and need for close-to-home fishing and associated outdoor activities; and

WHEREAS, the Department and City wish to take advantage of the qualities of this Area and maximize the recreational values associated with its proper management and use.

NOW, THEREFORE, in consideration of the mutual covenants of the parties contained herein, the parties hereto do mutually agree as follows:

1. **CITY RESPONSIBILITIES.** The City agrees to:

- A. Allow free public access and full use of the Area for fishing and related recreational activities by the general public consistent with the Wildlife Code of Missouri and during hours established by mutual agreement of the City and the Department.
- B. Provide Area maintenance as specified in attached Exhibit B.
- C. Monitor the condition of the Area's facilities and take actions necessary to ensure that they are clean, safe and usable, including but not limited to closing facilities to public access until any dangerous conditions that may have arisen have been corrected.
- D. Provide adequate law enforcement and protective services, as much as City jurisdiction permits, for the safety and well-being of the Area's users and facilities.

- E. Give proper recognition to the Department and the Federal Aid in Sport Fish Restoration Program in all brochures, advertisements or other publications concerning the Area.
- F. Prohibit fish stocking other than that recommended in writing by a Department fisheries management biologist.
- G. Manage its property within the watershed of Spring Fork Lake to maintain the lake's good water quality, and take no actions that will lead to the deterioration of the lake's water quality, habitat or aquatic community.
- H. Comply with all local, state, and federal laws and regulations related to the performance of this Agreement to the extent that the same may be applicable to the City. The City agrees to assume all risks associated with the activities performed under this Agreement. Nothing in this Agreement shall constitute a waiver of sovereign immunity.
- I. Follow the terms and conditions found on Exhibit C until July 23, 2029 since federal aid was used. Maintain in good working order and repair all facilities constructed pursuant to the July 23, 2004 Agreement until July 23, 2029. These facilities include the boat ramp, privy, floating fishing dock, parking lot with concrete parking pad, and entrance road.

2. DEPARTMENT RESPONSIBILITIES. The Department agrees to:

- A. Prepare and provide a general management plan for the fishery resources of the lake.
- B. Provide periodic fish community surveys and analysis, and manage the fishery through proper regulations, fish stocking, manipulation of the fish population and other fisheries management actions as determined by the Department.
- C. Enact and enforce appropriate fishing rules and regulations, and assist the City in enforcing the laws of the State of Missouri and the Wildlife Code of Missouri.
- D. Provide and maintain informational and entrance signs recognizing the City and the Department for their roles in this cooperative project.

3. JOINT RESPONSIBILITIES AND ACKNOWLEDGEMENTS. Both parties agree that:

- A. This Agreement is for the purpose of capitalizing on the value of the Area for public fishing and related outdoor activities.
- B. The Department may fund its obligations under this Agreement with any combination of state and federal monies.

- C. The required fishing permit as defined by the Wildlife Code of Missouri and the effective regulations pertaining to the taking of fish and use of the Area will be jointly publicized whenever possible.
- D. This Agreement shall become effective upon execution by both parties. It shall expire twenty-five years from the effective date; provided, however, that it shall renew automatically for successive terms of one year each if neither party has advised the other in writing of its intention to terminate the same at least one hundred and twenty days prior to any applicable termination date.
- E. Any electronic signatures affixed to this document are intended to authenticate this writing and to have the same force and effect as manual signatures, pursuant to the Missouri Uniform Electronic Transactions Act (§432.200 et seq., RSMo).
- F. This Agreement may be amended as desired by the mutual written agreement of the parties hereto.
- G. In the event of breach or default of this Agreement by the City, or should this Agreement be terminated by the City for other than breach or default by the Department, before July 23, 2029, the City shall reimburse the Department for that portion of the costs of improvements at the Area provided by the Department pursuant to the July 23, 2004 Agreement, minus the total amount actually expended by the City to maintain said Area as previously set out. In the event of breach or default of this Agreement by the Department prior to its expiration date, use without restriction of all improvements installed at the Area with Department funds pursuant to the July 23, 2004 Agreement shall revert to the City at no cost.

AREA MAINTENANCE STANDARDS

The City agrees to provide routine maintenance of the Area and facilities sufficient to keep the public use facilities in a clean, safe and usable condition. In accomplishment of this, the City agrees to:

- 1) Provide routine cleaning of the boat ramp.
- 2) Clean up trash and litter at least once each week from May 1st through September 15th, and as needed during the rest of the year.
- 3) Clean and deodorize privy at least once a week from May 1st through September 15th, and as needed during the rest of the year.
- 4) Pump privy when liquid levels reach 75% of pit capacity or before when conditions warrant, and to make repairs to Area privies as needed.
- Mow grass within 10 feet of roads, parking lots, and other public use facilities often enough to ensure that it does not exceed a height of 6 inches; and mow a 20-foot semi-circle around the cantilever directional sign (if provided) often enough to ensure that vegetation does not obstruct the visibility of the sign from both directions.
- 6) Control grass on roads and parking areas and around traffic control barriers (if present).
- 7) Provide and install rock (rip rap), as needed, to maintain any protective rocked slopes or banks in the vicinity of the provided facilities.
- Provide the normal, routine maintenance of Area roads, parking lots, entrance road, boat ramp, floating fishing dock, privy, sidewalks, ADA parking spaces and any other facilities needed to keep these items fully functional and to present a positive image of the City and Department to the public.

EXHIBIT C

NOTICE OF FEDERAL PARTICIPATION



SUBJECT: AMENDMENT TO CENTRAL WWTP BUDGET – HAULING OF EXCESS SLUDGE FROM DRYING BEDS

DATE: August 16, 2023

Background:

The Central WWTP is in the process of upgrading the aeration basin. As part of the upgrade, the City will need to provide space for biosolids that will be taken out of the aeration basin for the upgrade.

Discussion:

The existing drying beds have material that has been there for several years, which needs to be removed. To accomplish this task will require the hiring of a contractor who has the ability to haul the material to the landfill. The cost of the contractor and equipment is approximately \$27,000.00; based on a quantity of 480 tons of material (960,000lbs or 9000c.f.) and taking 2 weeks to complete. In addition, the City will pay for the disposal cost, at the landfill, at a rate of \$100/ton (\$48,000.00). The Public Works Department is requesting an **increase** of \$75,000.00 for account number 61-51-352-01 Land Improvements, Water Pollution Control Budget.

Recommendation:

City staff recommends the City Council approved the amendment to increase the budget by \$75,000.00 for account number 61-51-352-01.

AN ORDINANCE OF THE CITY OF SEDALIA PROHIBITING TELEPHONE HARASSMENT OF PUBLIC SAFETY AGENCIES.

WHEREAS, the City of Sedalia, Missouri desires to protect public safety employees from harassment in the form of repetitive, non-emergency telephone calls, as such harassment can distract limited resources and attention away from addressing emergency situations; and

WHEREAS, this concern is not hypothetical, but real, as several individuals routinely make dozens of non-emergency calls to 911 Joint Communications Dispatch every month, and at least one such call occurred while dispatchers were addressing a legitimate emergency.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF SEDALIA, MISSOURI as follows:

Section 1.

Sec. 36-25. Telephone Harassment of a Public Safety Agency

- (a) *Definitions*. As used in this section, the following terms shall have the following meanings:
 - (1) Repeatedly means 10 or more times in any 30-day period.
 - (2) Non-emergency telephone calls mean any telephone call that does not clearly involve a danger to life, danger to property, or does not seek assistance to the caller's location by a public safety agency.
 - (3) Public safety agency means any public safety organization providing emergency response services inside the city of Sedalia or any organization dispatching such services, including, but not limited to, Pettis County 911 Joint Communications, the Sedalia Police Department, the Sedalia Fire Department, the Pettis County Sheriff's Department, the Pettis County Fire District, the Pettis County Ambulance District, and the Missouri State Highway Patrol.
- (b) It shall be unlawful for any person to repeatedly make non-emergency telephone calls to a public safety agency, whether to the public safety agency's emergency line or administrative business line.
- (c) Nothing in this section shall be construed to limit or obstruct any person from making a legitimate emergency call or calling for assistance or service.
- (d) Nothing in this section shall be constructed to limit or obstruct the enforcement or prosecution of ordinance 36-24, which prohibits making a false report.

- (e) For the purposes of this section, it is immaterial which telephone number the call is made from, to which public safety agency telephone number the call is made, or which public safety employee answers the call. The burden of proof on the prosecution shall only be to prove, beyond a reasonable doubt, that the accused defendant cumulatively made a prohibited number of non-emergency telephone calls to covered public safety organizations in the prescribed period of time. The recordings of such calls shall be admissible into evidence upon the sworn testimony of a public safety agency's custodian of records that the recordings, and the listed dates and times of those recordings, are true and accurate.
- (f) Upon conviction for a first offense under this section, the Court shall impose a fine. Upon conviction of a second offense under this section within one year of the first offense, the Court may impose a jail sentence. Fines and jail sentences may be imposed in accordance with applicable law.
- (g) While not required to enforce this section or prosecute a violation of same, the director of any covered public safety agency is authorized to issue warning letters advising of this ordinance as appropriate.

Section 2. This ordinance shall be in full force and effect from and after its passage and approval.

MISSOURI HIGHWAYS AND TRANSPORTATION COMMISSION STRATEGIC HIGHWAY SAFETY PLAN PROGRAM AGREEMENT

THIS AGREEMENT is entered into by the Missouri Highways and Transportation Commission (hereinafter, "Commission") and the

City of <u>Sedalia Police Department</u>, a municipal corporation in the State of Missouri (hereinafter, "City").

WITNESSETH:

NOW, THEREFORE, in consideration of the mutual covenants, promises and representations in this Agreement, the parties agree as follows:

- (1) <u>PURPOSE</u>: The Commission has authorized State Road Funds to be used to support regional Strategic Highway Safety Plan activities. The purpose of this Agreement is to grant the use of such State Road Funds to the <u>City</u>.
- (2) <u>ACTIVITY:</u> The State Road Funds, which are the subject of this Agreement, will support the following activity to further Missouri's Strategic Highway Safety Plan Program: **Bike Patrol for Aggressive, Speed, Occupant Protection, Distracted Enforcement**
- (3) <u>INDEMNIFICATION</u>: To the extent allowed or imposed by law, the <u>City</u> shall defend, indemnify and hold harmless the Commission, including its members and the Missouri Department of Transportation (MoDOT or Department) employees, from any claim or liability whether based on a claim for damages to real or personal property or to a person for any matter relating to or arising out of the <u>City's</u> wrongful or negligent performance of its obligations under this Agreement.
- (4) <u>AMENDMENTS</u>: Any change in this Agreement, whether by modification or supplementation, must be accomplished by a formal contract amendment signed and approved by the duly authorized representatives of the **City** and the Commission.
- (5) <u>COMMISSION REPRESENTATIVE</u>: This Commission's District Engineer is designated as the Commission's representative for the purpose of administering the provisions of this Agreement. The Commission's representative may designate by written notice other persons having the authority to act on behalf of the Commission in furtherance of the performance of this Agreement.

- (6) <u>NONDISCRIMINATION CLAUSE</u>: The <u>City</u> shall also comply with all state and federal statutes applicable to the <u>City</u> relating to nondiscrimination, including, but not limited to, Chapter 213, RSMo; Title VI and Title VII of the Civil Rights Act of 1964 as amended (42 U.S.C. Sections 2000d and 2000e, *et seq.*); and with any provision of the "Americans with Disabilities Act" (42 U.S.C. Section 12101, *et seq.*).
- (7) <u>ASSIGNMENT</u>: The <u>City</u> shall not assign, transfer or delegate any interest in this Agreement without the prior written consent of the Commission.
- (8) <u>LAW OF MISSOURI TO GOVERN</u>: This Agreement shall be construed according to the laws of the State of Missouri. The <u>City</u> shall comply with all local, state and federal laws and regulations relating to the performance of this Agreement.
- (9) <u>CANCELLATION</u>: The Commission may cancel this Agreement at any time for a material breach of contractual obligations or for convenience by providing the <u>City</u> with written notice of cancellation. Should the Commission exercise its right to cancel the contract for such reasons, cancellation will become effective upon the date specified in the notice of cancellation sent to the <u>City</u>.
- (10) ACCESS TO RECORDS: The **City** and its Contractors must maintain all records relating to this Agreement, including but not limited to invoices, payrolls, etc. These records must be available at no charge to the Commission and/or their designees or representatives during the period of this Agreement and any extension, and for a period of three (3) years after the date on which the **City** receives reimbursement of their final invoice from the Commission.
- agrees that funds to implement Missouri's Strategic Highway Safety Plan activities shall only be available for reimbursement of eligible costs which have been incurred by the City. The City shall supply to the Commission copies of all bid information; purchase orders; invoices; and name, date, hours worked, and rate of pay (on Program Agreements that include salaries). Any costs incurred by the City prior to authorization and notification to proceed from the Commission are not reimbursable costs. The Commission shall not be responsible for any costs associated with the activity herein unless specifically identified in this Agreement or subsequent written amendments. The Commission shall not provide more than nine thousand, one-hundred thirty-six dollars (\$9,136.00) for this Strategic Highway Safety Plan safety project.
- (12) <u>USE OF FUNDS</u>: Any employee of the <u>City</u> whose salary or wages are paid in whole or in part with federal funds is prohibited from participating in certain partisan political activities, including, but not limited to, being a candidate for elective office pursuant to Title 5 United States Code (hereinafter, "U.S.C."), Sections 1501-1508. If an employee of the <u>City</u> participates in activities prohibited by the Hatch Act, the <u>City</u> shall no longer pay that employee's salary or wages with federal funds unless the requirements of 5 U.S.C. Sections 1501-1508 are not applicable to that employee pursuant to 5 U.S.C. Section 1502(c).

- (13) INSPECTION OF IMPROVEMENTS AND RECORDS: The City shall assure that representatives of the Commission shall have the privilege of inspecting and reviewing the work being performed per this Agreement. The City shall also maintain all financial documents, reports, papers and other evidence pertaining to costs incurred in connection with this Program Agreement, and make such materials readily available for review at reasonable times and at no charge during this Agreement period and for three (3) years from the date of final payment under this Agreement, for inspection by the Commission or any authorized representatives of the State of Missouri; copies shall be furnished, upon request, to authorized representatives of the Commission or State.
- (14) <u>VENUE</u>: It is agreed by the parties that any action at law, suit in equity, or other judicial proceeding to enforce or construe this Agreement, or regarding its alleged breach, shall be instituted only in the Circuit Court of Cole County, Missouri.
- (15) <u>FINAL AUDIT</u>: The Commission may, in its sole discretion, perform a final audit of project costs. The <u>City</u> shall refund any overpayments as determined by the final audit.
- (16) <u>SOLE BENEFICIARY</u>: This Agreement is made for the sole benefit of the parties hereto and nothing in this Agreement shall be construed to give any rights or benefits to anyone other than the Commission and the **City**.
- (17) <u>AUTHORITY TO EXECUTE</u>: The signers of this Agreement warrant that they are acting officially and properly on behalf of their respective institutions and have been duly authorized, directed and empowered to execute this Agreement.



AN ORDINANCE AMENDING THE SEDALIA CITY CODE BY AUTHORIZING THE BOARD OF APPEALS TO ISSUE ORDERS TO VACATE DANGEROUS BUILDINGS.
WHEREAS, the City Council wishes to empower the Board of Appeals, in issuing demolition orders for dangerous buildings, to further order the owners of such buildings and any occupants of same to vacate the premises to make way for such demolition; and
WHEREAS , the City Code authorizes fine and imprisonment for failing to comply with an order of the Board of Appeals.
NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF SEDALIA, MISSOURI, as follows:

SECTION ONE. Sec. 10-453 Order of repair or demolition.

(b) The order shall state a reasonable time, which shall not be less than 30 days from the date of issuance, within which to comply with the order, such time to be determined by the concurring vote of three members of the board of appeals, and shall further provide that if it is not complied with within such time, the building official shall cause the work or demolition to be done by the city and its own crews or by contractors employed by the city for that purpose. The board is further authorized to order all occupants and owners to vacate the subject premises to make way for such work or demolition. Persons refusing to vacate the premises shall be guilty of failing to comply with an order of the board of appeal pursuant to section 10-459 and subject to arrest and prosecution for same. Notice of an order to vacate shall be posted on the front of the subject building not less than ten days before the demolition commences.

SECTION TWO. Repeal of Conflicting Ordinances.

The provisions of any ordinance or code section in conflict with any provision of this ordinance are hereby repealed to the extent of such conflict.

SECTION THREE. Effective Date.

This ordinance shall be in full force and effect from and after the date of its passage and approval.

SECTION FOUR. Severability.

The provisions of this ordinance are severable and if any provision hereof is declared invalid, unconstitutional, or unenforceable, such determination shall not affect the validity of the remainder of this ordinance.

AN ORDINANCE AMENDING CHAPTER 64, ARTICLE VII, DIVISION 2, SECTION 64-210 GROUND SIGNS/MONUMENT SIGNS OF THE CODE OF THE CITY OF SEDALIA, MISSOURI TO ADJUST SIZE REQUIREMENTS.

WHEREAS, the City of Sedalia, Missouri desires to update its Code of Ordinances by amending Section 64-210 regarding Ground Signs/Monument Signs; and

WHEREAS, the City of Sedalia, Missouri has determined that it is appropriate and necessary to amend this Section to clarify size requirements for said signs.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF SEDALIA, MISSOURI as follows:

Section 1. That Section 64-210. – Ground Signs/Monument Signs of Division 2 – Sign Construction and Maintenance Standards, Article VII - Signs, Chapter 64 - Zoning of the Code of the City of Sedalia, Missouri, be amended to remove subsection (3) in its entirety, to read as follows:

Sec. 64-210. - Ground Signs/Monument Signs.

Ground Signs shall be subject to the following restrictions:

- (1) Shall be located so as to not obstruct vision at an intersection or a vehicular entry or exit from the property.
- (2) Ground/monument signs shall not exceed ten feet in height and a maximum size of 80 square feet. Pre-existing signs may not be altered without engineered plans.
- (3) Shall have a maximum size of 48 square feet.
- (4) (3) One ground sign shall be allowed for each building fronting a public street. The foregoing, however, is subject to the specific provisions of this division regarding the total number of signs allowed for each business.
- Section 2. That all other parts and provisions of the City Code not in conflict herewith shall remain in full force and effect unless previously or subsequently amended or appealed.
- <u>Section 3.</u> That should any section, sentence or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.

Section 4. That this Ordinance shall be in full force and effect from and after its passage and approval.

<u>Section 5.</u> That the City Clerk is authorized by this ordinance to correct any scrivener's errors identified within this Ordinance.
