Re: Agenda items for City Council meeting on Monday, December 18, 2023, 6:30 p.m.

<u>Strategic Plan Input</u> – As we progress through our strategic planning process heading to the January 6 session, we set aside a time each year to invite the public to provide input. Staff advertises this invitation to the public to provide suggestions at this time for inclusion in the strategic plan.

<u>Public Safety Committee</u> – There is one item for consideration through the Public Safety Committee.

As part of our strategic planning process, we ask that our outside service contractors make a
presentation. The contract requires such presentation and essentially, we ask that they report on how the funds were used this fiscal year, and then what services and costs they propose for the next fiscal year. For this meeting Trisha Rooda, will make such a report of the
cooperative contract between the City and County to join together for emergency management.

<u>Finance/Administration Committee</u> – There are five items for consideration through the Finance / Administration Committee.

- 1. Jessica Pyle, Finance Director, will provide an update on major trends in tax revenue collections.
- 2. Current City Code imposes certain regulations on holding garage sales and, in those regulations, imposes the requirement to obtain a permit for each such sale. The intent of the permitting requirement was to insure compliance with the regulations. However, many were not aware of the permit requirement and therefore never applied. Further, policing of the permits themselves has proven to be inefficient and unproductive to accomplishing the real intent of the regulations. Therefore, staff suggests eliminating the unwarranted and ineffective bureaucracy of the permit requirements. This still leaves the ability to manage the requirements, such as duration and frequency allowed, through other means that focuses solely on those that create a nuisance or undue disruption to the neighborhood. Staff recommends approval.
- 3. At the last Council meeting a very good discussion and debate on the merits of moving Council Member terms to four years was held. Ultimately, Council voted six in favor of and two against to direct staff to prepare an ordinance and bring back to this meeting for consideration to put this issue on a ballot for a vote of the people to weigh in. As stated during the discussion, staff sees this as purely a Council choice and has no recommendation for or against.
- 4. Certain positions within the City are required to make disclosures regarding potential conflicts of interest as regulated by the Missouri Ethics Commission (MEC) and City Codes. With the reinstatement of an Assistant City Administrator position, we asked legal to review if this position is subject to these disclosure reporting requirements. Our City Attorney advised that

the MEC reporting requirements do not apply to this position; however, the MEC does not preclude us from imposing these requirements by City Code. Therefore, in the spirit of transparency, full disclosure, and ensuring public trust, staff recommends imposing the conflicts of interest reporting requirements on the Assistant City Administrator position.

5. Included in the employment agreement with the Assistant City Administrator are provisions for, and limitations on the use of a city owned vehicle. We have located a used Durango that is suitable for this use from the Kansas Highway Patrol for \$30,850. Staff recommends approval of a budget amendment to appropriate the funds for this purchase.

<u>Public Works Committee</u> – There are five items for consideration through the Public Works Committee.

1. Chris Davies, our Public Works Director, will continue this year's presentations of strategic planning for each department. Director Davies will present at this meeting an overview of the plans for the water and wastewater departments.

As a reminder, I ask that in each of the individual presentations that they address the following four questions:

- a) Why is the service needed?
- b) Why should the City be doing it?
- c) What level of service are we providing now?
- d) How are we going to accomplish it? In other words, strategies going forward for services including any major budget requests related to new or expanded initiatives.

These presentations will all lead up to and set the stage for the Council strategic planning session on January 6th (the first Saturday in January). During this session, we review the highlights of each of these individual department strategic plans to bring them together into an overall plan for the City, to include setting relative priorities. This high-level direction from Council then becomes the basis for the budget development to match that strategy. We will then have budget work sessions February through March, culminating with a budget adoption the last meeting in March.

- 2. As part of our road maintenance program, we have a need for rock salt to treat roads during snow and ice events. We have developed storage capacity that enables us to bring in enough material to last the entire season, unless we have an extreme year with an abnormal number of events. This storage capacity allows us to bargain for a better lump sum price delivered outside of when everyone else is needing product. Likewise, this means that when it gets toward the end of the season and other communities are scrambling to find materials, we have it on hand. Staff has issued an invitation for bids (IFB) in accordance with our procurement policies. Four bids were received in response to the IFB and staff recommends award to the low bidder, Hutchinson Salt Company, Inc. at the bid price of \$75.42 per ton delivered price, and \$41.13 per ton with us picking it up.
- 3. The strategic plan for the upcoming year included the need to replace garbage trucks that are at the end of their useful lives. Further, the intent was to lay out the plan in the budget development for next fiscal year. However, we have been experiencing equipment failures at a rate that are impeding our ability to keep trash picked up. We have had so many failures at

the same time that we had to have public works crews pick up trash with loaders and dump trucks, which is inefficient to say the least. Likewise, the repair costs to keep the current trucks operational has been excessive and consuming our fleet maintenance resources. Therefore, staff has accelerated the proposal for Council consideration to move forward with some of the needed replacements now. The current operations require four side loaders and two rear loading trucks. This number allows for one of each type to be in reserve to rotate in as needed when others are down for maintenance or repairs. When we entered into a lease purchase arrangement five years ago for the side loaders, the intent was that these trucks had an expected useful life in excess of seven years. This would allow us to start purchasing replacements one at a time at the end of the five-year amortization so that we could get them spread out on a rotational replacement schedule. However, these trucks have proven to be undersized for our needs, and therefore have not lasted as long as they were anticipated to. Staff has researched and identified heavier trucks that are more suitable to the usage that we put them through, and further, have located two such trucks available for purchase now at \$757,800.00. Another part of the problem though, is that the Sanitation Fund does not have sufficient reserves to offset this level of purchase. I recommend that rather than going externally to borrow the funds or enter into a leasing arrangement, that we loan the money from the General Fund to cover this purchase. The General Fund has sufficient reserves to cover this without unduly putting into jeopardy the financial stability of the City even when considering fluctuations in the economy or the ability to react to disasters. As reported in our last audit report the General Fund has an unassigned fund balance of \$9,664,833. Staff recommends approval to move forward with this plan.

- 4. To further complicate matters with sanitation trucks discussed above, the newest rear loader truck was recently involved in an accident and the insurance adjuster determined it to be a total loss. We had two older trucks that we had been using as reserve when other trucks broke down. When the front-line new truck was wrecked, this put one of the older units back to front line use. Then the reserve unit went down and was not repairable, leaving us with no reserve on either the rear load or side load routes. This meant when any truck went down we had to bring in loaders and dump trucks. Staff worked with the insurance company to collect the proceeds from the totaled truck of \$207,364.95, and then located a new truck that was coming available quickly for \$265,000.00 plus \$2,364.95 to add camera equipment. Since we had a short window to secure the new truck, Mayor Dawson declared it an emergency purchase. In the spirit of transparency, staff recommends ratification of the purchase decision, as well as, approval of a budget amendment to formally appropriate the funds.
- 5. The owner of two lots, currently outside the city limits, has requested a connection to City utilities. In keeping with past practices over the last few years, staff has negotiated an annexation and utility services agreement. This agreement gives the City the right to annex the property at such time it becomes eligible, in exchange for providing access to City water services. Staff recommends approval of the two agreements with Kroeger Properties II LLC.

Community Development Committee-There are no items for consideration.

MINUTES: The Council Meeting minutes of November 20, 2023 were approved on motion by Foster, seconded by Cross. All in Favor.

Discussion: Consideration of moving Council to 4-Year Terms

City Council discussed changing Council Terms from 2 years to 4 years. City Prosecutor, Todd Smith explained that the term length process is defined by Statute 77.030. A city can move from 2 to 4-year terms which become effective on the next election. If approved by the voters, it would not be retroactive but the next term would be 4 years. There is a deadline of January 23, 2024 for adding the question to the April 2, 2024 ballot. The language on the ballot would read "Shall the terms of council members which are currently set at 2 years in the City of Sedalia, be extended 2 years for members elected after the relevant date".

Council Comments:

Oldham – Opposed to extension of terms; 2-year terms allow council members to remain active in the community and ensure they do their job appropriately and effectively; moving to 4-year terms has no benefit; believes in giving the voters the opportunity to have a say on the issue.

Boggess – In favor of increase to match Mayor term of 4-years; first 2 years is learning and then you return and run again; would be easier and more cohesive to have the extra time.

Hiller – Has received positive feedback from citizens and staff on extending City Council terms; first 1-2 years is learning the job.

Cross – By increasing the term, more individuals would be interested in running.

Foster – Pros and Cons to changing the term; would save taxpayer dollars by having fewer elections; shorter term encourages you to stay connected as a council member.

Bloess – Opposed to increase; willing to put it on ballot and let the voters decide.

Robinson – Opposed to increase; having the extra time is not beneficial; if you do a great job, you are reelected.

Motion by Boggess, seconded by Cross to draft an ordinance for the December 18, 2023 Council meeting to put the language on the April ballot. Roll Call Vote: Voting "Yes" were Oldham, Marshall, Boggess, Hiller, Cross and Foster. Voting "No" were Robinson and Bloess.

PUBLIC SAFETY – Jack Robinson, Chairman; Steve Bloess, Vice Chairman

<u>Strategic Planning Presentation – Fire Department</u>

Fire Chief Matt Irwin provided the following statistics since 2017: 42.3% increase in incidents; 46.6% increase in EMS; 34.2% increase in Non-EMS; 7.82% increase in overlapping incidents; Response time increase of 42 seconds; Turnout time decrease of 19 seconds.

Accomplishments:

Fire Prevention: Inspections up 104%; Pre-incident planning averages 775 annually; Hydrant testing of approximately 1,000 Hydrants, or 300/month.

Training: Total hours up 256% (12,742). Hours per member average 296.

Department Budget Impact:

- 1. Stations Central station rehabilitated 5 years ago but is due for replacement; possibility exists to add 610 acres to the southwest of the City; Future plans include Central Station rebuild behind the current Central Station along with a Training Center.
- 2. Apparatus (2) squad trucks expected mid 2024; Engine expected mid-2024, recommend ordering 1 more; Aerial needs to be ordered in 2024, 3-year delivery; Brush Truck needs to be ordered.

- **3. Personnel** Full-time Training/Preparedness officer; increase daily staffing from 10 to 12 and per shift from 13 to 15.
- **4. Training Facility** Currently have one small Conex box which is not stamped or certified; new facility would give ability to conduct live fire training for state certification and offer training to other fire departments; approximate cost \$1 Million.
- 5. Fire Hydrant Improvements Add hydrants to make inroads to underserved areas.
- 6. EMS Improvements UTV; Ballistic vests and MCI Bags
- **7. Community Involvement** Freddie the Fire Truck, Digital Sign for Headquarters, First Due Community Connect, Off-Duty personnel for special events.

<u>Presentation: Records Management System – Fire Department</u>

Fire Chief Matt Irwin stated that the Fire Department currently uses Emergency Reporting by ESO and the company has since sold and will not support or update emergency reporting to meet NERIS standards. The software is needed because under the United States Fire Administration, they are required to report all fire incidents and it is required for the acceptance of Federal Grants.

In reviewing various vendors, <u>ESO</u> increased cost to \$15,620 annually with a \$4,160 implementation fee and no additional services. <u>Tyler Technologies</u> was \$12,912 annually with a \$15,785 implementation fee, however, it is more geared toward Police and Joint Communications and everything is 3rd party. <u>First Due</u> is one platform and meets all fire department needs. The cost is \$24,100 for 15 months. Councilman Bloess inquired about a community module. Fire Chief Irwin stated that it is part of the Community Risk reduction. The community connect section will provide information on people, pets, special needs individuals, etc. and information is "back facing", meaning that it is not visible to the general public. The First Due system is efficient, saves time, provides cross module communication, vital information at time of dispatch, integrates with Brycer and direct connection with the community.

BILL NO. 2023-226, ORDINANCE NO. 11941 – AN ORDINANCE AUTHORIZING AN AGREEMENT FOR REPORT MANAGEMENT SOLUTIONS FOR THE SEDALIA FIRE DEPARTMENT was read once by title.

2nd Reading – Motion by Oldham, 2nd by Bloess. All in Favor.

Final Passage – Motion by Oldham, 2nd Robinson. All in Favor.

Roll Call Vote: Voting "Yes" were Robinson, Oldham, Marshall, Boggess, Hiller, Cross, Foster and Bloess. No one voted "No".

Strategic Planning Presentation – Police Department

Police Chief Matthew Wirt and Commander David Woolery gave an overview of Police Department Operations and goals. Department services include police, community services and training. Year-to-date, the department has handled over 30,000 calls for service. The Traffic/DWI unit have worked together to reduce serious incidents by 23% over the past 3 years. The Drone unit currently has 6 licensed pilots and 3 additional officers are getting their license. The Department was able to secure a grant for 4 bicycles and 2 e-bikes to use on the Katy Trail or other areas that require a quiet or hands on approach. The Department is involved with 4th of July, Halloween, Thanksgiving eve events and increased social media presence.

Areas of training include West Point Leadership (3-week leadership intensive course designed by West Point military and geared toward law enforcement); Raider Training (high intensive/active shooter type

call); Emergency Vehicle Operation Course driver training for all officers; Regional CIT training; Specialized crime scene and investigation training; and in-service training.

Strategic Planning:

Mr. Ingram stated he would talk to Mr. Powers and Ms. Shane to see what options they would like to pursue.



AN ORDINANCE AMENDING CHAPTER 44, ARTICLE III RUMMAGE SALES OF THE CODE OF THE CITY OF SEDALIA, MISSOURI TO REMOVE GARAGE SALE PERMITTING.

WHEREAS, the City of Sedalia, Missouri desires to remove permitting requirements for garage or rummage sales; and

WHEREAS, the City of Sedalia, Missouri has determined that it is appropriate and necessary to amend Chapter 44 to reflect the changes to garage sale regulations.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF SEDALIA, MISSOURI as follows:

Section 1. That Chapter 44, Article III Rummage Sales of the Code of the City of Sedalia, Missouri, be repealed in its entirety, and a new Chapter 44, Article III Garage Sales is hereby enacted to read as follows:

"ARTICLE III. GARAGE SALES

Sec. 44-88. Definitions.

- As used in this Article, the term "Garage Sale' shall mean the sale or trade, or offering for sale or trade, of unwanted or surplus goods, wares, merchandise or personal property of a household nature to the general public held on the premises of a private single-family or multiple family residence or any other building by the owner, owners, tenants or occupants thereof. The term "garage sale" shall include, but not be limited to, any patio sales, rummage sales, yard sales, lawn sales, moving sales, or other sales similarly conducted at or upon any property. The term "Garage Sale" specifically does not include privately organized, occasional sales or trades of items of personal property to a private individual in a single transaction. The term "Garage Sale" also does not include no-impact home-businesses under 71.990 RSMo..
- B. As used in this Article, the term "Estate Sale" shall mean a Garage Sale put on by the executor, administrator, or guardian of the legal estate of a deceased person.

Sec. 44-89. Frequency and duration; exceptions.

No Garage Sale shall be held or scheduled for more than two calendar days. No one person shall hold a Garage Sale more often than three times in any one calendar year; nor shall any such sale be held on the same premises more often than three times in any one calendar year unless otherwise explicitly authorized by law, provided, that this section shall not apply to any person conducting any such sale under and pursuant to a valid merchant's license issued by the city, nor to any Estate Sale.

Sec. 44-90. Exceptions for certain organizations.

The following organizations may have up to four Garage Sales per year on the same or different premises, provided that such premises are owned by the organization, or are not zoned R-1 to R-3 inclusive, nor used as residential property:

- (1) Organizations operating under section 501 of the Internal Revenue Code of the United States;
- (2) Not-for-profit corporations operating under state statutes; or
- (3) Organizations registered with the attorney general of the state under RSMo 407.453 et seq., charitable solicitations. Any such organization desiring to have more than two Garage Sales per year must provide adequate proof that they meet the requirements set forth in this section before the additional Garage Sales will be permitted.

Sec. 44-91. - Enforcement.

Violations of this Article are subject to municipal citation and prosecution. The penalty for violation shall be a fine as provided by law. Photographic evidence of garage sales on specific dates at specific locations, while not required, shall be admissible at trial as a business record of Sedalia Code Enforcement to prove the violation.

Secs. 44-92—44-125, Reserved"

- Section 2. That Appendix A, City Fee Schedule, of the Code of the City of Sedalia, Missouri be amended to repeal, Section 44-120 –Rummage, yard, or garage sale permit, in its entirety.
- Section 3. That the Fine/Bond Schedule of the City of Sedalia, Missouri be amended to repeal Section 44-120 No garage/rummage sale permit, in its entirety.
- Section 4. That all other parts and provisions of the City Code not in conflict herewith shall remain in full force and effect unless previously or subsequently amended or appealed.
- <u>Section 5.</u> That should any section, sentence or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.

AN ORDINANCE AMENDING SECTION 2-833(C) OF ARTICLE IX OF CHAPTER 2 OF THE CODE OF THE CITY OF SEDALIA, MISSOURI TO REQUIRE ASSISTANT CITY ADMINISTRATOR TO FILE FINANCIAL DISCLOSURE REPORTS.

WHEREAS, the City of Sedalia, Missouri is authorized by 105.485, RSMo. to enact an ordinance which requires certain city officials and employees to file annual financial disclosure forms; and

WHEREAS, the City of Sedalia, Missouri currently requires each elected official, candidate for elective office, the chief administrative officer, the chief purchasing officer, and the full-time general counsel to file annual financial disclosure forms; and

WHEREAS, the City Council of the City of Sedalia, Missouri has determined that it is in the best interest of the citizens and City to require the Assistant City Administrator, the assistant administrative officer, to file annual financial disclosure forms.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF SEDALIA, MISSOURI as follows:

Section 1. That Section 2-833(c) of Article IX — ETHICS, of Chapter 2 — Administration of the Code of the City of Sedalia, Missouri, be amended to include additional language, to read as follows:

- "(c) Disclosure reports. Each elected official, candidate for elective office, the chief administrative officer, the assistant administrative officer, the chief purchasing officer, and the full-time general counsel shall disclose the following information by May 1, or the appropriate deadline as referenced in RSMo 105.487, if any such transactions occurred during the previous year calendar year:
 - (1) For such person, and all persons within the first degree of consanguinity or affinity of such person, the date and the identities of the parties to each transaction with a total value in excess of \$500.00, if any, that such person had with the political subdivision, other than compensation received as an employee or payment of any tax, fee or penalty due to the political subdivision, and other than transfers for no consideration to the political subdivision.
 - (2) The date and the identities of the, parties to each transaction known to the person with a total value in excess of \$500.00, if any, that any business entity in which such person had a substantial interest, had with the political subdivision, other than payment of any tax, fee or penalty due to the political subdivision or transactions involving payment for providing utility service to the political subdivision, and other than transfers for no consideration to the political subdivision.
 - (3) The chief administrative officer, the assistant administrative officer, the chief purchasing officer and candidates for either of these positions also shall disclose by May 1, or the appropriate deadline as referenced in RSMo 105.487, the following information for the previous calendar year:
 - a. The name and address of each of the employers of such person from whom income of \$1,000.00 or more was received during the year covered by the statement.

- b. The name and address of each sole proprietorship that he owned; the name, address and the general nature of the business conducted of each general partnership and joint venture in which he was a partner or participant; the name and address of each partner or co-participant for each partnership or joint venture unless such names and addresses are filed by the partnership or joint venture with the secretary of state; the name, address and general nature of the business conducted of any closely held corporation or limited partnership in which the person owned ten percent or more of any class of the outstanding stock or limited partnership units, and the name of any publicly traded corporation or limited partnership that is listed on a regulated stock exchange or automated quotation system in which the person owned two percent or more of any class of outstanding stock, limited partnership units or other equity interests;

The City provides residential garbage service to its residents. To provide the service the City should have six (6) vehicles: Four (4) side loaders and two (2) rear dumps. This would provide the City with one (1) back up for each type of vehicle. Approximately five (5) years ago, the city purchased the side loaders, which based on my opinion, were not adequate to perform the job. Based on the current year budget we are over budget by 100%, and we still have a little of 3 months to go. The major issue with the current trucks are that they are undersized for the job and the arm is not designed for picking up such large loads.

The vehicles we are asking permission to purchase have significant advantages; 1) they are tandem axel, which allows the truck to carry the heavy loads, 2) the arm has less moving parts, is able to reach out vertically further, can handle up to 1000lbs, 3) and is able to hold 31 YD's of trash.

Please find attached an annexation agreement between the City of Sedalia and Kroeger Properties II LLC for Lot number Three (3) for Walnut Park 3 to be addressed as 6025 Lowe Dr. Kroeger Properties II LLC is requesting connection to the City's water distribution system and has agreed to pay the "out of City limits" rates until such time as the property is annexed into the City.

The agreement is written to allow the City to disconnect the water line should Kroeger Properties II LLC not complete the annexation process. Kroeger Properties II LLC has already signed and had notarized the agreement.

ANNEXATION AND UTILITY SERVICES AGREEMENT

This Agreement (hereinafter "Agreement") entered into this ______ day of _______ the Competer of Sedalia, Missouri, (hereinafter "City") and Kroeger Properties II, LLC (hereinafter "Owner").

RECITALS:

1. Whereas, Owner represents that he is the owner of the following real estate (hereinafter referred as "Owner's real estate") located in Pettis County, Missouri:

See attached "Exhibit A" as legal description of property and "Exhibit B" for location of property.

- 2. Whereas, Owner desires to connect Owner's property to the City's water system for purposes of developing Owner's property; and
- 3. Whereas, City desires to permit Owner to connect to the City's water system for purposes of developing Owner's property; and
- 4. Whereas, City desires the right to annex Owner's property if Owner's property becomes contiguous to City's corporate city limits; and

NOW, THEREFORE, for and in consideration of the above-recitals as well as the terms and conditions hereafter, the parties hereby agree as follows:

- 1. Owner, in exchange for the City's agreement to allow Owner to connect his property to the City's water system, the Owner, on behalf of himself, his successors, heirs and assigns, hereby conveys unto the City the irrevocable and perpetual right to file on his behalf a Petition of Annexation at any time after annexation becomes possible.
- 2. City shall allow Owner to connect a water line serving Owner's property to the City's water system, and Owner shall make connection at his expense. Prior to approving the physical connection, Owner shall obtain all necessary easements, if needed, from any other landowners and provide recorded copies to the City, obtain permits for the connection and pay all fees required to connect to the City's water system. City shall provide and install water meter and box for connection of Owner's water service line. Owner shall be responsible for connecting the Owner's water service line from the house to the meter. Owner shall become a utility customer of the City and shall pay all fees and charges established by the City for water service.
- 3. The Owner shall ensure the water service line serving Owner's property is constructed in compliance with City regulations and standards. Construction of the water service line shall be

inspected by the City as though the property were within the City limits and shall be subject to City approval. Owner agrees to bring the new water service line to the City's meter and make connection. Owner shall not be charged for water service until the activation of service with the City of Sedalia.

- 4. Owner agrees to the "out of city limits" fee/cost schedule for services until such time as the Owner's property is annexed into the City of Sedalia.
- 5. Water service lines serving property other than the Owner's property shall not be connected to the line serving the Owner's property without the City's written consent.
- 6. To the extent allowed by law, the City may annex Owner's property into the City, without further action of the Owner, after Owner's property becomes contiguous to the corporate limits of the City.
- 7. Owner irrevocably appoint the City Administrator of Sedalia, Missouri, as its attorney-in- fact for the sole purpose of presenting a verified petition requesting annexation of Owner's property to the City Council of Sedalia, Missouri, IF AND WHEN the property becomes contiguous and compact to the city limits of the City of Sedalia, Missouri. The City Administrator may exercise this power of attorney at any time after Owner's property becomes contiguous to the corporate limits of the City. Owner on his behalf, and on behalf of his heirs, successors and assigns do hereby waive any notice of the filing of the petition, do hereby consent to the granting of the petition, and do hereby waive any objections, statutory or otherwise, to the annexation of the property into the City of Sedalia. Owner does hereby authorize the City to take whatever action necessary to complete the annexation of this property. Owner's consent to such future annexation of the Property is irrevocable.
- 8. The parties hereto agree that this Agreement shall be recorded, in the real estate records of the Office of Recorder of Deeds of Pettis County, Missouri, and that the obligations and conditions of this Agreement shall run with the Property and shall be binding upon all future owners and users of the Property. Owner, on his own behalf and on behalf of all such future owners of the Property hereby agree that each purchaser, assignee or transferee of an interest in the Property, or any portion thereof, will be obligated and bound by the terms of this Agreement. Owner, on his own behalf and on behalf of all future owners of the Property, acknowledges that he and /or future owners of the Property shall be responsible for payment of all properly billed fees for water service as established by the City of Sedalia. Owner's liability contained in this paragraph 8 shall terminate when Owner has transferred his ownership interest in Owner's property to a successor owner, at which time, the successor owner shall be responsible for payment of all properly billed fees for water service as established by the City of Sedalia.
- 9. Alternatively, if requested by the City Administrator, Owner, his successors, assigns and heirs shall, within such time as specified by the City Administrator, submit a verified petition requesting annexation of the Owner's property to the City Clerk for presentation to the City Council of Sedalia, Missouri. The City Administrator may request Owner to present an annexation petition at any time after Owner's property becomes contiguous to the corporate limits of the City. The provisions of this paragraph shall be enforceable by specific performance.
- 10. Owner shall give a copy of this Agreement to the person or persons who buy the Owner's property.
- 11. If Owner fails to comply with any of the provisions of this Agreement, or repudiate the

terms of this Agreement, City may terminate water service to Owner's property and disconnect the utility lines serving Owner's property from the City's water system. City shall give Owner six months prior written notice of its intent to terminate service.

- 12. This Agreement is not intended to confer any rights or remedies on any person other than the parties.
- 13. The benefits and burdens of this Agreement are intended to attach to and run with the land and shall be binding on and inure to the benefit of the parties and their respective legal representatives, successors, heirs and assigns. All persons claiming under the parties shall conform to and observe the provisions of this Agreement.
- 14. This Agreement shall be recorded in the office of the Pettis County Recorder of Deeds at the City's expense.



The agreement is written to allow the City to disconnect the water line should Kroeger Properties II LLC not complete the annexation process. Kroeger Properties II LLC has already signed and had notarized the agreement.

ANNEXATION AND UTILITY SERVICES AGREEMENT

This Agreement (hereinafter "Agreement") entered into this 4th day of December, 2023, between the City of Sedalia, Missouri, (hereinafter "City") and Kroeger Properties II, LLC (hereinafter "Owner").

RECITALS:

1. Whereas, Owner represents that he is the owner of the following real estate (hereinafter referred as "Owner's real estate") located in Pettis County, Missouri:

See attached "Exhibit A" as legal description of property and "Exhibit B" for location of property.

- 2. Whereas, Owner desires to connect Owner's property to the City's water system for purposes of developing Owner's property; and
- 3. Whereas, City desires to permit Owner to connect to the City's water system for purposes of developing Owner's property; and
- 4. Whereas, City desires the right to annex Owner's property if Owner's property becomes contiguous to City's corporate city limits; and

NOW, THEREFORE, for and in consideration of the above-recitals as well as the terms and conditions hereafter, the parties hereby agree as follows:

- 1. Owner, in exchange for the City's agreement to allow Owner to connect his property to the City's water system, the Owner, on behalf of himself, his successors, heirs and assigns, hereby conveys unto the City the irrevocable and perpetual right to file on his behalf a Petition of Annexation at any time after annexation becomes possible.
- 2. City shall allow Owner to connect a water line serving Owner's property to the City's water system, and Owner shall make connection at his expense. Prior to approving the physical connection, Owner shall obtain all necessary easements, if needed, from any other landowners and provide recorded copies to the City, obtain permits for the connection and pay all fees required to connect to the City's water system. City shall provide and install water meter and box for connection of Owner's water service line. Owner shall be responsible for connecting the Owner's water service line from the house to the meter. Owner shall become a utility customer of the City and shall pay all fees and charges established by the City for water service.
- 3. The Owner shall ensure the water service line serving Owner's property is constructed in compliance with City regulations and standards. Construction of the water service line shall be

inspected by the City as though the property were within the City limits and shall be subject to City approval. Owner agrees to bring the new water service line to the City's meter and make connection. Owner shall not be charged for water service until the activation of service with the City of Sedalia.

- 4. Owner agrees to the "out of city limits" fee/cost schedule for services until such time as the Owner's property is annexed into the City of Sedalia.
- 5. Water service lines serving property other than the Owner's property shall not be connected to the line serving the Owner's property without the City's written consent.
- 6. To the extent allowed by law, the City may annex Owner's property into the City, without further action of the Owner, after Owner's property becomes contiguous to the corporate limits of the City.
- 7. Owner irrevocably appoint the City Administrator of Sedalia, Missouri, as its attorney-in- fact for the sole purpose of presenting a verified petition requesting annexation of Owner's property to the City Council of Sedalia, Missouri, IF AND WHEN the property becomes contiguous and compact to the city limits of the City of Sedalia, Missouri. The City Administrator may exercise this power of attorney at any time after Owner's property becomes contiguous to the corporate limits of the City. Owner on his behalf, and on behalf of his heirs, successors and assigns do hereby waive any notice of the filing of the petition, do hereby consent to the granting of the petition, and do hereby waive any objections, statutory or otherwise, to the annexation of the property into the City of Sedalia. Owner does hereby authorize the City to take whatever action necessary to complete the annexation of this property. Owner's consent to such future annexation of the Property is irrevocable.
- 8. The parties hereto agree that this Agreement shall be recorded, in the real estate records of the Office of Recorder of Deeds of Pettis County, Missouri, and that the obligations and conditions of this Agreement shall run with the Property and shall be binding upon all future owners and users of the Property. Owner, on his own behalf and on behalf of all such future owners of the Property hereby agree that each purchaser, assignee or transferee of an interest in the Property, or any portion thereof, will be obligated and bound by the terms of this Agreement. Owner, on his own behalf and on behalf of all future owners of the Property, acknowledges that he and /or future owners of the Property shall be responsible for payment of all properly billed fees for water service as established by the City of Sedalia. Owner's liability contained in this paragraph 8 shall terminate when Owner has transferred his ownership interest in Owner's property to a successor owner, at which time, the successor owner shall be responsible for payment of all properly billed fees for water service as established by the City of Sedalia.
- 9. Alternatively, if requested by the City Administrator, Owner, his successors, assigns and heirs shall, within such time as specified by the City Administrator, submit a verified petition requesting annexation of the Owner's property to the City Clerk for presentation to the City Council of Sedalia, Missouri. The City Administrator may request Owner to present an annexation petition at any time after Owner's property becomes contiguous to the corporate limits of the City. The provisions of this paragraph shall be enforceable by specific performance.
- 10. Owner shall give a copy of this Agreement to the person or persons who buy the Owner's property.
- 11. If Owner fails to comply with any of the provisions of this Agreement, or repudiate the

terms of this Agreement, City may terminate water service to Owner's property and disconnect the utility lines serving Owner's property from the City's water system. City shall give Owner six months prior written notice of its intent to terminate service.

- 12. This Agreement is not intended to confer any rights or remedies on any person other than the parties.
- 13. The benefits and burdens of this Agreement are intended to attach to and run with the land and shall be binding on and inure to the benefit of the parties and their respective legal representatives, successors, heirs and assigns. All persons claiming under the parties shall conform to and observe the provisions of this Agreement.
- 14. This Agreement shall be recorded in the office of the Pettis County Recorder of Deeds at the City's expense.



Background:

The City of Sedalia, in October 2022, advertised for Engineering Services, via a RFQ process following the procurement of engineering services in accordance with sections 8.285 through 8.291, RSMo. On or about December 2022, City Council approved Burns & McDonnell Engineering Company, Inc. (Burns & McD) to provide that service.

The City of Sedalia is under a consent order from MoDNR for both the North and Central Wastewater Treatment plants. The original concept was to upgrade specific portions of the Central WWTP to bring the plant into compliance; the North WWTP concept was to build a new plant north of the existing plant.

In reviewing past documents and concepts, staff made a recommendation to look at an alternative: the concept of combining both the "new" North WWTP and the Central WWTP into one (1) plant at the site of the existing plant. Once staff felt this was a viable option we worked through the concept with Burns & McD. Our next step was to bring the concept to MoDNR and review the process and concept to see if we had missed any key points. MoDNR felt this was a good way to proceed. The key benefits to this option are: 1) potential project savings of \$10M - \$15M, 2) reducing the number of WWTP, and 3) saving approximately 1 -2 years of time.

The City was also in the process of applying for State Revolving Funds Loan, which is a low interest loan program for large projects in the water and wastewater field. Applications for SRF funding are due March 1 of each year.

Since the original concept of a new plant and moving to a consolidation of plants, this would require some additional work by our engineer, which was outside of any existing scope of work.

Discussion:

In working with both Burns & McD and MoDNR, we have prepared a scope of work (Task Order No. 2) which engages Burns & McD in assisting the City of Sedalia in applying for SRF Funding and making application by the deadline of March 1, 2024. The scope of work includes the following major components: 1) Project Management, 2) Antidegradation Report, 3) Site Evaluation, 4) Feasibility Study, and 5) Assistance in applying for all appropriate grants and loans through MoDNR.

Recommendation:

City staff recommends the City Council approved the Engineer-Owner Agreement (Task Order No. 2) for the assistance with Technical Support to apply to MoDNR for SRF funding.

1. Scope of Services:

ENGINEER will assist OWNER with technical support for application to the Missouri Department of Natural Resources for State Revolving Fund Loan for the Central Wastewater Treatment Plant Expansion. As part of the technical support for the application, a Feasibility Study will be developed for the proposed project scope. The scope of this work will focus on the consolidation of the North Wastewater Treatment Plant and Central Wastewater Treatment Plant site. The proposed scope includes evaluation of the expansion of the Central Wastewater Treatment Plant to a rated capacity of five (5) million gallons per day, associated decommissioning of the North Wastewater Treatment Plant, and conveyance of flows from the North Wastewater Treatment Plant to the Central Wastewater Treatment Plant site. Storage to accommodate peak wet weather flows will be maintained as currently configured at the North Wastewater Treatment Plant Site and a new peak wet weather storage basin will be sited adjacent to the Central Wastewater Treatment Plant site. Schematic routing and preliminary confirmation to convey flow from the North Wastewater Treatment Plant to the Central Wastewater Treatment Plant tributary collection system will be evaluated. Exhibit B provides a defined scope of services for this Task Order.

2. Compensation:

A. Amount of Payment:

- 1. For Services performed, OWNER shall pay ENGINEER the lump sum amount of One hundred Forty-one Thousand Six Hundred Eighty-nine dollars (\$141,689.00).
- 2. For additional, reduced, or changed Scope of Services, the amount of payment shall be adjusted on a mutually agreeable lump sum basis.

B. Statements:

 Monthly statements will be submitted by ENGINEER to OWNER. Statements will be based on ENGINEER's estimated percent of Services completed at the end of the preceding month.

3. Time of Service:

Scope of Services: ENGINEER will assist OWNER with technical support for application to the Missouri Department of Natural Resources (DNR) for State Revolving Fund Loan for the Central Wastewater Treatment Plan Expansion. As part of the technical support for the application, a Feasibility Study will be developed for the proposed project scope. The scope of this work will focus on the consolidation of the North Wastewater Treatment Plant and Central Wastewater Treatment Plant at the Central Wastewater Treatment Plant site. The proposed scope includes evaluation of expansion of the Central Wastewater Treatment Plant to a rated capacity of five (5) million gallons per day and associated decommissioning of the North Wastewater Treatment Plant and conveyance of flows from the North Wastewater Treatment Plant to the Central Wastewater Treatment Plant site. Storage to accommodate peak wet weather flows will be maintained as currently configured at the North Wastewater Treatment Plant Site and a new peak wet weather storage basin will be sited adjacent to the Central Wastewater Treatment Plant site. Task 1 - Project Management

- 1. Project Administration
 - a. The Engineer shall prepare a monthly status report and invoices and will monitor project budget, labor hours expended and schedule throughout the project. Monthly status reports will describe the work completed during the previous month, anticipated work for the following month, current budget and schedule status, and any project issues requiring discussion or resolution.
- 2. Progress Meetings
 - a. Engineer shall conduct one (1) virtual and one (1) in-person progress meetings with Owner to provide updates on work progress, budget and schedule status, current issues, and/or variance in potential scope of work. Engineer will draft meeting minutes and provide to Owner for review and approval.
- 3. Project QA/QC Activities
 - The Engineer will perform internal quality assurance and quality control on project deliverables.



Task 2 - Antidegradation Report

1. Evaluation and Review

- a. Evaluation of discharge options on a pollutant-by-pollutant basis relative to determining whether the Antidegradation approach will be significantly or minimally degrading.
- b. Identify and assess no-discharge options, minimally degrading, and significantly degrading alternatives with consideration for each pollutant of concern; these options will be reused from the North Wastewater Treatment Plant Anti-degradation review. One option for consolidation at the Central Wastewater Treatment Plant will be evaluated. Prepare an evaluation of alternatives to the proposed discharge. These alternatives are compared in terms of practicability, economic efficiency and affordability.
- c. Determine the Base Case Effluent Limits Identify a reliable treatment design to be the Base Case that will meet the minimum water quality requirements of the receiving water. All pollutants of concern will be identified to determine minimum water quality requirements including considerations for the current North Plant pollutants of concern.
- d. Conduct an Alternatives Analysis Preliminary assessment will be completed to review three alternatives. Alternatives include no discharge (copied from North Wastewater Treatment Plant Anti-degradation review), construction of a new North Wastewater Treatment plant (copied from North Wastewater Treatment Anti-degradation review), and a new consolidated treatment facility at the Central Wastewater Treatment Plant resulting in decommissioning the existing North Wastewater Treatment Plant. Flow schematics, cost estimates, and present worth calculations will be developed for each alternative. The preferred alternative will be selected.
- e. Develop Effluent Limits for Discharge Options Effluent limits for all discharge will be established. For pollutants shown to be non-degrading using the method, effluent limits shall reflect the maintenance of pollutant concentrations. For pollutants that are degrading, the effluent limits shall reflect the concentrations that can be reliably met by the preferred alternative.
- f. Determine Social and Economic Impacts Identify the affected community, identify relevant factors that characterize the social and economic conditions of the affected community and describe the important social and economic development associated with the project.

2. Report Development

- a. Draft Antidegradation Review Report A draft Antidegradation report will be developed to summarize the project background and the evaluation approach. The draft will be provided to the OWNER for review and comment.
- b. Final Antidegradation Review Report OWNER comments will be incorporated into the Final Report for inclusion in the Feasibility Study.
- c. Complete Antidegradation forms and other requirements complete associated forms and requirements including the natural heritage review, and antidegradation tier form. Provide to OWNER as included in the Antidegradation Review Report.
- d. OWNER will be responsible for submitting Antidegradation Review Report to DNR and for any associated fees.
- e. Correspond with the DNR as necessary; up to eight hours of correspondence is included as part of the work.



Task 3 - Environmental Review

ENGINEER will draft a Feasibility Study report for the OWNER to submit in conjunction with the associated SRF application. The Feasibility Study will provide schematic design for the North Pump Station, force main, collection system upgrades, and flow equalization for the Central Wastewater Treatment Plant Expansion. A schematic design to consolidate the discharge from the North Wastewater Plant and the Central Wastewater Plant to a single facility at the Central Wastewater Treatment Plant will be developed. The opinion of costs for the proposed project will be provided.

- 1. Previous wastewater master plan reports will be utilized to provide basic information in the study of the planning and service area, population projections and proposed planning period.
- Alternatives evaluation will be completed utilizing previous reports which included a nodischarge alternative and a new plant to replace the existing North Wastewater Treatment Plant. Schematic design will be developed to evaluate an additional alternative to combine the



North and Central Wastewater Treatment Plants to a single facility at the Central Wastewater Treatment Plant site. A recommended project alternative will be established. Previous master plan will be referenced in relation to the evaluation of the existing wastewater facilities condition.

- A schematic design of the proposed sewer collection system infrastructure associated with routing flow from the existing North treatment plant to the Central Plant will be developed. Easements and improvements to the existing collection system will be identified.
- 4. Storage to accommodate peak wet weather flows will be maintained as currently configured at the North Wastewater Treatment Plant Site and a new peak wet weather storage basin will be sited adjacent to the Central Wastewater Treatment Plant site. The existing collection system model will be utilized to verify the volume of the proposed storage basin. The model will be used to evaluate the management of wet weather flow conditions for both the north and central sewer basins. Previous master plan report will be referenced to address inflow and infiltration analysis and evaluation.
- 5. Wastewater strength received at the North Wastewater Treatment Plant and Central Wastewater Treatment Plant periodically exceeds typical domestic strength, Basis for design of the consolidated Central Wastewater Treatment Plant will consider typical domestic strength wastewater (medium strength, as defined in the fifth edition of Wastewater Engineering Treatment and Resource Recovery by Metcalf & Eddy). Implementation and governance of pretreatment program by the OWNER will serve to regulate and reduce industrial contributions in lieu of planning and construction of a municipal facility to receive and treat industrial strength waste. OWNER will conduct laboratory analysis to characterize influent (upstream of the primary clarifiers) to support development of biological calculations to supplement historical plant performance data for the North Wastewater Treatment Plant and the Central Wastewater Treatment Plant. The data collection will occur over fourteen consecutive days and will consist of the following parameters: (1) influent and effluent flow, (2) influent chemical oxygen demand (COD), (3) influent biochemical oxygen demand (BOD), (4) influent soluble BOD, (5) influent total Kjeldahl nitrogen, (6) influent ammonia, (7) influent nitrate and nitrite, (8) influent total phosphorus, (9) influent orthophosphate, (10) influent total suspended solids (TSS), (11) influent volatile suspended solids, (12) influent pH, (13) influent alkalinity, (14) RAS flow, (15) WAS flow. OWNER shall note any operational irregularities including return flow from extraneous flow basins, solids handling filtrate, or otherwise impactful conditions. OWNER shall provide additional Daily Monitoring Report data from previous years (2021-2023).

Task 7 - Facility Plans

TASK 7 IS NOT INCLUDED IN THE INITIAL SCOPE AND FEE; SCOPE, FEE, AND SCHEDULE WILL BE FINALIZED BASED ON FINDINGS FROM THE FEASIBILITY STUDY. AN AMENDMENT WILL BE ISSUED PRIOR TO PROCEEDING WITH TASK 7.

- 1. Facility Plan No. 1: North Lift Station, Force Main, and New Equalization Basin
- 2. Facility Plan No. 2: Central Wastewater Treatment Plant Expansion



Task 8 – Clean Water State Revolving Loan Fund Application

Engineer will provide assistance in application for the Clean Water State Revolving Loan Fund. Up to three (3) applications may be made to maximize grant funding opportunities. The applications will include the following:

- 1. CWSRF with Emerging Contaminant Grant: pending sampling at the existing Central Wastewater Treatment Plant flow equalization basin, accumulated sludge may contain emerging contaminants. If emerging contaminants are present, the Engineer will provide technical assistance included in Task 5 in application for the Emerging Contaminant Grant as part of a CWSRF application.
- 2. CWSRF with Affordability Grant: pending final determination of capital cost and implementation schedule, the Engineer will provide technical assistance included in Task 6 in application for the Affordability Grant as part of the CWSRF application.
- 3. CWSRF with Water Quality Grant: based on discussion with DNR staff, a Water Quality Grant may be applicable to the project. Engineer will provide technical assistance included in Task 6 in application for the Water Quality Grant as part of the CWSRF application.
