# OFFICE OF THE CITY ADMINISTRATOR

Re: Agenda items for City Council meeting on Monday, October 21, 2024, 6:30 p.m.

<u>Finance/Administration Committee</u> – There are two items for consideration through the Finance / Administration Committee.

- Bothwell Regional Health Center (BRHC) is a City Hospital organized under Chapter 96 of the State Statutes (RSMo). Under such statutes and the applicable city code, an annual report is required to be made to the Council showing the receipts of all funds and expenditures therefrom. A copy of the audit report was sent out to Council ahead of time, and the Chief Executive Officer (CEO) and Chief Financial Officer (CFO) will provide an overview of the operations of the hospital and clinics.
- 2. Jessica Pyle, Finance Director, will provide an update on major tax revenue collection trends.

<u>Public Works Committee</u> – There are two items for consideration through the Public Works Committee.

- In connection with the new indoor arena the State Fair is building, there is a need to extend a sewer line to this facility. The extension will be from the fairgrounds along Clarendon, across the Katy Trail, to near Southwest Boulevard. In order to facilitate this construction, easements or license agreements are needed to grant access across the Katy Trail. Staff has negotiated terms of such agreement, and recommends approval.
- The Citizen's Traffic Advisory Commission received a request to establish a 3-way stop sign on West 10<sup>th</sup> Street and Mitchell Road. The Commission voted to recommend approval to Council. Currently, there is a stop sign at the end of Mitchell where it makes a tee intersection with 10<sup>th</sup> Street. The traffic on 10<sup>th</sup> is not required to stop at this time.

<u>Community Development Committee</u> – There is one item for consideration through the Community Development Committee.

 In reviewing the State Statutes and City Codes regarding the formation of a Plumbing Board and the process to issue plumbing certificates, we noticed that the State Statutes prescribe specific fees for such certificates. Staff recommends setting the City Code at the amounts called for by the State at \$5.00 annually for a Master Plumber Certificate and \$1.00 annually for a Journeyman Plumber Certificate.

<u>Public Safety Committee</u> – There is one item for consideration through the Public Safety Committee.

Fire Chief Irwin presented in his strategic plan the addition of six personnel to the Fire Department. As he presented, this would facilitate having two more firefighters responding to structure fires. The Chief pointed out how their roles would be assigned so that these added professionals will make the team more efficient, while increasing the safety of all the person-

nel on the scene, particularly if they are called upon for a search and rescue during the fire. Granted, thankfully, structure fires of this size do not occur very often. However, outside of these significant structure fire situations, adding two more individuals will facilitate responding to more overlapping calls quicker while maintaining the safety that is afforded with a three-person engine company. With the addition of the squad units that are currently being placed in service, we can now send out a two-person squad to the first medical or non-fire rescue call. Then, when an overlapping second call for that station comes in, the threeperson engine company would respond. For these reasons, Council ranked this initiative fifth out of eighteen for the General Fund priorities, and then approved \$366,609 in the budget. Also included in the budget though, was anticipated revenue from a grant that would fund these added costs for up to three years. We just learned, that while our grant application scored well, it did not score high enough to be funded. Despite not being successful in obtaining grant funding, staff recommends moving forward with the initiative of adding six more personnel to the Fire Department. All of the same reasons, as stated in the strategic plan, are still pertinent. However, the lack of additional revenue would mean that going forward lower ranked initiatives will not be able to be reached. Therefore, staff thought it important to review this situation with Council before moving forward with the hiring process. If Council agrees, no action will be necessary as the expenditures are already appropriated. On the other hand, if it is Council's desire to hold off the addition of these personnel, then that direction would be given in the form of an adopted motion. Of note in making this decision, there would be some offsets to these added costs, such as reduced overtime and the wear and fuel costs for the engines, as they would be the second apparatus out rather than the first to the vast majority of the calls.



## CITY OF SEDALIA, MISSOURI CITY COUNCIL MEETING OCTOBER 7, 2024

Fire Chief Matt Irwin stated that Mr. Kowalski is a second generation firefighter and graduated from the City's first Fire I and II Academy.

MINUTES: The Council Meeting minutes of September 23, 2024 were approved on motion by Oldham, seconded by Robinson. All Present in Favor. Marshall was absent.

#### UNFINISHED BUSINESS:

Citizens Traffic Advisory Commission received a request to establish a no parking zone in front of 710 West 6th Street. The residents there include some foster children with special needs. The parent requested the no parking to improve the safety of these children while getting on and off of the school bus. The Commission voted to recommend approval. A concern was raised regarding setting a precedent that would encourage others to come forward to request no parking in front of their homes. A compromise was suggested to limit the no parking to only during school hours. Council voted to postpone action on the matter and direct staff to modify the language of the bill. Since the last meeting, individual Council Members have been in contact with the requester and indications are that establishing a no parking zone for Monday through Friday from 7:00 a.m. to 4:00 p.m. would accomplish her goals.

Councilwoman Foster has concerns that this ordinance would set a precedence that more residents would want no parking areas in front of their homes. Having a lot of no parking zones can cause a lot of issues especially if there isn't enough parking to begin with. The school district should be brought in to determine other options.

#### Strategic Planning Presentation - Cemetery

Cemetery Director Roger Waters stated the Cemetery Department provides casket and cremation burials in-ground and above ground in Columbarium's. Since Crown Hill was founded in February 1866, there have been 24,909 burials through September 2024. There have been 83 burials, 40 grave lots and 11 Niches sold this year. Cemetery personnel sets Military Government markers for veterans and oversees the Monument Companies setting the headstones with proper location and footing for the size of the stones. During the spring, summer and fall cemetery personnel mow approximately 70 acres per week and in the winter are straightening headstones, trimming trees, working on mowing equipment and clearing snow from roadways.

Hebrew Cemetery located on South Grand has been owned by the City since 2001. There are 236 people buried at the Cemetery. Calvary Cemetery belongs to the Catholic Church, opened in 1868 and lies within Crown Hill Cemetery. There have been 3,949 burials in Calvary Cemetery thru September 2024 and the City collects monthly fees for maintenance and fees for the opening and closing of the grave lots.

Strategies include plotting out new areas for burials and new roads in the next few years. There are 1,980 grave lots left to sell in the new addition. Some are not the best due to water issue next to roadway ditches. The Columbarium installed in November of 2019 has 64 Niches with 63 sold. The new Columbarium ordered in July 2022 and installed in March 2023 has 64 Niches with 12 sold thru September 2024.

The property west of Veterans Memorial Drive purchased by the City in 2021 is suitable for a cremation burial area due to the trees. Cemetery Director Waters stated that he would also like to make walking trails in this area. The property catches water and changing how the water drains would be needed. Cemetery staff is working to stop mischief in the area and trying to make it safer and look like a cemetery/park area. Public Works has been assisting in the clean-up efforts, however, other projects have slowed progress. Cemetery Director Waters is currently researching ways to budget for assistance from an outside source to finish the clean up so Cemetery crews can maintain. He would also like to add a Committal Service Shelter in the area which is a covered pavilion on concrete that protects individuals from wind, rain, or snow and provide seating for 40-50 people during interment services. He would like to put this area off of Veteran's Memorial Drive, estimated cost of 65,000.00. He would also like to implement a new fee structure since fees have not been increased in seven years.

Staff has been working on a project to extend sewer to the new Bobcat dealership along with other existing businesses in the area. To facilitate the extension of the main across 65 Highway to tie into existing mains on the west side of the highway, additional easements need to be obtained. Vacuum and Jet Trucks are used in Public Works for routine maintenance of sewer mains by jetting them out to dislodge items that cause clogs to keep them flowing. Another common use is jetting out culverts and storm water structures. Due to the increasing usage of this equipment and the age, a new truck was purchased in April. The plan was to replace the 2008 model with the new truck and then refurbish the 2013 model. The cost to refurbish the 2013 model significantly exceeded the amount budgeted and the highest bid for the 2008 truck came in well below expectations. Staff worked with the dealer and negotiated a favorable trade-in for the 2008 truck to apply to the repairs to the 2013 truck. The quoted repair cost of \$83,300.98 will be offset partially with a trade-in allowance of \$40,221.24, leaving a net cost of \$43,089.74.

The City uses a Geographic Information System to map out and manage infrastructure. The City participates in an intergovernmental agreement with Pettis County where the City provides the flyover orthography updates every two years to the County and in turn the County provides access to the base layer of recorded property information. We then add our additional layers of infrastructure information. Due to logistical challenges, there has been a lack of coordination in the way this has been managed in the City. Individual departments have maintained separate programs at outlying locations to manage and view information, and have used copies of the database and added individual layers. Upon investigating, we determined that if we moved to a cloud version of the software, the management of the database would be streamlined. We have worked with the software company to develop a transition plan over the next three years and they will provide us licenses to use the current versions of the software, and assist in moving to cloud storage.

#### PUBLIC SAFETY - Chairman Jack Robinson, Vice Chairman Steve Bloess

The Police Department has been successful in obtaining a grant to supply rams and bullet resistant shields in all marked patrol units. They were also successful in securing a grant to purchase a computer for the drug enforcement unit. The budget amendment is to recognize the extra revenue of \$12,187.00 and formally appropriate the funds for the purchases.

#### **OLD BUSINESS:**

#### Installation of a 4-way stop at the intersection of E. 3rd St. and S. Massachusetts Ave.

Randy Riley is requesting a 4-way stop at the intersection of E. 3<sup>rd</sup> St. and S. Massachusetts Ave. He states while traveling north the cars parked in front of the apartments make it impossible to see oncoming traffic.

Ms. Esquivel stated after the July 10<sup>th</sup> meeting she notified residents of the apartments at this intersection as well as the employees of the Essex Senior Living Complex to no longer park in front of the fire hydrant. It appears since this, no one has been parking there and obstructing the view.

Ms. Broyles made the motion to deny the request. Mr. Callis seconded. All were in favor.

#### Installation of a 2-way stop at the intersection of E. 11th St. and S. Summit Ave.

Nadine Johnson is requesting the installation of a 2-way stop sign at the intersection of E. 11<sup>th</sup> St. and S. Summit Ave. She states currently there are no stop signs and motorists fly through the intersection and do not look for other vehicles. She would like the sign to stop the traffic on E. 11<sup>th</sup> St.

Traffic counts were conducted at this intersection (see attached). Mr. Davies also prepared a memo detailing why staff recommends the denial of placing the stop signs at this location (see attached).

Mr. Callis motioned to deny the request based on staff recommendations. Mr. Leftwich seconded. All were in favor.

#### Installation of a 2-way stop at the intersection of Skyline Dr. and Wing Ave.

Sherrie Harris is requesting the installation of a 2-way stop sign facing north and south on Skyline Dr. She states there are many kids in the area, cars are speeding and there is driver inattention.

The Commission directed Staff to place traffic counters after school was back in session. Those counts are currently under way.

Ms. Broyles motioned the request remain tabled until traffic counts are completed. Mr. Rucker seconded. All were in favor.

#### **NEW BUSINESS:**

#### Intersection of W. 10th St. and S. Mitchell Rd.

Tom Oldham has requested the Commission to review the intersection of W. 10<sup>th</sup> St. and S. Mitchell Rd. He stated with the extension of W. 10<sup>th</sup> St. from S. Mitchell Rd. to Lamm Dr. there has been an increase in traffic and those who exceed the speed limit. The area has seen growth with the Primrose Retirement Community, E.W. Thompson Rehabilitation Center, Deer Brook Village, E.W. Thompson Daycare. Mr. Oldham is looking for any help with the intersection.

Ms. Nations stated there is a stop sign currently on S. Mitchell Rd., which stops the traffic on S. Mitchell Rd.

Mr. Callis suggested counts are usually conducted before stop signs are put in to access the volume and speed of traffic.

Ms. Broyles stated she feels the installation of the signs would be a good idea. There will continue to be expansion in the area so this would help control the intersection.

Ms. Broyles motioned for a 3-way stop to be installed at the intersection of W. 10 St. and S. Mitchell Rd. Mr. Rucker seconded. All were in favor.

Intersection of W. 14th St. and S. Beacon Ave.

Debbie Ulmer has requested the Commission to review the intersection of W. 14<sup>th</sup> St. and S. Beacon Ave. There is currently no stop sign or dip sign in the area. She stated it is getting to be a dangerous intersection as vehicles stop or slow down they lose control. March 3<sup>rd</sup> of last year a driver lost control, hit the utility pole and totaled the car.

Ms. Esquivel asked if a dip sign could just be put in.

Mr. Leftwich made the motion for Public Works to install a dip sign at the intersection. Mr. Matson seconded. All were in favor.

11TH STREET; WITH STOP ON SUMMIT

#### Background:

The City of Sedalia received a request to install a 2-Way STOP at S. Summit and E. 11th Street, with STOP's on S. Summit.

#### Discussion:

The City conducted a traffic count study with the following results:

- The volume of traffic entering the intersection from the north and south, respectively is 252 and 226 vehicles per day.
- 2. The volume of traffic entering the intersection from the west and east, respectively is 75 and 92 vehicles per day.
- 3. 95% of the vehicles are at or below the posted speed limit.
- 4. There has not been any accidents within the last 5 years.

Minimum criteria for the installation of STOP signs is:

- 1. 5 or more reported crashes in a 12-month period
- 2. Volume of traffic averages at least 300 vehicles per hour for any 8 hour period on the major leg.
- 3. Volume of traffic averages at least 200 vehicles per hour for the same 8 hour period on the minor leg.
- 4. If the 85th-percentile approach speed of the major street exceeds 40 mph.

Based on the above information this intersection does not meet any of the criteria for the installation of a 2-WAY STOP.

If you have any questions or need, additional information please let me know.

#### Recommendation:

City staff recommends denial of the 2-Way STOP at S. Summit and E. 11th.

#### Background:

The Missouri State Fairgrounds is building a new indoor arena near the intersection of Clarendon Road and the Katy Trail. As part of the improvements sanitary sewer will be provided to the arena.

#### Discussion:

The sewer connection for the new indoor arena on the Missouri State Fairgrounds requires the extension of a City Wastewater line located near the intersection of Southwest Blvd. and Clarendon Rd. The extension is approximately 240 feet in length, in a northerly direction, until it enters the Missouri State Fairgrounds property. At this point the line will be extended on state property to provide sanitary sewer for the new indoor arena and is the responsibility, maintenance and operation, of the Missouri State Fairgrounds.

The northerly extension (240 feet) will become the responsibility of the City of Sedalia. For the construction to take place two (2) easements are required:

- Crossing the Katy Trail requires a license agreement between the Missouri Department of Natural Resources and the City of Sedalia, which is the one we are seeking approval for from the Sedalia City Council at this time.
- The 2<sup>nd</sup> easement is from Matz Properties Partnership located at 2540 Southwest Blvd.
  This easement will come before Sedalia City Council at a later date once the documents
  have been signed by the Matz Properties Partnership.

#### STATE OF MISSOURI DEPARTMENT OF NATURAL RESOURCES SANITARY SEWER LINE LICENSE AGREEMENT

THIS LICENSE AGREEMENT, NO. PTS2422 (Agreement), is made this year 2024 between the MISSOURI DEPARTMENT OF NATURAL RESOURCES (Licensor) and the CITY OF SEDALIA (Licensee).

#### ARTICLE I

- 1. Term: This Agreement shall be effective the date it is signed by Licensor and shall continue in force and effect indefinitely, so long as it is used for the purpose set forth in this Agreement or until any railroad operation is required pursuant to the National Trails System Act, at which time this Agreement may be assigned to railroad authority, unless terminated by either party giving the other party not less than 30 days advance written notice of an intention to terminate.
- 2. Consideration and Description: In consideration of a one-time preparation fee of ONE HUNDRED SEVENTY-FIVE DOLLARS (\$175.00) and a license fee of FOUR HUNDRED EIGHTY DOLLARS (\$480.00), Licensor grants a license and permission to Licensee and Licensee's representatives to construct, use, maintain, repair, and develop an eight inch (8") in diameter, SDR35 PVC carrier pipe encased in a sixteen inch (16") casing (Exhibit A) crossing in the Licensor's right-of-way (ROW) along the former Missouri-Kansas-Texas Railroad, presently utilized as a linear state park known as Katy Trail State Park. For convenience, said sewer line installation is called "Crossing" and Katy Trail State Park is called "Trail." The location of Crossing is described as:

Said 8" sanitary sewer line crosses the Trail at MP 229.8, GPS Coordinates 38.689194, -93.262611, in Section 08, Township 45N, Range 21W; City of Sedalia, Pettis County, State of Missouri, as shown in Exhibit B which is attached hereto and incorporated herein by reference.

- 3. Access: Licensor grants permission to Licensee to enter Licensor's Trail for the purpose of installing and maintaining Crossing at the location and as described above. Before entering Licensor's ROW, Licensee shall submit to Licensor five (5) days advance written notice before any work shall be performed on Licensor's property, subject to emergency access described in Section 4 below.
  - (a) Licensee shall post industry standard construction warning signs at the construction site, and at the Trailhead nearest the west approach to the construction site. Licensee shall cause as minimal interference as possible with the operation of Licensor's Trail. At no time is Licensor's Trail to be blocked from travel by users of Trail.
  - (b) Licensee shall notify Licensor the date the Crossing is installed and on completion of installation Licensee shall promptly remove from Licensor's property all tools,

equipment, and materials placed by Licensee. Licensee shall restore property to state and condition as when Licensee entered, reasonable wear and tear accepted, and shall leave property in a clean and presentable condition. Within 30 days of the completion of the construction of Crossing, Licensee shall submit to Licensor as-built drawings of Crossing.

4. Emergency Access: Licensee may enter Licensor's Trail if emergency maintenance or repair of Licensee's Crossing is necessary. In such circumstances, the five (5) day notice is waived. However, Licensee shall make reasonable efforts to notify Licensor that work is to be done and shall give Licensor a written report of the nature of the emergency and the time period Licensee was on Licensor's property as soon as possible after the emergency.

#### ARTICLE II

#### Licensee undertakes and agrees:

- 1. To assume the risk of, protect to the extent permitted by law, indemnify and hold harmless Licensor, its officers, agents, and employees from and against all liability for or on account of claims, demands or suits involving injury or death of any and all persons or damage to property or livestock, resulting from or incident to the construction, maintenance, reconstruction, and use of Crossing caused by Licensee, its agents, users, guests and invitees. Licensor shall not be liable for any damage to said Crossing or the contents thereof, unless caused by the negligence of DNR. Licensee agrees to immediately investigate any claims, demands or suits and shall defend, settle, and/or otherwise dispose at its sole cost and expense. In the event Licensee settles any claims, demands, or suits, it shall obtain a release which includes all claims against Licensor. Licensee shall not have or make against Licensor any claim or demand for or on account of any damage Licensee may suffer or sustain because of any failure of Licensor's title to the ROW and lands occupied by Crossing or any part thereof, and waives all right to question the validity of this License or any of the terms of provisions hereof, or the right or power of Licensor to execute and enforce the same.
- 2. To perform the above described Crossing work at its sole cost and expense. Said routine work shall be performed in accordance with plans and specifications prepared by Licensee, which plans and specifications must be approved in writing by Licensor prior to commencement of the work by Licensee. Written approval or disapproval of said plans shall be given by Licensor to Licensee within 30 days of the receipt of said plans and specifications, and Licensor's approval of said plans shall not be unreasonably withheld. Before entering upon Licensor's Trail, Licensee will give to Licensor five days advance written notice before any non-emergency work shall commence upon Licensor's Trail. Further, Licensee shall notify Licensor upon completion of said routine work, and Licensee shall promptly remove from Licensor's Trail all tools, equipment, and materials placed thereon by Licensee or Licensee's agents. Any and all excavations shall be backfilled by Licensee in a manner satisfactory to Licensor and Trail bed shall be restored to the conditions existing previous to the Crossing work and in such a manner so that Trail bed can be used as a recreational hiking and bicycling trail. Said work shall be performed by or on behalf of Licensee in such a manner and at such times as shall not endanger or interfere with the safe operation of Trail established along the previous railroad ROW with

Licensor's permission, or any railroad operation which may be required pursuant to the National Trails System Act in the future at said location. Licensee shall comply with all federal and state laws, regulations of Licensor, and the instructions of its representatives, relating to the proper manner of performing work on state land, and protecting the Trail and property at this location as well as the persons and authorized vehicles occupying, moving on, or using the Trail.

- (a) All construction contracts awarded by Licensee for the Project Area shall be awarded through competitive bidding procedures to the lowest, responsive, responsible bidder in accordance with Section 8.250, RSMo. Licensee shall comply with all other applicable provisions of Chapter 8, RSMo and Chapter 34, RSMo.
- (b) In no event shall approval by Licensor of the scope of work be a representation that any such plans comply with applicable laws. Licensee shall comply with all laws applicable to the construction work, and shall be solely responsible for obtaining all required approvals and permits for the same.
- (c) The Project Area shall be considered public works, and Licensee and/or its contractor(s) and subcontractors are performing work for the use of the public. Therefore, Licensee and its contractors and subcontracts shall comply with Missouri's Prevailing Wage Law, Sections 290.210 to 290.340, RSMo.
- (d) Licensee shall require a bond to guarantee payment of all persons and entities performing work on or furnishing materials for work on state land, in accordance with Section 107.170, RSMo, and ensure compliance with 285.530 RSMo, prohibiting employment of unauthorized aliens.
- (e) The prompt payment requirements imposed by Section 8.960, RSMo shall apply to payment of all invoices for design and construction services rendered in connection with the Project Area. Licensee shall make payments to all parties performing work on the Project Area promptly, in accordance with such statute.
- (f) Licensee shall comply with all federal, state and local environmental health and/or safety laws and regulations in existence or as amended or adopted in the future. Licensee shall not use or dispose of any hazardous materials on the License premises. In the event of any release of Hazardous Materials on, or contamination of, the License Premises, Licensee, at its sole expense, shall promptly take all actions necessary to clean up the affected property. Licensee shall return the affected property to the prior condition before contamination, to the satisfaction of Licensor and any governmental authorities having jurisdiction. In all cases, Licensee shall promptly notify Licensor of any release or contamination of Hazardous Materials on the License Premises 1. Licensee's obligations under this section shall survive the termination of this License Agreement.
- 3. To make appropriate arrangements with any person or legal entity occupying or using the premises affected hereby pursuant to a lease or other permission granted by Licensor, so that Licensee's said Crossing will not unreasonably interfere with the use of the subject property, or

create undue hardship on any person or legal entity occupying or using the premises or otherwise be in conflict with any of the provisions of Licensor's agreements under the National Trails System Act or the Certificate of Interim Trail Use (CITU).

4. This Agreement does not create any rights, claims, or causes of action between the parties to this Agreement in favor of any non-parties to the Agreement.

#### ARTICLE III

- 1. Repairs and Relocations: (a) In its use of the Crossing, Licensee shall at all times maintain the Crossing in a safe and secure manner, in a condition satisfactory to Licensor, and in a manner that will protect and will not interfere with the Trail or its users. Licensor may request Licensee to make reasonable repairs of damage to Crossing caused by Licensee, its users, guests or invitees, as in the judgment of Licensor shall be necessary to avoid interference with or danger in the use or operation of Licensor's Trail and property; its present or future appurtenances; or facilities or operations of other persons occupying or using the Trail with Licensor's permission. Licensee shall not be responsible for repair of damage to the Crossing, which is not caused by Licensee, its users, guests or invitees. Licensor shall provide written notice to Licensee designating non-compliance and, upon receipt of written notice, Licensee shall make any repairs as soon as reasonably practical, but in no event later than 30 days from receipt of notice for repairs that do not pose a public safety hazard, and within 10 days from receipt of notice in the event a condition exists that may threaten public safety.
  - (b) If Licensee shall fail to perform any of its obligations contained herein, including failure to make necessary repairs as outlined in Paragraph 1 (a) of Article III, Licensor may cause condition to make safe or made to comply as required, or cause repairs to be made. Licensor, acting as the agent of Licensee, may perform work as is necessary in the judgment of Licensor. Licensee shall, on demand, promptly reimburse Licensor the whole cost, plus 10% as a charge for supervision, accounting, use of tools and equipment; or Licensor may terminate this License by giving to Licensee not less than 10 days advance written notice of its intention to do so.
- 2. Termination: Notwithstanding Paragraph 1 (b), Licensor may terminate this Agreement if Licensee fails to comply with Licensee's covenants and obligations. Licensor may also terminate this Agreement if Trail is required for railroad purposes pursuant to the National Trail Systems Act. No reimbursement shall be made for Licensee's expenses incurred in the removal of the Crossing or the consideration paid for this Agreement. No termination or expiration shall affect the rights and liabilities, if any, of the existing parties.
- 3. Restoration: Upon the termination of this Agreement, Licensee shall remove its Crossing and restore Trail ROW to its condition prior to the construction of Licensee's Crossing, and in a manner satisfactory to Licensor. If Licensee fails to remove its Crossing within 90 days following termination of this Agreement, Licensor may remove and charge the expense there from to Licensee on the basis provided in Paragraph 1 (b) of Article III.

- 4. Assignability: This Agreement, and all the provisions contained, shall be binding upon the parties, and is personal to Licensee. Licensee agrees to supply notice in writing to Licensor of any name changes. Licensee agrees not to assign this Agreement or any interest including but not limited to concessionaires, without prior written consent of, and payment of any fees to, Licensor, and Licensor shall not unreasonably withhold consent. Any such attempted assignment or transfer without written consent is void and shall terminate this License. Licensor retains the right to cancel and terminate this Agreement if Licensee or its assignee uses this Crossing for any purpose other than as described in this License.
- 5. Miscellaneous: (a) The personal pronouns used as referring to Licensee shall be understood to refer to Licensee whether Licensee is a natural person, a partnership, a corporation, a political subdivision, or any combination.
  - (b) Any notice required to be given by Licensor to Licensee, or Licensee to Licensor shall be properly given when served upon or hand delivered to, or upon receipt if mailed, postage paid, certified mail, return receipt requested, addressed as follows:

- (d) This Agreement does not become binding upon Licensor until executed by Licensor's Director, or the Director of the Department's Division of State Parks.


